ANNOUNCER: THIS PROGRAM, POLITICAL EDUCATION OF THE AIR,

IS A PUBLIC SERVICE PRESENTATION OF THE

HEADQUARTERS DEPARTMENT OF PUBLIC AFFAIRS. THE

SERIES IS DESIGNED TO HELP BRING ABOUT AN

AWARENESS OF THE VARIOUS POLITICAL ALTERNATIVES

TO THE PEOPLE OF MICRONESIA.

THE TRUST TERRITORY GOVERNMENT TAKES NO SIDES

IN THE POLITICAL ISSUES ON THE FUTURE OF

MICRONESIA. ITS TASK IS SIMPLY YO PRESENT THE

ISSUES AS THEY ARE, NOT TO INTERPRET THEM OR

DRAW ANY CONCLUSIONS FROM THEM.

NARRAOTR : AS WE LEARNED IN AN EARLIER PROGRAM OF THIS

SERIES, THE UNITED STATES HAS OFFERED A COMMON-

WEALTH FORM OF GOVERNMENT TO MICRONESIA.

HOWEVER, SO FAR ONLY ONE OF THE SIX DISTRICTS

OF MICRONESIA HAS EXPRESSED A CLEAR DESIRE TO.

ACCEPT THIS ALTERNATIVE. THAT DISTRICT IS THE

MARIANA ISLANDS. FOR THE BENEFIT OF THOSE WHO ARE STILL INTERESTED IN LEARNING MORE ABOUT THE COMMONWEALTH PROPOSAL, WE WILL PRESENT A DESCRIPTION OF IT TODAY. THE MARIANAS HAVE ELECTED TO PURSUE THIS FORM OF ASSOCIATION AND, THEREFORE, THE PARTICULAR PROGRAM WILL BEAR DIRECTLY AND HAVE A SPECIAL IMPACT ON THEM.

THE DISCUSSION ON THIS PROGRAM IS BASED ON THE U.S. PROPROSAL SUBMITTED TO THE MARIANAS THIS SPRING. WHATEVER CHANGES OR MODIFICATIONS MAY DEVELOP FROM THE CURRENT ROUND OF NEGOTIATIONS BETWEEN THE MARIANAS AND THE U.S. DELEGATION ARE OF COURSE FOR THE FUTURE BUT SHOULD NOT MATERIALLY AFFECT THE GENERAL NATURE OF THE ARRANGEMENT OF COMMONWEALTH AS IT MIGHT BE CONSIDERED FOR OTHER PARTS OF MICRONESIA.

UNDER THE TERMS OF THE COMMONWEALTH OFFERED BY THE UNITED STATES, THE MARIANAS WOULD BECOME A PART OF THE UNITED STATES AND WOULD, AS A RESULT, ASSUME CERTAIN OBLIGATIONS AND AT THE SAME TIME RECEIVE CERTAIN RIGHTS AND BENEFITS, THE RELATIONSHIP WOULD INVOLVE MUCH CLOSER TIES THAN EITHER THE FREE ASSOCIATION AND

INDEPENDENCE PROPOSALS. HOWEVER, THE RELATION—SHIP WOULD NOT BE AS CLOSE AS THAT OF A STATE OF THE UNITED STATES NOR WOULD IT BE ONE WHICH IMPLIES LESS INTERNAL AUTONOMY AS IS THE CASE OF AN UNINCORPORATED TERRITORY. AS A COMMONWEALTH, MICRONESIA WOULD JOIN THE POLITICAL FAMILY AND POLITICAL AREA WHICH MAKE UP THE UNION UNDER THE UNITED STATES CONSTITUTIONAL SYSTEM.

PERHAPS THE EASIEST WAY TO CLEARLY UNDERSTAND
THE NATURE OF THE PROPOSAL FOR COMMONWEALTH
STATUS IS TO EXAMINE THE RELATIONSHIP WHICH
WOULD EXIST BETWEEN THE COMMONWEALTH OF THE
NORTHERN MARIANAS AND THE UNITED STATES GOVERNMENT.
UNDER THE UNITED STATES PROPOSAL, CERTAIN
POWERS WOULD BE RESERVED PRIMARILY FOR THE
MICRONESIAN GOVERNMENT; OTHERS WOULD BE SHARED
WITH THE UNITED STATES GOVERNMENT, AND OTHERS
WOULD BE RESERVED PRIMARILY FOR THE UNITED STATES
GOVERNMENT.

A SUMMARY OF THE RELATIONSHIP WHICH WOULD EXIST IN MAJOR AREAS IS AS FOLLOWS:

ANNOUNCER:

1. BY JOINING THE UNITED STATES POLITICAL SYSTEM,
THE PEOPLE OF THE MARIANAS WOULD BE OFFERED A

CHOICE BETWEEN TWO STATUSES. CURRENT
RESIDENTS COULD BECOME UNITED STATES CITIZENS,
BUT IF THEY DID NOT WANT THIS THEY COULD SIMPLY
BECOME UNITED STATES NATIONALS - A CONDITION WHICH
GIVES FEWER INDIVIDUAL PRIVILEGES AND OBLIGATIONS.

SINCE THEY WOULD BE EITHER U.S' CITIZENS OR U.S. NATIONALS, THEY WOULD HAVE THE RIGHT TO FREE ACCESS TO THE UNITED STATES FOR ANY REASON, INCLUDING BUSINESS, STUDY AND TRAVEL. IN ADDITION, GOODS ORIGINATING IN THE MARIANAS

WOULD BE ALLOWED FREE ACCESS INTO THE UNITED STATES.

2. THE PEOPLE OF THE MARIANAS WOULD BE FREE TO

DETERMINE THEIR OWN INTERNAL GOVERNMENTAL STRUCTURE
THROUGH A CONSTITUTIONAL CONVENTION WITHIN CERTAIN
LIMITATIONS AND RESTRICTIONS. FIRST, THE

CONSTITUTION OF THE MARIANAS WOULD HAVE TO PROVIDE
A REPUBLICAN FORM OF GOVERNMENT, INCLUDING A BILL
OF RIGHTS, AND NOT BE INCONSISTENT WITH THE CONSTITUTION OF THE UNITED STATES OR THE UNITED

STATES ACT ESTABLISHING THE COMMONWEALTH RELATIONSHIP.

- 3. THE MARIANAS LEGISLATURE WOULD HAVE FULL AUTHORITY TO LEGISLATE IN LOCAL MATTERS.
- 4. ALL THE PROPERTY HELD OR CONTROLLED BY THE TRUST TERRITORY GOVERNMENT IN THE MARIANAS INCLUDING THE SO-CALLED PUBLIC LANDS AND MILITARY RETENTION AREAS WOULD BE TURNED OVER TO THE COMMONWEALTH GOVERNMENT.
- 5. AREAS AGREED TO BY THE MARIANAS AND THE U.S.

 GOVERNMENT WOULD BE MADE AVAILABLE TO THE

 FEDERAL GOVERNMENT FOR PUBLIC PURPOSES OR

 MILITARY NEEDS.
- 6. THE MARIANAS WOULD HAVE ITS OWN LOCAL COURTS
 WHICH WOULD ENFORCE AND INTERPRET LOCAL LAWS.
 IN ADDITION THE U.S. FEDERAL COURT SYSTEM
 COULD BE EXPANDED TO INCLUDE THE MARIANAS AND
 THE U.S. CIRCUIT COURT OF APPEALS AND THE U.S.
 SUPREME COURT COULD BE AVAILABLE FOR APPEALS.
- 7. MEANS WOULD BE FOUND TO PROTECT LAND IN THE MARIANAS FROM ALIENATION TO OUTSIDERS.

- 8. FOREIGN AFFAIRS AND DEFENSE FOR THE MARIANAS WOULD BE TAKEN CARE OF AND HANDLED BY THE U.S. GOVERNMENT UNDER THE DIRECTION OF THE PRESIDENT OF THE UNITED STATES.
- 9. THE MARIANAS WOULD ENJOY SUBSTANTIAL FINANCIAL AND ECONOMIC ASSISTANCE FROM THE UNITED STATES BOTH DIRECTLY AND INDIRECTLY IN THE FORM OF FEDERAL GRANTS AND PROGRAMS AND EXPENDITURES RESULTING FROM MILITARY ACTIVITIES AND SPENDING IN THE AREA.

THESE ARE AMONG THE MAJOR AREAS IN WHICH THE MICRONESIANS WOULD HAVE TO CONSIDER THE ADVANTAGES AND DISADVANTAGES OF THE CONCEPT OF COMMONWEALTH.

AS POINTED OUT EARLIER THIS CONCEPT HAS BEEN ACCEPTED BY THE LEADERS OF THE MARIANAS DISTRICT. THE CURRENT NEGOTIATIONS BETWEEN THE U.S. DELEGATION AND THE MARIANAS FUTURE POLITICAL STATUS COMMISSION ARE BASED ON THIS TYPE OF POLITICAL ARRANGEMENT.

THE LEADERS OF THE FIVE OTHER DISTRICTS IN THE CONGRESS OF MICRONESIA HAVE NOT ACCEPTED THIS PROPOSAL.
