A HOUSE JOINT RESOLUTION

Urging the High Commissioner and the Department of Defense to take immediate steps to review and renegotiate the lease agreement for Kwajalein Island, Carlos Island, and other islands in the Kwajalein Atoll which were included in the 1964 Kwajalein lease agreement.

1 WHEREAS, since February 9, 1944, certain islands of Kwajalein
2 Atoll have been used by the United States Government for military
3 purposes; and

4 WHEREAS, on February 9, 1964, twenty years later, a lease
5 agreement was signed between the landowners of certain islands of
6 Kwajalein Atoll and the United States Government, giving the latter
7 continued use rights for a period of 99 years and setting compensa-
8 tion to the landowners at the unconscionably low amount of \$750,000
9 for said use of land; and

10 WHEREAS, during the negotiations for Kwajalein Island, nearby
11 Carlos Island was taken by the United States Government through
12 eminent domain with compensation set at \$200 per acre for
13 indefinite land use rights; and

14 WHEREAS, during the negotiations for Kwajalein Island, the
15 United States Government also threatened to use eminent domain to
16 acquire Kwajalein Island unless the landowners yielded to the
17 inadequate United States offers of \$1,000 per acre; and

18 WHEREAS, it is the sense of the Congress of Micronesia that
19 the validity or legality of any lease agreement, where landowners
20 are coerced and compelled to sign in fear of loss of their lands
21 without adequate compensation, is highly improper; now, therefore,

22 BE IT RESOLVED by the House of Representatives of the Fifth

1 Congress of Micronesia, Second Regular Session, 1974, the Senate
2 concurring, that the High Commissioner, the Department of Defense,
3 the Marshall Islands Nitijela, and local leaders from the
4 Kwajalein Atoll take immediate steps to review and renegotiate
5 the lease agreements of Kwajalein and other islands of the
6 Kwajalein Atoll to insure fair and adequate compensation to
7 landowners; and

8 BE IT FURTHER RESOLVED, that certified copies of this House
9 Joint Resolution be transmitted to the United Nations Security
10 and Trusteeship Councils, U.S. Ambassador Franklin Haydn Williams,
11 the U.S. Department of Defense, the U.S. Department of the
12 Interior, the High Commissioner of the Trust Territory of the
13 Pacific Islands, and the Marshall Islands Nitijela.
