OFFICIALS TESTIFIED IN WASHINGTON THURSDAY (APRIL 4) IN SUPPORT

OF A \$61 MILLION BUDGET APPROPRIATION, WHICH THEY HOPE TO RAISE

OF A \$61 MILLION NEXT YEAR, ACCORDING TO A GANNETT NEWS REPORT

TO \$75 MILLION NEXT YEAR, ACCORDING TO A GANNETT NEWS.

STANLEY S. CARPENTER. DIRECTOR OF THE OFFICE OF TERRITORIAL AFFAIRS, TOLD CHAIRMAN ALAN BIBLE, OF THE SENATE APPROPRIATION SUBCOMMITTEE THAT THE TRUST TERRITORY WANTS PROGRESSIVELY INCREASED CEILINGS OF \$75 MILLION, \$80 MILLION AND \$85 MILLION OVER THE NEXT THREE FISCAL YEARS.

THIS PROPOSAL IS NOW BEFORE THE ADMINISTRATION'S OFFICE OF MANAGEMENT AND BUDGET. THE PRESENT CEILING IS \$61 MILLION. THE MICRONESIAN DELEGATION ALSO ASKED FOR EXPEDITED HANDLING OF A REQUEST FOR \$1.6 MILLION TO HELP BUILD NEW INTER-ISLAND SHIPS.

REPRESENTATIVE RAYMOND SETIK (TRUK), CHAIRMAN OF THE CONGRESS OF MICRONESIA'S JOINT COMMITTEE ON PROGRAM AND BUDGET PLANNING, SAID RESIDENTS OF THE TT ARE TRAVELLING BETWEEN ISLANDS ON OUTMODED SHIPS, SOME 30 YEARS OLD. HE SAID MONEY FOR THE VESSEL ALREADY IS AVAILABLE UNDER UNSPENT FUNDS FOR THE PRESENT FISCAL YEAR.

THE U.S. PROGRAM TO BUILD EIGHT NEW SHIPS FOR INTER-ISLAND PASSENGER AND CARGO SERVICE AMONG THE ISLANDS OF MICRONESIA IS IN THE WORKS. THE FIRST VESSEL, THE 225-FOOT MICRONESIA PRINCESS, HAS BEEN BUILT IN PUSAN, KOREA, AND WILL BE READY FOR USE THIS SUMMER.

CARPENTER SAID MICRONESIA IS HAVEING "ONE OF THE MOST SIGNIFICANT YEARS IN ITS HISTORY" AS IT IS "PROGRESSING RAPIDLY TOWARDS THE JOINT GOAL OF SELF-GOVERNMENT FOR MICRONESIA WITH A MUCH STRONGER ECONOMIC BASE," THE GANNETT STORY REPORTED. HIGH CONMISSIONER EDWARD E. JOHNSTON SAID THE \$61 MILLION

HIGH CONMISSIONER EDWARD E. JOHNSTON SAID THE \$61 MILLION SOUGHT IN FISCAL 1975 INCLUDES \$2.2 MILLION FOR A NEW HOSPITAL IN YAP DISTRICT: \$13 MILLION FOR THE PUBLIC EDUCATION SYSTEM INVOLVING 34,000 STUDENTS IN 234 SCHOOLS; \$2 MILLION FOR SURVEYS REQUIRED TO RETURN PUBLIC LANDS TO LOCAL DISTRICT CONTROL; \$1 MILLION FOR ECONOMIC DEVELOPMENT LOANS; AND \$667,000 FOR REHABILITATING THE ISLAND OF BIKINI.

JOHNSTON ALSO REQUESTED \$1.4 MILLION TO INITIATE PAYMENT OF MICRONESIAN POST-SECURE CLAIMS BETWEEN 1944 AND 1951 FOR DAMAGE CAUSED BY U.S. OCCUPATION. THERE IS \$5 MILLION AVAILABLE TO PAY THE U.S. SHARE, WITH MATCHING JAPANESE INDEMNITY, FOR DAMAGES DURING THE WAR ITSELF. JOHNSTON SAID A TOTAL OF 11,098 CLAIMS HAS BEEN FILED.

THE TOTAL FILED FOR THE POST-WAR PERIOD IS MORE THAN \$11 BILLION, MICRONESIA OFFICIALS SAID, BECAUSE IT INCLUDES CLAIMS BY THE MICRONESIAN LEGAL SERVICES CORP., FOR DAMAGES THROUGH NUCLEAR TESTING ON BIKINI AND ENIVETOK.

IN ADDITION TO HIGH COMMISSIONER JOHNSTON AND CONGRESSMAN SETIK, SEVERAL OTHER TT AND CONGRESS STAFF ARE IN WASHINGTON FOR THE CURRENT ROUND OF BUDGET HEARINGS.
