(FINAL BILLS RECEIVED)

SAIPAN, APRIL 15 (MNS) --- THE OFFICE OF THE HIGH COMMISSIONER ON SAIPAN HAS RECEIVED THE FINAL PIECES OF LEGISLATION TO BE OFFICIALLY TRANSMITTED FROM THE 1974 SESSION OF THE CONGRESS OF MICRONESIA. THEY INCLUDE TWO NEW HOUSE BILLS, AND A HOUSE BILL ALREADY DISAPPROVED BY THE ADMINISTRATION, BUT RE-PASSED BY THE CONGRESS.

THE HIGH COMMISSIONER HAS TWENTY DAYS IN WHICH TO CONSIDER THE RE-PASSED BILL. IT IS A MEASURE DESIGNED TO PUT A STOP TO THE PRACTICE OF EXPATRIATES AVOIDING. THE PROVISIONS OF LAWS GOVERNING FOREIGN BUSINESS ACTIVITY BY VIRTUE OF EITHER BEING MARRIED TO, OR ADOPTING, MICRONESIAN CITIZENS (HB 3). THE BILL MAKES CERTAIN CHANGES IN THE DEFINITION OF "NON-CITIZEN"IN THE BUSINESS PERMIT LAWS.

ONE OF THE FIRST BILLS TO PASS DURING THE RECENT SESSION ON SAIPAN, THE MEASURE MAS VETOED BY THE HIGH COMMISSIONER BECAUSE IT WAS THOUGHT TO BE DISCRIMINATORY, AND POSSIBLE ILLEGAL. THE CONGRESS REJECTED THIS REASONING IN RE-PASSING THE LEGISLATION. IF THE ADMINISTRATION FINDS IT STILL CANNOT APPROVE OF THE BILL, IT WILL HAVE TO BE SENT TO THE SECRETARY OF THE INTERIROR FOR FINAL DISPOSITION.

THE NEW LEGISLATION RECEIVED INCLUDES THE BILL TO ESTABLSIH A MICRONESIAN DEVELOPMENT BANK, AND APPROPRIATING \$140,000 AS THE INITIAL FUNDING FOR THIS ENTERPRISE (HE 246): AND A BILL APPROPRIATING \$659,000 FOR GENERAL STUDENT SCHOLARSHIPS, ESTABLISHMENT OF A STUDENT LOAN FUND, PARTIAL TRUST TERRITORY SCHOLARSHIPS, AND THE PURCHASE OF A BUS FOR USE BY MICRONESIAN STUDENTS AT THE UNIVERSITY OF GUAM (HB 254). THE HICOM HAS THIRTY DAYS FROM THE DATE OF RECEIPT TO TAKE ACTION ON THESE MEASURES.

ALL 46 BILLS PASSED DURING THE SESSION HAVE NOW BEEN RECEIVED, AND TEN ARE STILL UNDER CONSIDERATION. THE REST HAVE BEEN ACTED UPON, WITH 31 SIGNED INTO LAW, AND FIVE VETOED.

(COLEMAN PROCLAIMS LAW DAY)

SAIPAN, APRIL 15 (MNS)---"YOUNG MICHONESIA: LEAD THE WAY. HELP PRESERVE GOOD LAWS, CHANGE BAD LAWS AND MAKE BETTER LAWS." THIS IS THE SLOGAN TRUST TERRITORY DEPUTY HIGH COMMISSIONER PETER T. COLEMAN ANNOUNCED THIS WEEK IN PROCLAIMING LAW DAY MICRONESIA, WHICH WILL BE ON MAY 1ST THIS YEAR.

IN HIS PROCLAMATION, COLEAN SAID: "IT IS FITTING THAT LAW DAY BE DEVODED TO HIS WORTHY PURPOSE, FOR WITHOUT LAWS AND INDEPENDENT COURTS, THE FREEDOMS WE ENJOY WOULD BE MEANINGLESS.

"TO EACH GENERATION OF MICRONESIA CITIZENS COMES A NEW OPPORTUNITY AND RESPONSIBILITY TO PROVIDE NEW LEADERSHIP, FRESH WISDOM AND FORESIGHT FOR MICRONESIA," COLEMAN ADDED. COLEMAN SAID THAT AS MICRONESIA MOVES TOWAR SELF-

GOVERNMENT THE RESPONSIBILITIES OF LEADERSHIP WILL PASS TO TODAY'S GENERATION OF YOUTH. THE DEPUTY HICOM STATED THAT THE 12TH ANNUAL TERRITORIAL OBSERVANCE OF LAW DAY MICRONESIA ON WEDNESDAY, MAY 1, WILL BE DIRECTED TOWARD YOUTH AND THE LAW.

IN EMPHASIZING THE IMPORTANCE OF LAW TO YOUTH, COLEMAN SAID EVERY EFFORT WILL BE MADE TO ASSIST MICRONESIAN YOUNG MEN AND WOMEN, WHO COMPRISE NEARLY ONE-HALF OF OUR POPULATION, IN GAINING A BETTER UNDERSTANDING OF THE LAW AND THE LEGAL PROCESS AND THEIR LEADERSHIP RESPONSIBILITIES.

"WE CAN BE JUSTLY PROUD OF MICRONEISA'S YOUTH FOR THEY ARE PLAYING AN ACTIVE ROLE IN THE CONTINUING GROWTH OF OUR TERRITORY;

THESE YOUNG CITIZENS ARE LEARNING THE IDEALS OF MICRONESIA BY TAKING A CONCERNED INTEREST IN COMMUNITY ACTION PROGRAMS

EMBRACING STUDENT GOVERNMENT, CIVIC, SOCIAL, BUSINESS, RELIGIOUS AND EDUCATIONAL ACTIVITIES," COLEMAN SAID.

THE DEPUTY HICOM CONCLUDED BY SAYING: "I AM CONFIDENT THAT OUR YOUTH WILL CARRY OUT THE RESPONSIBILITIES THAT WILL SOON BE TRUST UPON THEM WITH GREAT CREDIT TO OUR ISLANDS."

('73 WAS ACTIVE YEAR FOR CO-OPS)

SAIPAN, APRIL 15 (MNS) --- ANNUAL BUSINESS STATISTICS FOR COOPERATIVE AND CREDIT UNION ACTIVITY IN THE TRUST TERRITORY FOR 1973 HAVE BEEN RELEASED BY THE COOPERATIVE AND CREDIT UNION SECTION OF THE RESOURCES AND DEVELOPMENT DEPARTMENT'S ECONOMIC DEVELOPMENT DIVISION.

COOPERATIVE GROSS SALES AND REVENUES FOR THE YEAR ENDING DECEMBER 31, 1973 SHOWED 7.7. MILLION DOLLARS WORTH OF BUSINESS, A 22 PER CENT INCREASE OVER THE PREVIOUS YEAR. MORE THAN FIFTY COOPERATIVES ARE OWNED AND OPERATED BY AND FOR OVER 12,000 MICRONESIAMS, WHO MAVE INVESTED ABOUT A MILLION DOLLARS OF THEIR MONEY IN SHARES, BRINGING TOTAL ASSETS TO MORE THAN FOUR MILLION DOLLARS, A SPOKESMAN SAID. GROWTH IS STEADY AND UPWARD, WHEN LOOKING AT THE TREND DURING THE PAST SEVERAL YEAR. HE POINTED OUT.

CREDIT UNIONS ARE THE BRIGHTEST, WITH OVER FOUR MILLION DOLLARS IN LOANS TRANSACTED DURING THE 1973 REPORTING YEAR. A RECENT ANALYSIS OF MAJOR CREDIT UNIONS SHOWED THAT MORE THAN HALF OF THESE LOANS WERE MADE FOR "HOME IMPROVEMENTS." THE AVERAGE MEMBER'S SAVING INCREASED TO \$325 DURING THE YEAR, A 27 PER CENT INCREASE OVER THE YEAR BEFORE. FORTY-SIX CREDIT UNIONS ARE OWNED AND OPERATED BY AND FOR OVER 10,000 MICRONESIAN, WHO HAVE SAVINGS IN THEM TOTALLING 3.4 MILLION DOLLARS. THIS REPRESENTS MONEY THAT MAY NOT OTHERWISE HAVE BEEN SAVED IF IT WERE NOT FOR THE CREDIT UNION MOVEMENT IN MICRONESIA, THE DEPARTMENT SPOKESMAN SAID.

THE TRUST TERRITORY GOVERNMENT'S COOPERATIVE/CREDIT UNION PROGRAM HAS ASSISTED MICRONESIANS BY POOLING A TOTAL SAVINGS OF 4.4 MILLION DOLLARS WHICH IS NOW PROVIDING GOODS AND SERVICES AT COST TO NORE THAN 22.000 MEMBERS.
