

SUBJECT: A VIEW OF THE MARIANAS (APRIL 26, 1974)

1. (C) WITH ROUND FOUR OF THE MARIANAS STATUS TALKS NOW SET FOR MAY 15 ON SAIPAN, THIS MESSAGE PRESENTS A SURVEY OF POLITICAL DEVELOPMENTS IN MARIANAS DISTRICT AND ATTEMPTS TO SET FORTH SOMETHING OF ATMOSPHERE IN WHICH TALKS MAY GE EXPECTED TO TAKE PLACE.

2. (C) MPSC CHAIRMAN PANGELINAN'S RELUCTANCE TO HAVE XNXRN ROUND TAKE 2LACE ON SAIPAN AND HIS REPEATED EXPRESSIONS OF CONCERN AND PREDICTIONS OF 2ROBLEMS THAT WOULD HAVE TO BE FACED BY MEETING HERE, ARE, I BELIEVE, OUTWARD 5 (GNS OF CONSIDERABLE INWARD AGITATION NOT ONLY ON PART OF PANGELINAN BUT ON 2ART OF MARIANAS POLITICAL LEADERS IN GENERAL. PANGELINAN'S GRUDGING ACCEP-TANCE OF SAIPAN VENUE (ACKNOWLEDGING THAT VIRTUALLY BANKRUPT MPSC COULD NOT ITSELF FUND ATTENDANCE AT MEETING ANYWHERE ELSE) WAS FORERUNNER OF STORY



TINIAN ACTIVISTS THAT BROKE APRIL 24 CONCERNING HOSTILE MOVES BY HERMAN MANGLONA, FELIPE MENDIOLA AND SYLVESTER CRUZ TO TAKE WHAT THEY APPARENTLY INTENDED WOULD BE LEGAL ACTION TO PREVENT U.S. ACQUISITION OF LAND REQUIREMENTS ON TINIAN. SO FAR HAS HADE NO HOVE TO CONFRONT THIS REKKETABLY, PANGELINAN SHOW TO CONFRONT THIS OPPOSITION, MOVES OF AT LEAST HE CIVES DESTURBING EVED OF HAVING THE SOULD AND STREAM OF THE STREAM OF THE

(C) NOT SURPRISINGLY TINIAN SEEMS TO BE THE HEART OF THE POLITICAL ACTIVITY BUT THE FERMENT IS MORE WIDELY SPREAD, SPARKED BY FORTHCOMING LOCAL ELECTIONS ON BOTH TINIAN AND SAIPAN FOR MUNICIPAL COUNCIL MEMBERS. 4. (C) ELECTION ON TINIAN IS SET FOR FIRST SUNDAY IN JUNE. PARTY LINES, CUSTOMARILY SOMEWHAT HAZY ON TINIAN, SEEM TO BE LESS BINDING THAN EVER. SHIPANESE ONE COMMENTATOR HAS DESCRIBED SITUATION THERE AS POLARIZING ON THE BASIS OF PRO AND CON U.S. MILITARY REQUIREMENTS. CANDIDATES, HOWEVER, BEAR PARTY BANNERS AND TERRITORIAL PARTY HAS COME UP WITH STRONGLY ANTI-MILITARY CANDIDATE FELIPE MENDIOLA ASSESSMENTED FOR MAYOR. PRESENT REPORTS A THEY INDICATE THAT POPULAR PARTY HAS SPLIT WITH ONE FACTION HAVING NOMINATED PRESENT SPEAKER HARRY CRUZ FOR MAYOR AND SECOND HALF, SLATED TO MAKE ITS DECISION APRIL 27, MAY NOMINATE PRESENT MAYOR BORJA, REGARDED AS PRO-MILITARY. A PLETHORA OF CANDIDATES FOR TINIAN REASONABLE MUNICIPAL COUNCIL SEEMS TO HAVE NARROWED TO NECLIGIDAE PROPORTIONS WITH THREE CANDIDATES MOUNTED BY EACH OF THE TWO PARTIES. WHILE AS INDICATED ABOVE, PARTY DISTINCTION IS NOT FIRM, GENERAL LINE-UP IS TERRITORIAL PARTY ANTI-MILITARY; POPULAR PARTY PRO-MILITARY.

5. (C) ELECTION FOR SAIPAN MUNICIPAL COUNCIL IS SCHEDULED FOR SECOND SUNDAY OFJUNE. PARTIES ARE SCHEDULED TO MEET THIS WEEKEND TO FINALIZE THEIR CANDIDATES, BOTH FOR THE COUNCIL AND FOR THE CONSTITUTIONAL CONVENTION.

6. (C) THERE ARE SIGNS THAT MARIANAS' TERRITORIAL PARTY IS MONITORIARD SUPPORT OF CONGRESS OF MICRONESIA AND HERRITAR CONSTITUTIONAL CONVENTION FOR ON SUBJECT SAYS; ALL DISTRICTS. ARTICLE IN WEEKLY I.GAZETA MAKES-THIS-POINT-AS-FOLLOWS: "INTERESTINGLY THE STATUS COMMISSION OF THE MARIANAS MAY VERY WELL BE REDIRECTED TO INSURE THAT BASIC OWNERSHIP OF THE MARIANAS KAXX RESTS WITH THE PEOPLE OF THE MARIANAS AND NOT THE U.S. GOVERNMENT, NIXON, WILLIAMS AND NOT EVEN LOCAL POLITICIANS. ACCORDINGLY, THE PARTY DECIDED TO WORK WITH THE CONGRESS OF MICRONESIA UNTIL SUCH TIME WHEN THE PEOPLE OF THE MARIANAS ARE READY TO DEVELOP A GOVERNMENT OF THEIR OWN -- A GOVERNMENT WHICH IS FREE FROM DICTATORIAL CONTEXT -- . A GOVERNMENT WHICH MUST PROTECT ITS CITIZENS FROM FOREIGN EXPLOITATION." 7. (C) PRESIDENT OF TERRITORIAL PARTY FRANK PALACIOS OF MPSC HAS BEEN OFF ISLAND FOR PAST WEEK AND I HAVE BEEN UNABLE TO CHECK OUT PARTY POSITION WITH HIM. HOWEVER, I HAVE HELD DISCUSSION WITH TWO LEADERS OF UNITED CAROLINIAN ASSOCIATION WHICH IS AFFILIATED WITH TERRITORIAL PARTY. WHILE ONE OF THEM SAID CLEARLY THAT UCA SUPPORTS CONGRESS AND FREE ASSOCIATION FOR ALL MICRONESIA, FELIX RABAULIMAN OF MPSC WAS NOT SO FIRM.

8. (C) RABAULIMAN DISCUSSED AT SOME LENGTH THE PERSISTENT STREAM OF TRADI-TIONAL LEADERSHIP AMONG CAROLINIANS IN THE MARIANAS. HE SAID UCA HAS NAMED FOUR TRADITIONAL LEADERS REPRESENTING CLEARLY DEFINED CAROLINIAN CLANS AND OR WILL INSIST THAT THEY AND THEIR REPRESENTATIVES FIND BE INCLUDED IN CONSTITU-TIONAL CONVENTION.

9. (C) ON ANOTHER OCCASION PALACIOS SAID THAT CHAMORROS TOO HAD TRADITIONAL LEADERS WHO, IN SOMEWHAT MYSTIC FASHION WOULD COME FORTH AT THE PROPER TIME. WHILE HE DECLINED TO NAME THEM I HAVE UNDERSTOOD FROM OTHERS THAT TWO  $MA \wedge UEL$ PRINCIPALS ARE PANGELINAN, FATHER OF EDITOR OF I. GAZETA VICTOR PANGELINAN, AND VENERABLE JUDGE BENAVENTE.

10. (C) IN CONTRAST TO THESE INDICATIONS OF LIVELY ACTIVITY AMONG THE  $\gamma_{D} \cup T H$ SENIOR CITIZENS, IS THE REPORT OF A NEW GROUP ON SAIPAN CALLED MARIANAS FUTURE ORGANIZATION. THIS ORGANIZATION GATHERING TOGETHER YOUNG VOTERS IN THE 18 TO 25 YEAR AGE GROUP IS CHAIRED EXXEXX BY YOUNG DINO JONES WHO IS ADMINISTRATIVE ASSISTANT TO MARIANAS CONGRESSIONAL DELEGATION AND ASSISTANT EDITOR OF MARIANAS VARIETY. THE ORGANIZATION STARTING OUT WITH A MEMBERSHIP MEMBERSHIPOF 25 TO 30 BUT GROWING, INVITED SENATOR PANGELINAN TO DISCUSS MARIANAS STATUS WITH THEM AT A RECENT MEETING. JONES HAS TOLD ME THAT THE GROUP IS INTERESTED IN MICRONES IAN IDENTITY, MANNERG OF MARIANAS AS A STRATEGIC AREA, ALTERNATIVES TO COMMONWEALTH STATUS AND DEVELOPMENT OF MARINE AND SOIL RESOURCES.

11. (C) ONE OF THE DISTRICT'S YOUNG POLITICAL LEADERS OSCAR RASA, WHO ALMOST MADE HIS WAY TO THE CONGRESS OF MICRONESIA IN THE 1972 ELECTION HAS COME OUT AGAIN WITH SOME PROMINENCE AS PUBLISHER OF I. GAZETA HAVING RETURN TO SAIPAN FROM GRADUATE STUDY AT AMERICAN UNIVERSITY IN WASHINGTON. HIS POLITICAL ASPIRATIONS ARE WIDELY KNOWN.

REPLACEMENT IS UP TO ROTA COUNCIL. I FIND NO EVIDENCE THAT THESE CASES HAVE HAD ANY PARTICULAR<sup>Y</sup>DEGRADING EFFECT ON THE MPSC. IT TOO APPEARS TO BE LATHER RATHER LOW. JUST WHY IT SEEMS IMMOBILIZED (AS WITNESS ITS CONTINUED STALLIEG ON ISSUING THE TRANSLATION OF OUR LAND REQUIREMENTS PAPER) IS DIFFICULT TO JUDGE.

13. (C) KOMMENTX DISTAD ADA CONTINUES TO STALL ON ANY VISIBLE IMPLEMENTATION OF THE PORTION OF THE HONOLULU TALKS UNDER WHICH HE WAS TO INETTATE ACTION IN SET UP TWO COMMITTEES OF CRITICAL IMPORTANCE TO STATUS NEGOTIATIONS: 1) LAND AND 2) CIVILIAN-MILITARY RELATIONS AND PLANNING. IT APPEARS THAT HE AND PANCELY OF (AND PERHAPS SANTOS) ARE AGAIN OUT OF COMMUNICATION WITH EACH OTHER ON THESE AND OTHER MATTERS.

15. (C) I BELIEVE TINIAN LAND SITUATION IS CRUX OR AT LEAST FOCUS OF PROBLEM. (OUR CAUSE IS NOT HELPED BY CHARACTERISTIC GUAM PDN BANNER (APR 16): "NAVY LAND GRAB TACTICS ARE TOLD"). DURING NEXT ROUND WE MUST BE PREPARED TO EXPLAIN OUR REQUIREMENTS IN SIMPLEST POSSIBLE TERMS. VISUAL AIDS, ESPECIALLY ACTUAL MODEL HOUSES (SUCH AS USED SUCCESSFULLY IN CONNECTION WITH MARSHALLESE AGREEMENT TO PLANS FOR ENIWETOK) SHOULD BE AVAILABLE. PERHAPS A SORT OF MOCKUP OF A "REHABILITATED" TINIAN, SHOWING DOCK, MARINA, CHURCH, SCHOOL, BEACHES, AIR FIELDS, ETC. WOULD BE HELPFUL, TOGETHER WITH A SIMILAR PRESENTATION FOR MEMORIAL PARK AND TANAPAG AREAS ON SAIPAN. PRACTICAL ' ROACH IS RECOMMENDED. TRENT
