1. (S) PER REF A THE REVERSAL DOD REQUIREMENTS VIS A VIS NECESSITY  
RELOCATION SAN JOSE VILLAGE COULD CAUSE SERIOUS CREDIBILITY PROBLEMS  
GIVEN U.S. PROMISES AND COMMITMENTS MADE TO DATE BASED ON MY  
PRESIDENTIALLY APPROVED NEGOTIATING INSTRUCTIONS AND PRIOR DOD PLANS  
AND BRIEFINGS.

2. (S) NEVERTHELESS WILL DO MY BEST TO ACCOMMODATE NEW DOD REQUIRE-  
MENTS WITHIN CONTEXT MY CURRENT INSTRUCTIONS TAKING INTO ACCOUNT  
PRACTICAL LOCAL POLITICAL CONSIDERATIONS AND POSSIBLE NEGATIVE CONSE-  
QUENCES OF WITHDRAWAL THIS LATE DATE OFFERS AND PROMISES ALREADY MADE  
PRIVATELY AND PUBLICALLY.

3. (S) STRONGEST PRO U.S. MILITARY ELEMENTS ON TINIAN ALSO STRONGEST  
ADVOCATES FOR VILLAGE RELOCATION AND HAVE BEEN ACTIVELY PROMOTING  
LOCAL POLITICAL SUPPORT FOR SUCH A MOVE. LIKEWISE STRONGEST KNOWN  
PRO MILITARY MEMBERS MPSC WHO FAVOR FULL SATISFACTION U.S. LAND NEEDS  
ON TINIAN ALSO SUPPORT PROPOSAL U.S. HAS PUT FORWARD FOR BUILDING.

COMPLETELY NEW VILLAGE ON NEW SITE. REACTION THESE INDIVIDUALS TO WITHDRAWAL OF VILLAGE RELOCATION OPTION WILL BE IMPORTANT. ALSO CONCERNED THEIR REACTION CHANGE IN PLANS WHICH NOW CALL FOR LOCATION MILITARY HOUSING AND COMMUNITY CENTER IMMEDIATELY ADJACENT CURRENT VILLAGE. CONTRAST IN QUALITY MILITARY AND DEPENDENT HOUSING, PUBLIC BUILDINGS AND OTHER FACILITIES WITH SHABBINESS SAN JOSE COULD CAUSE SERIOUS SOCIAL AND POLITICAL PROBLEMS. AT MINIMUM I BELIEVE WAYS AND MEANS OF REHABILITATING AND UPGRADING PRESENT VILLAGE A POLITICAL NECESSITY IF PLAN B IS TO BE SUCCESSFUL AND IF SERIOUS FUTURE CIVIL-MILITARY COMMUNITY CONFLICT TO BE AVOIDED.

4. (S) YOU MAY BE SURE THAT DESPITE POSSIBLE COMPLICATIONS WILL CAPITALIZE ON ALL POSITIVE ELEMENTS NEW HOV PLANS WHICH ARE NOT INSIGNIFICANT. IF IT APPEARS THAT DOD REQUESTED CHANGE IN U.S. APPROACH WILL SERIOUSLY JEOPARDIZE ACHIEVEMENT PRINCIPLE U.S. LAND OBJECTIVES ON TINIAN WILL SEEK YOUR IMMEDIATE COUNSEL. WARM REGARDS.
