REFERRING TO JOINT COMMUNIQUE ANDER-SON SAID "IT IS A FASCINATING DOCUMENT, REPRESENTING AGREEMENT IN PRINCIPLE ON NEARLY EVERY MAJOR POINT REMAINING IN THE PLAN TO MAKE THE MARIANAS A U.S. COMMONWEALTH. IT IS, I STRONGLY FEEL, A VIRTUAL BLUEPRINT OF WHAT THE FINAL DRAFT COVENANT WILL LOOK LIKE ... THE JOINT COMMUNIQUE SHOULD BE READ AND CONSIDERED VERY CAREFULLY BY THE LEADERSHIP IN THE OTHER DISTRICTS, PARTICULARLY BY THE MEMBERS OF THE CONGRESS OF MICRONESIA. THEN PERHAPS THEY WILL ASK THEMSELVES WHETHER THE TIME HAS NOT AT LAST COME TO ADMIT WHAT HAS BEEN FAIRLY EVIDENT FOR SOME TIME--THAT IT IS FAR TOO LATE TO ENTERTAIN EVEN A FAINT HOPE OF BRINGING THE MARIANAS BACK INTO THE FOLD." {C} GENERAL ACKNOWLEDGEMENT OF THIS LAST POINT WOULD OPEN THE WAY FOR RAPID PROGRESS IN JOINT NEGOTIATIONS AS WELL.
