FOLIOWING IS TEXT OF RESOLUTION CURRENTLY CIRCULATING ON TINIAN IN SUPPORT U.S. LAND REQUIREMENTS AND COMMONWEALTH RELATIONSHIP:

BEGIN TEXT. WE THE UNDERSIGNED RESIDENTS OF TINIAN PROCLAIM AS FOLLOWS:

- 1. THAT WE DO NOT SHARE THE DECISIONS REACHED BY TINIAN PROCLAMATION DATED MAY 19, 1974 INSTITUTED BY THE TINIAN COMMITTEE FOR JUSTICE;
- 2. WHEN CIRCULATED IT WAS WRITTEN IN ENGLISH AND NEVER TRANSLATED OR FULLY EXPLAINED;
- 3. THE TINIAN COMMITTEE FOR JUSTICE EXERTED UNDUE INFLUENCE AND CO-ERCION TO GAIN PUBLIC SUPPORT AND SIGNATURES;
- 4. WE RECOGNIZE AND RESPECT THE MANDATE OF THE MARIANAS POLITICAL STATUS COMMISSION AS DULY CONSTITUTED BODY TO NEGOTIATE FOR ALL THE PEOPLE OF THE MARIANAS ISLANDS DISTRICT WITH THE UNITED STATES TO DEVELOP A STATE OF COMMONWEALTH OF THE MARIANAS;
- 5. THE UNDERSIGNED SUPPORT THE MPSC IN ITS EFFORTS TO REPRESENT AND NEGOTIATE FOR THE PEOPLE OF THE MARIANAS ISLANDS DISTRICT;
- 6. WE SUPPORTED THE ORIGINAL U.S. PROPOSAL TO RELOCATE THE VILLAGE OF SAN JOSE AND WE RECOGNIZE THE BENEFITS THAT WOULD HAVE ACCRUED TO THE PROPLE OF TINIAN BY SUCH RELOCATION;
- 7. WE RECOGNIZE THE MANY ADVANTAGES FROM THE ESTABLISHMENT OF A MULTI-SERVICE MILITARY COMPLEX ON TINIAN;
- 8. WE HEREBY URGE THE MPSC TO NEGOTIATE AND REACH DECISIONS IN THE

MANY IMPORTANT AREAS OF CLOSE ASSOCIATION SUCH AS LAND NEEDS, ECONOMIC NEEDS, POLITICAL STATUS, AND TRANSITION TO AND FOR ALL THE PEOPLE OF THE MARIANAS ISLANDS DISTRICT.
