### FOURTH ROUND MARIANAS TALKS

Marianas Status. Fourth Round Marianas Status talks held on Saipan 15-31 May, with much progress achieved:

- Generally agreed to satisfy military land requirements, but tough details to be worked out this summer by joint committee.
- Tentative agreement on annual financial support at \$13.5 million plus normal Federal programs; however, must be approved by White House since level is above current \$12 million ceiling.
- Expect Fifth Round in October to complete substance of Commonwealth Agreement.

<u>Issues Concerning DOD</u> center around very difficult aspects of land acquisition

- lease versus purchase of military land (OASD/I&L and members of Congress insist on purchase). Ambassador appears ready to concede lease:
- value of land should not be inflated as a negotiation incentive because of bad precedent for US/DOD land actions elsewhere in that area;
- details of land acquisition to be worked out during July-August by a joint committee rather than DOD acquiring land directly.

#### Discussion Points

- Compliment Ambassador Williams on his excellent handling of Tinian village relocation issue (TAB A) ... regret we (DOD) could not have given him earlier notice.
- indicate that we recognize the difficulty in acquiring land at reasonable cost ... DOD prepared to takeover this task, or assign appropriate talent to land committee and respond to Ambassador's policy guidance; however, we don't think it would be appropriate to have another Department's employee in charge of this committee ... should be DOD chairman.
- If Ambassador Williams raises subject of Saipan Memorial Park (TAB B) indicate we have not received interior's Master Plan yet, but consider park project an endeavor the Congress would be pleased to authorize/ appropriate funds for ...

#### Micronesian Talks

- Ambassador Williams intends to meet with Chairman Salii on Guam 8-10 July and in Palau 11-12 July to discuss further the Micronesian status talks.
  - -- DOD is still concerned about satisfying land requirements and status of forces agreement in these talks ... don't want to 'delay these tough issues until after our negotiating leverage is nearly gone.
