IN A PREPARED STATEMENT, MARIANAS DISTRICT ADMINISTRATOR FRANCISCO C. ADA SAID, "WE HAVE CONSIDERED ALL ASPECTS OF THIS MOST IMPORTANT VENTURE AND THE OVERVHELMING RESULTS WERE FOR ME TO RECOMMEND THAT THE BEST OVER-ALL BID WAS THAT OF INTERNATIONAL SHOPPERS LIMITED."

ADA'S RECOMMENDATION, ALONG WITH AN ANALYSIS BY AIRPORT CONSULTANT LEIGH FISHER, WERE FORWARDED TO HIGH COMMISSIONER

EDWARD JOHNSTON FOR HIS REVIEW.

"THE HIGH COMMISSIONER," ADA CONTINUED, "NOTIFIED ME ON TUEDAY, JULY 2ND, THAT HE HAD MADE HIS DECISION TO SELECT INTERNATIONAL SHOPPERS LIMITED." THE HIGH COMMISSIONER SIGNED THE FOREIGN BUSINESS PERMIT FOR INTERNATIONAL SHOPPERS.

ACCORDING TO ADDISON MARROW, MARIANAS PROGRAM AND BUDGET OFFICER, THERE WERE SEVERAL ITEMS WHICH WERE CONSIDERED TO DETERMINE THE BEST BID. THEY WERE EXPERIENCE. MANAGEMENT AND MERCHANDISING STAFF, MARKETING PROGRAM, PLANS FOR TENANT IMPROVEMENTS, THE HIGHEST PREPAID MINIMUM CONCESSION FEE, AND THE HIGHEST MINIMUM IMPROVEMENT COST.

"AS FAR AS WE ARE CONCERNED," MARROW SAID, "THE BEST BID IS INTERNATIONAL SHOPPERS, ANY WAY YOU LOOK AT IT." MARROW SAID THAT THE TOTAL COST OF CONSTRUCTING THE

TERMINAL AND ITS ASSOCIATED STRUCTURES WILL 3E \$5,000,000.
"THAT WAS ONE OF THE REASONS THAT WE NEEDED THE MONEY-

FOR THE BID WE TOOK," HE SAID. "IT WAS ALMOST IMPOSSIBLE TO GO TO ANY OTHER BID BECAUSE THIS ONE WOULD END UP WRITING

ITSELF OUT."

THERE HAS BEEN SOME CONTROVERSY REGARDING ADDITIONAL OFFERS SUBMITTED BY SAIPAN DUTY FREE SHOPS, LTD., MARROW SAID. JOETEN ENTERPRISES AND THE NAURU GOVERNMENT WERE THE JOINT SPONSORS OF SAIPAN DUTY FREE SHOPS. IN THEIR BID, THEY ATTACHED ADDITIONAL BIDS TO THE MAIN FORM. THIS WAS CONTRARY TO THE INSTRUCTIONS GIVEN BY THE GOVERNMENT.

"WE KEPT THAM IN," MARROW SAID, "BECAUSE THEY ARE A LOCAL COMPANY. AND," HE NOTED, "THE BIDDING INSTRUCTIONS ALSO SAID THAT THE DISTAD COULD AMEND THESE REGULATIONS AT

HIS DISCRETION."

WHEN ANALYZED BY FISHER, JOETEN'S TOTAL BID CAME TO \$5,915,000. INTERNATIONAL SHOPPERS TOTAL BID, MARROW SAID, WAS FOR \$7,800,000. SUPPORTERS OF THE JOETEN/NAURU BID HAD

SAID THAT THEIR BID WAS THE HIGHEST.

"THE MICRONESIAN PEOPLE AS A WHOLE," MARROW POINTED OUT, "ARE GOING TO BENEFIT MOST BY THE GREATEST AMOUNT OF MONEY WE CAN GET. IT IS GOING TO KEEP THEM," HE CONTINUED, "FROM PUTTING THEIR CAPITAL IMPROVEMENT MONEY INTO THE AIRPORT. WE CAN SPEND IT ON SCHOOLS, HOSPITALS AND OTHER VALUABLE SERVICES."

THE BIDS FOR THE CONSTRUCTION OF THE PRIME CONCESSION BUILDINGS ARE EXPECTED TO BE OPENED IN OCTOBER. THE TERMINAL FACILITIES, SAID MARROW, ARE EXPECTED TO BE COMPLETED BY JUNE, 1976.
