Dear Ambassador Williams:

Secretary Clements asked that I respond to your letter of June 24, 1974 in which you requested two representatives from the Department of Defense to serve on a Joint US-Marianas Land Committee to assist in the conduct of sub-negotiations for the acquisition of land required by the United States in the Marianas. Additionally, you asked for certain technical consultants to advise the US members of the land committee.

To meet your desires for early establishment of the land committee, the names of the Defense members were provided verbally to your office on July 2, and I understand that they met with Mr. James Wilson on July-3 to review the objectives and modus operandi of the committee.

This is to confirm the assignment of Mr. Roy Markon, Deputy Assistant Commander for Real Estate, Navy Facilities Engineering Command, and Mr. Bernard Dove, Chief Bases and Units Division, Directorate of programs, Headquarters United States Air Force, as the Department of Defense members of the Joint US-Marianas Land Committee. During certain initial sessions of the Land Committee's deliberations these members will be represented by Mr. Joseph Samaritano, Pacific Division, Navy Facilities Engineering Command, and Lieutenant Colonel Walter W. Appelle, Jr., Bases and Units Division, Headquarters United States Air Force, respectively.
