THE CHAIRMEN OF THE COMMITTEE ARE PEDRO A. TENORIO AND JAMES M. WILSON, JR. MARIANAS COMMITTEE MEMBERS ARE JOSE CRUZ AND BEN MANGLONA. AMTRICAN REPRESENTATIVES INCLUDE EMMETT M. RICE, ROY MAKKON AND BERNARD DOVE. THE LATTER TWO ARE CURRENTLY BEING REPRESENTED BY JOSEPH SMARITANO AND LT. COLONEL WALTER APPELLE.
