SAIPAN, AUGUST 19 (MNS) - TRUST TERRITORY DIRECTOR OF EDUCATION DAVID RAMARUI HAS FURTHER CLARIFIED THE SPECIAL ASSIGNMENT GIVEN LAST WEEK TO DARO WEITAL, DIRECTOR OF THE COMMUNITY COLLEGE OF MICRONESIA, RELATING TO THE UPCOMING MICRONESIAN CONSTITUTIONAL CONVENTION.

WEITAL, AN ELECTED DELEGATE TO THE CONVENTION FROM PONAPE, HAS BEEN ASSIGNED BY HIGH COMMISSIONER EDWARD E. JOHNSTON TO PREPARE A DRAFT OR ALTERNATE DRAFTS"... OF PROPOSED EDUCATIONAL COMPONENTS THAT MAY BE PRESENTED TO THE DELEGATES OF THE MICRONESIAN CONSTITUTIONAL CONVENTION TO BE CONSIDERED FOR INCLUSION IN THE NEW MICRONESIAN CONSTITUTION."

RAMARUI SAID MONDAY (AUG.19) THAT THE SPECIAL ASSIGNMENT WAS RECOMMENDED BY THE MICRONESIAN BOARD OF EDUCATION AND BY HIS DEPARTMENT OF EDUCATION IN VIEW OF THE -FACT THAT WEITAL, AN EXPERIENCED FDUCATOR, WILL BE IN A UNIQUE POSITION TO OFFER A TRAINED EDUCATIONAL VIEWPOINT IN THE CONSTITUTIONAL CONVENTION. HE SAID THE ASSIGNMENT WAS IN NO WAY AN ATTEMPT BY THE EXECUTIVE BRANCH OR THE HIGH COMMISSIONER TO INTERFERE WITH THE CONVENTION, AND POINTED OUT THAT WHATEVER DRAFTS WEITAL PREPARES WILL FIRST BE CONSIDERED BY THE BOARD OF EDUCATION, AND WILL THEN BE PRESENTED TO THE CONVENTION ITSELF.

"OF COURSE, THE CONSTITUTIONAL CONVENTION DELEGATES WILL HAVE THE FINAL SAY IN WHETHER ANY OF THESE EDUCATIONAL COMPONENTS ARE INCLUDED IN THE CONSTITUTION," RAMARUI STATED.

HIS CLARIFICATION WAS PROMPTED BY AN INQUIRY FROM SENATOR LAZARUS SALII, THE CONGRESS OF MICRONESIA LIAISON TO THE CONVENTION AND ITS PRE-CONVENTION COMMITTEE. AFTER SEEING THE STORY OF THE WEITAL ASSIGNMENT IN THE WEEKEND NEWSPAPER, SENATOR SALII HAD QUESTIONED THE ADVISABILITY OF THE EXECUTIVE BRANCH INJECTING ITSELF INTO THE CONSTITUTIONAL CONVENTION IN THIS WAY.

"I DO NOT THINK YOU CAN COMPLETELY SEPARATE THE EXECUTIVE BRANCH FROM THE CONSTITUTION DRAFTING PROCESS," RAMARUI SAID. HE ADDED THAT THE BOARD OF EDUCATION AND THE EDUCATION DEPARTMENT HAVE BEEN CHARTED, THROUGH RESOLUTIONS FROM THE CONGRESS OF MICRONESIA, WITH RESPONSIBILITY FOR FORMULATING NEW POLICIES FOR EDUCATION IN MICRONESIA, AND WEITAL'S WORK PRIOR TO THE CONSTITUTIONAL CONVENTION WILL BE IN LINE WITH THIS. SENATOR SALII MET WITH RAMARUI WONDAY TO DISCUSS THE WEITAL ASSIGNMENT, INDICATING AFTERWARD THAT HE IS CATISFIED THE EXECUTIVE BRANCH IS NOT TRYING TO INTERFERE WITH THE

THE MICRONESIAN CONSTITUTIONAL CONVENTION IS EXPECTED TO BE HELD NEXT YEAR ON SAIPAN. THE 60 DELEGATES WILL MEET FOR 90 DAYS TO DRAFT THE CONSTITUTION AND FRAMEWORK FOR MICRONESIA'S FUTURE GOVERNMENT.

(NEW AIRLINE FORMING)

SAIPAN, AUGUST 19 (MNS) --- A SAIPAN BUSINESSMAN HAS ANNOUNCED PLANS TO FORM A NEW AIRLINE TO SERVE THE NORTHERN MARIANAS AND GUAM.

THE AIRLINE, TO BE CALLED "MARIANAS AIRLINES", IS BEING FORMED AS A SOLE PROPRIETORSHIP BY RAY GUERRERO, WHO WAS FORMERLY NORTHERN MARIANAS MANAGER FOR GUAM-BASED AIR PACIFIC

TNTERNATIONAL. GUERRERO SAID MONDAY (AND. 19) THAT HE HOPE

GUERRERO SAID MONDAY (AUG. 19) THAT HE HOPES TO HAVE HIS AIRLINE OFF THE GROUND IN NOVEMBER, AND THAT IT WILL BE BASED ON SAIPAN. INITIALLY THE COMPANY WILL OPERATE A 20, 40372 PASSENGER TWIN OTTER 300, A CANADIAN MANUFACTURED PLANE THAT IS DESIGNED TO OPERATE IN AND OUT OF SHORT, UNIMPROVED AIRFIELDS. GUERRERO SAID THE COMPANY WILL SERVE SAIPAN, TINIAN. ROTA. GUAM AND PAGAN.

FULL DETAILS OF THE PROPOSED AIRLINE WERE NOT MADE AVAILABLE, BUT GUERRERO TOLD MNS THAT ARRANGEMENTS FOR MAINTENANCE OF THE AIRPLANE ON SAIPAN HAVE BEEN MADE, AND ADVERTISEMENT FOR POSITIONS WITH THE COMPANY, INCLUDING PILOTS, WILL BEGIN SOON. HE ADDED THAT IF ALL GOES WELL, MARIANAS AIRLINES HOPES TO ACQUIRE A SECOND TWIN OTTER WITHIN SIX NOMTHS OR SO.

GUERRERO ADDED THAT THE AIRPLANE WILL BE FULLY CERTIFIED BY THE U.S. FEDERAL AVIATION ADMINISTRATION FOR OPERATION IN AND OUT OF GUAM, A U.S. TERRITORY.

THE NORTHERN MARIANAS ARE ALREADY SERVED BY TWO AIRLINES, THE CAB CERTIFIED CARRIER, AIR MICRONESIA, AND THE AIR PACIFIC INTERNATIONAL. ENTRY OF A THIRD AIRLINE INTO THIS FIELD WILL MAKE THE ROUTES BETWEEN THE ISLANDS OF THE MARIANAS THE MOST COMPETETIVE IN THE TRUST TERRITORY.

THE TWIN OTTER WHICH MARIANAS AIRLINES WILL OPERATE HAS A RANGE OF ABOUT 800 MILES, AND IS USED BY A NUMBER OF U.S. AIRLINES FOR SHORT-HAUL ROUTES, INCLUDING FRONTIER AIRLINES AND ALASKA AIRLINES.
