(SURVEY TEAM IN PALAU)

PALAU, AUGUST 20 (MNS) 74AT THE INVITATION OF THE PALAU DISTRICT LEGISLATURE, A 12-MAN UNITED STATES LAND SURVEY TEAM ARRIVED IN KOROR MONDAY (AUG. 19) TO SURVEY SITES FOR POSSIBLE FUTURE USE BY THE U.S. MILITARY.

THE TEAM IS HEADED BY NAVY REAR ADMIRAL WILLIAM J. CROWE, JR., AND IS COMPOSED OF TECHNICAL EXPERTS FROM THE DEPARTMENT OF DEFENSE AND THE OFFICE FOR MICRONESIAN STATUS NEGOTIATIONS IN WASHINGTON.

THE SURVEY TEAM WILL LOOK AT ALTERNATIVE SITES ON BABELTHUAP AND KOROR ISLANDS, AND DECIDE UPON FEASIBILITY OF THEIR POSSIBLE FUTURE USE BY THE UNITED STATES MILITARY FORCES. IN A MAY 2, 1974 RESOLUTION, THE DISTRICT LEGISLATURE REQUESTED A VISIT BY U.S. EXPERTS TO INDICATE THE EXACT LOCATION OF LAND AREAS BEING CONSIDERED FOR POSSIBLE MILITARY USE BY THE UNITED STATES UNDER THE TERMS OF ANNEX "B" OF THE DRAFT COMPACT OF FREE ASSOCIATION. THE SURVEY IS EXPECTED TO TAKE ABOUT TWO WEEKS.

SAIPAN, AUGUST 26 (MMS)---TRUST TERRITORY HIGH COMMISSIONER EDWARD E. JOHNSTON HAS APPROVED THE RENEWAL APPLICATION OF BLACK MICRO CORPORATION FOR A FOREIGN BUSINESS PERMIT, ACCORDING TO THE WEEKLY ANNOUNCEMENT FROM THE ECONOMIC DEVELOPMENT DIVISION OF THE RESOURCES AND DEVELOPMENT DEPARTMENT. THE DIVISION ALSO RECEIVED FOUR NEW APPLICATIONS DURING THE PAST WEEK.

BLACK MICRO'S APPROVAL FOR A RENEWAL OF THEIR PERMIT PERTAINS TO THE COMPANY'S OPERATIONS IN THE MARIANA ISLANDS DISTRICT. THE FIRM IS AUTHORIZED TO ENGAGE IN GENERAL CONTRACTING, ENGINEERING, ELECTRICAL, PAINTING, PLUMBING, AND SUB-CONTRACTING, INCLUDING QUARRY OPERATIONS. THE PERMIT IS PERPETUAL. VICE-PRESIDENT AND GENERAL MANAGER OF THE COMPANY IS JOSE I. AMAGSILA OF SAIPAN. THE FIRM IS AFFILIATED WITH BLACK CONSTRUCTION CORPORATION OF GUAM, AND SENIOR VICE-PRESIDENT OF THE COMPANY IS FORMER TT HIGH COMMISSIONER WILLIAM R. NORWOOD.

APPLICATIONS HAVE BEEN RECEIVED FROM THE FOLLOWING FOUR COMPANIES: INTER-ISLAND DEVELOPMENT COMPANY, TO ENGAGE IN COMMERCIAL AND RESIDENTIAL LAND DEVELOPMENT IN THE MARIANA ISLANDS DISTRICT: SAIPAN REALTY COMPANY, TO ENGAGE IN REAL ESTATE MANAGEMENT, SALES, LEASES, AND DEVELOPMENT: SAIPAN MORTGAGE GOMPANY, TO ENGAGE IN MORTGAGING REAL AND PERSONAL PROPERTY FOR PURPOSES OF LENDING MONEY THEREON AND RETAINING A SECURED INTEREST THEREIN; AND FIRST SAIPAN TITLE INSURANCE AND ESCROW COMPANY, TO ENGAGE I THE BUSINESS OF EXAMINING, CERTIFYING AND GUARANTEEING TITLE TO REAL ESTATE, ISSUE POLICIES OF TITLE INSURANCE, MAKE ABSTRACTS OF PUBLIC RECORDS, DOCUMENTS AND FILES, TO ACT AS ESCROW AGENTS FOR BUYERS AND SELLERS OF REAL PROPERTY. AND OTHER RELATED BUSINESS ACTIVITIES.

ALL FOUR OF TH'SE COMPANIES ARE INTER-RELATED, AND ALL HAVE THE SAME INDIVIDUALS LISTED AS CORPORATE OFFICERS, ALTHOUGH NOT WITH THE SAME TITLES IN EACH CASE. CLAUS A. FRITZEN OF GUAM IS PRESIDENT OF SAIPAN MORTAGE COMPANY, FIRST SAIPAN TITLE INSURANCE AND ESCROW COMPANY AND INTER-ISLAND DEVELOPMENT COMPANY, WITH HENRY S. PANGELINAN OF SAIPAN, A TT CITIZEN, LISTED AS SECRETARY. PANGELINAN IS IN TURN LISTED AS PRESIDENT OF SAIPAN REALTY COMPANY, WITH FRITZEN LISTED AS SECRETARY. THEIR LOCAL ATTORNEY IS JAMES E. WHITE.

DISTRICT, AND HAVE BEEN FORWARDED TO THE DISTRICT ECONOMIC DEVELOPMENT BOARD FOR CONSIDERATION AND RECOMMENDATION.

(BORJA CONCERNED ABOUT GOLDSMITH) .

SAIPAN, AUGUST 20 (CONDRESS RELEASE) --- MARIANAS SENATOR OLYMPIO T. BORJA HAS WRITTEN TT ATTORNEY GENERAL RICHARD I. MIYAMOTO CONCERNING THOMAS R. GOLDSMITH, WHO ALLEGEDLY FLED FROM SAIPAN AUGUST 9 IN FACE OF A CRIMINAL COMPLAINT FROM THE TRUST TERRITORY HIGH COURT. THE COMPLAINT, FILED ON BEHALF OF CRISPIN I. GUERRERO, CHARGED THAT GOLDSMITH UNLAWFULLY OBTAINED MONEY BY FALSE PRETENSES FROM LOCAL INVESTORS BY PRUPORTING TO SELL INTERESTS IN A LOCAL COMPANY.

IN HIS LETTER DATED AUGUST 16, BORJA SAID HE FOUND IT "DIFFICULT BO BELIEVE" THAT GOLDSMITH HAD BEEN ON SAIPAN FOR FIVE YEARS WOTHOUT COMING UNDER "THE SCRUTINY" OF THE ATTORNEY GENERAL'S OFFICE. HE ALSO QUESTIONED WHY IMMIGRATION OFFICIALS DID NOT REALIZE GOLDSMITH "HAD NO VALID REASON" TO REMAIN ON SAIPAN SINCE HIS ORIGINAL BUSINESS PROPOSAL OF FIVE YEARS AGO UNDER A COMPANY CALLED MICRONESIAN MANUFACTURING COMPANY FAILED TO MATERIALIZE.

"MR. GOLDSNITH, IF THAT IS INDEED HIS NAME," BORJA WROTE, "HAS APPARENTLY 'FLEECED' A NUMBER OF MICRONESIANS AND AMERICANS, AND HAS ALSO APPARENTLY SUCCESSFULLY AVOIDED THE LEGAL CONSEQUENCES OF HIS ACTIONS, UNDER THE VERY NOSE OF THE ADMINISTRATION."

THE MARIANAS SENATOR INFORMED THE ATTORNEY GENERAL THAT HE WOULD LIKE TO KNOW "IN WHAT MANNER" COLDSMITH HAS COMPLIED RO FAILED TO COMPLY WITH CURRENT STATUTES, INCLUDING THOSE PERTAINING TO ENTRY AND RESIDENCE OF NON-MICRONESIANS, AND AS TO WHAT STEPS THE GOVERNMENT IS NOW TAKING "TO SEE THAT THE INTERESTS OF THE PEOPLE BILKED BY GOLDSMITH" ARE PROTESTED BY THE LAW.

GOLDSMITH, WHO ARRIVE ON SAIPAN IN 1959, WAS RECENTLY INVOLVED WITH A COMPANY CALLED ISLAND ELECTRONICS, A COMPANY ENGAGED IN IMPORTING, SERVICING AND LEASING SLOT MACHINES.

GOLDSMITH ALLEGEDLY SOLICITED INVESTMENTS FOR THE COMPANY FROM NUMEROUS AMERICANS AND MICRONESIANS IN THE TERRITORY, AND WAS INCORPORATING ANOTHER COMPANY, PACIFIC CONTINENTAL, WHICH WAS TO HAVE TAKEN OVER THE SLOT MACHINE ENTERPRISES.

AFTER GOLDSMITH'S DEPARTURE, THE ATTORNEY GENERAL REVOKED THE BUSINESS PERMIT FOR MICRONESIAN MANUFACTURING COMPANY FOR NONCOMPLIANCE WITH CONDITIONS OF THE LICENSE. MMC WAS TO HAVE MANUFACTURED PIPES AND TUBING ON TINIAN, BUT THESE PLANS DID NOT MATERIALIZE.
