(ENIVETOK TRIP PLANNEL)

SAIPAN, AUGUST 21 (MNS) ZLABOUT FIFTY OF THE PEOPLE OF
ENIVETOK, WHO HAVE LIVED ON UJELAND FOR THE PAST 27 YEARS, WILL
PETURN TO THEIR HOME ISLANDS FOR THE FIRST TIME NEXT MONTH.

THEY WILL BE GOING TO ENIVETOK TO MEET WITH A TOP-LEVEL DELEGATION OF AMERICAN OFFICIALS TO DISCUSS PLANS FOR THE CLEANUP AND REHABILITATION OF THEIR ATOLL.

THE UJELAND DELEGATION, WHICH WILL TRAVEL TO ENIWETOK ON BOARD A SPECIAL FIELD TRIP SHIP ARRANGED BY MARSHALL ISLANDS DISTRICT ADMINISTRATOR OSCAR DEBRUM, WILL INCLUDE THE TWO TOP IROIJI OF THE ISLAND, THE MEMBERS OF THE MUNICIPAL COUNCIL, THEIR LOCAL PLANNING COUNCIL, AND THE HEADS OF EACH OF THE FAMILIES ON UJELANG.

THE AMERICAN DELEGATION WILL BE HEADED BY LIEUTENANT GENERAL WARREN D. JOHNSON, DIRECTOR OF THE DEFENSE NUCLEAR AGENCY IN WASHINGTON, D.C. SEVERAL TOP OFFICIALS OF THE TT GOVERNMENT, INCLUDING DEPUTY HIGH COMMISSIONER PETER T. COLEMAN AND DISTAD DEBRUM. WILL ALSO MAKE THE TRIP.

THE DEFENSE NUCLEAR AGENCY HAS BEEN ASSIGNED RESPONSIBILITY FOR THE PROPOSED CLEANUP OF THE ATOLL, PRIOR TO REHABILITATION WORK BY THE DEPARTMENT OF THE INTERIOR, WHICH WILL LEAD TO SOME 400 PEOPLE BEING RETURNED FROM UJELANG TO THEIR HOME ON ENIVETOK. THE PROPOSED CLEANUP AND REHABILITATION IS CONTINGENT UPON EVALUATION OF THE IMPACT ON THE ENVIRONMENT AND FUNDING FROM THE U.S. CONGRESS, ACCORDING TO AN ANNOUNCEMENT THIS WEEK FROM THE OFFICE OF STANLEY S. CARPENTER, DIRECTOR OF THE INTERIOR DEPARTMENT'S OFFICE OF TERRITORIES.

THE MAIN PURPOSE OF THE TRIP WILL BE FOR THE U.S. DELEGATION TO PRESENT TO THE MARSHALLESE A DRAFT ENVIRONMENTAL IMPACT STATEMENT. THE STATEMENT WILL BE REVIEVED BY THE ENIVETOK PEOPLE AND THEIR LEGAL COUNSEL, THE MICRONESIAN LEGAL SERVICES CORPORATION. WHEN FINALIZED, THE STATEMENT WILL BE TAKEN INTO ACCOUNT IN THE ENIVETOK MASTER PLAN, WHICH IS BEING PREPARED WITH INPUT AND APPROVAL FROM THE ENIVETOK COUNCIL AND PLANNING COMMITTEE.

WASHINGTON OFFICIALS HAVE EXPRESSED HOPE THAT, BASED ON THE FINAL ENVIRONMENTAL IMPACT STATEMENT AND PLANS TO DATE, THE UNITED STATES CONGRESS WILL PROVIDE THE NECESSARY FUNDS TO PROCEED WITH THE CLEANUP AND REHABILITATION.

ATOMIC ENERGY COMMISSION REPRESENTATIVES WILL ALSO BRIEF THE GROUP ON THEIR RECENTLY COMPLETED RADIOLOGICAL REPORT AND ANALYSES, WITH INTERIOR AND TRUST TERRITORY OFFICALS ADDRESSING THE MASTER PLAN FOR REHABILITATION AND RESETTLEMENT.

THE ENIVETOR MEETINGS WILL TAKE PLACE ON SEPTEMBER 7 AND 8 (TT TIME).

(SYMPHONY TO TOUR TT)

SAIPAN, AUGUST 21 (MNS)---THE HONOLULU SYMPHONY ORCHESTRA HAS AGAIN ANNOUNCED PLANS TO TOUR THE TRUST TERRITORY AND GUAM. THE TOUR, WHICH WILL BEGIN SEPTEMBER 5, IS THE THIRD TRIP THROUGH MICEONSI' AND THE ORCHESTRA.

GORDON T. COATS, THE HONOLULU SYMPHONY'S NEW GENERAL MANAGER, SAID ON SAIPAN THIS WEEK THAT THE 13-DAY, 10,000 MILE TOUR THIS YEAR WILL INCLUDE CONCERT STOPS IN KWAJALEIN, PONAPE, GUAM, SAIPAN AND TRUK. COATS IS MAKING AN AFVANCE TRIP TO ALL OF THE STOPS TO SUPERVISE FINAL ARRANGEMENTS.

HEADING THE ORCHESTRA'S MUSICAL FORCES FOR THE CURRENT TOUR WILL BE ITS ASSOCIATE MUSIC DIRECTOR, JOSEPH LEVINE (LA-VEEN), WHO SHARED LAST YEAR'S TOUR WITH THE MUSIC DIRECTOR, ROBERT LAMARCHINA (LA-MARKEENA), WHO WILL REMAIN IN HONOLULU THIS YEAR,

GUEST SOLDIST WILL BE GUITARIST TURAN-MIRZA KAMAL, AN INDONESIAN-BORN AMERICAN WHO IS HAILED AS ONE OF THE OUTSTANDING GUITARISTS OF THE YOUNGER GENERATION. HE WILL APPEAR AS SOLDIST WITH THE ORCHESTRA IN WORKS BY CASTELNUOVO-TEDESCO AND VIVALDI.

INCLUDED ON THE SYMPHONY TOUR SCHEDULE ARE YOUTH CONCERTS FOR ELEMENTARY AND HIGH SCHOOL STUDENTS, PLUS VISITS TO CLASSROOMS BY 12 ENSEMBLE TEAMS FROM THE ORCHESTRA WHO WILL DEMONSTRATE THEIR INSTRUMENTS AND PRESENT INFORMAL PROGRAMS. "PETER AND THE WOLF" FOR NARRATOR AND ORCHESTRA WILL BE A FEATURE OF THE CHILDREN'S CONCERTS. THE WORK WILL BE TRANSLATED INTO THE LANGUAGE OF EACH ISLAND AND WILL BE PERFORMED BY A SPEAKER CHOSEN FROM EACH AREA.

ALSO HIGHLIGHTED WILL BE THE WORLD PREMIERE OF "PENTATONIC ROCK FOR TRIO PERCUSSION" BY THE ORCHESTRA'S TYMPANIST, RICHARD KASHANSKI. AMONG THE INSTRUMENTS INVOLVED IN THIS WORK ARE A FLEXITONE, SMALL BURMESE GONG, TYMPANI, ROTO TOMS, BONGOS CONGAS, DRUM SET, CYMBALS, XYLOPHONE, BELLS, TRIANGLE AND WOOD BLOCK.

OUTDOOR COMMUNITY CONCERTS UNDER THE STARS, AS WELL AS IN REGULAR AUDITORIUMS, ARE SCHEDULED FOR THE GENERAL PUBLIC.

THE TOUR IS MADE POSSIBLE BY A GRANT FROM THE NATIONAL ENDOWNMENT FOR THE ARTS IN WASHINGTON, D.C., A FEDERAL AGENCY, WITH ADDITIONAL FUNDING FROM THE INSULAR ARTS COUNSEL OF GUAM. IT IS SPONSORED BY THE HONOLULU SYMPHONY SOCIETY IN COOPERATION WITH CONTINENTAL/AIR MICRONESIA.

THE TOTAL COST OF THE TRUST TERRITORY TOUR IS ABOUT \$70,000, OF WHICH ROUGHLY HALF IS PROVIDED BY THE NATIONAL ENDOWMENT FOR THE ARTS, ACCORDING TO COATS. HE SAID THE INSULAR ARTS COUNCIL OF GUAM PROVIDES \$11,000, AND IT IS KOPED TO RAISE MOST OF THE REST THROUGH LOCAL DONATIONS. COMMUNITY ORGANIZATIONS IN EACH OF THE LOCATIONS WHERE THE CRCHESTRA PERFORMS ARE BEING ASKED TO MAKE WHATEVER CONTRIBUTION THEY CAN TO FURTHER THIS CULTURAL ENDEAVOR. THE CONCERT TOUR WILL RUN FROM SEPTEMBER 6 TO SEPTEMBER 16.

BORN IN NGARARDMAU WILLAGE, BABELTHUAP ISLAND, RECHUCHER ATTENDED PACIFIC ISLANDS CENTRAL SCHOOL IN PONAPE WHERE HE GRADUATUED IN 1964. HE THEN ATTENDED THE UNIVERSITY OF GUAM FOR ONE SEMESTER AND RETURN TO PALAU WHERE HE WAS HIRED AS COUMUNITY ADVISOR FOR ADULT EDUCATION FOR ONE YEAR.

IN 1967, HE ATTENDED CABRILLO COLLEGE IN SANTA CRUZ, CALIFORNIA WHERE HE EARNED HIS AA DEGREE IN ACCOUNTING IN 1969. HE CONTINUED AT CALIFORNIA STATE UNIVERSITY IN HAYWARD WHERE HE RECEIVED HIS B.A. DEGREE IN PHILOSOPHY IN 1971. HE THEN ATTENDED HASTINGS COLLEGE OF THE LAW IN SAN FRANCISCO, EARNING A LAW DEGREE IN MAY OF THIS YEAR.

WHILE IN LAW SCHOOL, RECHUCKER STUDIED CORPORATION AND CONTRACT LAW AND SAID IT WAS HIS HOPE TO GET INTO THIS TYPE OF WORK IN THE TRUST TERRITORY.
