(NEW PLAN FOR IT FISHERMEN)
SAIPAN, JAN. 24 (MNS)---DIRECTOR OF RESOURCES AND
DEVELOPMENT WYMAN X. ZACHARY ANNOUNCED A SPECIAL PLAN THIS
WEEK WHICH IS AIMED AT PUTTING A NUMBER OF QUALIFIED
MICRONESIAN FISHERMEN ONTO TUNA FISHING VESSELS WHICH THEY
CAN OUN AND OPPRATE THEMSELVES.

THE PLAN CALLS FOR A NEW DESIGN FOR A FISHING BOAT FOR FISHING IN TRUST TERRITORY WATERS-ONE WHICH WOULD REPLACE THE OKINAWAN-JAPANESE TYPE OF BOAT PRESENTLY BEING USED IN OFFSHORE TUNE FISHING WHICH IS OF ANCIENT DESIGN AND NOT NEARLY AS PRODUCTIVE AS MODERN FISHING BOATS.

ACCORDING TO ZACHARY, THESE OKINAWAN VESSELS, MADE OF WOOD, ARE EXPENSIVE AND INEFFICIENT TO OPERATE. THEY CARRY ONLY LIMITED QUANTITIES OF BAIT UNDER POOR CONDITIONS, HAVE POOR CREW ACCOMMODATIONS, TRAVEL VERY SLOWLY, AND HAVE A VERY LIMITED RANGE, THUS MAKING IT IMPOSSIBLE TO FISH MORE THAN 50 MILES OFFSHORE. IN ADDITION, THE BEST HOOKING LOCATIONS OF THESE VESSELS ARE HIGH ABOVE THE WATER, MAKING IT DIFFICULT FOR THE FISHERMEN TO LAND THE LARGER TUNA.

IN ORDER TO OVERCOME THESE VARIOUS DIFFICULTIES, THE NAVAL ARCHITECT OF MARINE RESOURCES DIVISION, WENDELL H. CALKINS, IN CONSULTATION WITH VAN CAMP SEA FOOD COMPANY, LOCAL FISHERMEN AND OTHER STAFF MEMBERS. MAS DESIGNED A NEW STEEL LIVE-BAIT TUNA FISHING VESSEL WHICH SHOULD REMEDY ALL OF THE FAULTS OF THE PRESENT FISHING FLEET.

THE DESIGN PROVIDES A SHIP WITH A RANGE OF 1,500 MILES, ABLE TO TRAVEL AT A SPEED OF NINE KNOTS AND CARRY A CREW OF 14 MEN, 61 FEET IN LENGTH WITH A 19-FOOT BEAM AND A FIVE FOOT DRAFT, AMD A FISH CAPACITY OF 29 TONS IN INSULATED HOLDS. THE FISHING BOAT HAS BEEN LITERALLY DESIGNED AROUND THE BAIT WELLS, WHICH ARE USED TO CARRY LIVE BAIT FISH TO THE FISHING GROUNDS AS WELL AS TO STORE THE TUNA. NORMAL BAITING PRACTICES PRESENTLY CALL FOR THE CONCENTRATION OF BAIT IN A NET AND SCOOP NETS. RESEARCH AT THE UNIVERSITY OF HAVAIL HAS CLEARLY DEMONSTRATED THAT THIS TYPE OF HANDING CAUSES A LARGE PERCENTAGE OF THE BAIT TO DIE AND FURTHER WEAKENS THE BAIT SO THAT MOST.

IN ORDER TO REMEDY THIS PROBLEM, THE NEW TUNA VESSEL HAS BEEN DESIGNED WITH UNDERWATER DOORS. WHICH WILL MAKE IT POSSIBLE TO ACTUALLY SWIM THE BAIT INTO THE LIVE WELLS, THUS ELIMINATING THE NEED TO HANDLE THE BAIT WITH NETS AND BUCKETS. IN ADDITION, WATER WILL BE SUPPLIED TO THE BAIT WELLS BY PUMPS WHICH WILL DOUBLE THE PRESENT BAIT CARRYING CAPABILITY OF BAIT WILL BE REDUCED BY ELIMINATING OVERFLOW WELLS, LOSS ACTION WHICH TAKES PLACE IN PRESENT OPEN-TYPE WELLS.

THE VESSEL HAS ALSO BEEN DESIGNED TO BE OPERATED AS SIMPLY AS POSSIBLE. COMPLICATED EQUIPMENT AND MACHINERY HAS BEEN RESTRICTED TO A MINIMUM IN ORDER TO INSURE AGAINST MECHANICAL BREAKDOWNS. PLANS AND SPECIFICATIONS FOR THE VESSEL HAVE BEEN CIRCULATED TO SHIP YARDS THROUGHOUT THE FAR EAST, HAWAII, AND THE UNITED STATES. THOSE YARDS INTERESTED IN BIDDING ON THE BIDS IN TWO WAYS, INCLUDING A PROPOSAL WHEREBY THE VESSELS WILL SHIPYARDS HAVE BEEN ADVISED THAT IT IS THE DESIRE OF THE GOVERNMENT TO HAVE THE VESSELS BUILT WITHIN THE TRUST TERRITORY AT PRIVATE YARDS. THE UTILIZING AS UCH MICRONESIAN LABOR AS POSSIBLE AND THEREBY REDUCING DELIVERY FEES FOR THE FINISHED VESSEL. IN ADDITION, INTRODUCED TO A WHOLE NEW ARRAY OF NECHANICAL SKILLS SUCH AMERICAN PRACTICE IN MACHINERY, PIPING AND ELECTRICAL INSTALLATIONS.

PLANS AND SPECIFICATIONS FOR THE VESSEL HAVE ALSO BEEN

CIRCULATED THROUGHOUT ALL OF THE DISTRICTS AND MEETINGS HELD WITH LOCAL FIGURERIES TO ENGOGRACH THEM TO SUPMIT LOAM REQUESTES FOR THE COLUMN ICTION OF THESE BOATS. VAN CAMP SEA FOOD COMPANY IS ALSO COMSIDERING THE FEASIBILITY OF REPLACING THEIR FLEET WITH THESE VESSELS. WELL-KNOW MICRONESIAN FISHERMEN HAVE ALREADY REQUESTED INFORMATION ON THE VESSELS AND HOW TO GETAIN THEM.

IT IS HOPED THAT CONSTRUCTION BIDS FOR THESE BOATS WILL BE LOW ENOUGH SO THAT A NUMBER OF THEM CAN BE BUILT FOR EXPERIENCED MICRONESIAN TUNA FISHERMEN. PRELIMINARY ESTIMATESN BASED ON KNOWN ANNUAL PRODUCTION FIGURES FOR VESSELS WHICH HAVE BEEN FISHING FOR VAN CAMP OVER THE YEARS, INDICATE THAT IT SHOULD BE POSSIBLE TO ANORTIZE THE TOTAL COST OF THE VESSEL IN A FEW YEARS WHILE STILL PAYING THE MICRONESIAN CREW MEMBERS EXCELLENT EARNINGS.

DIRECTOR OF R&D ZACHARY CONCLUDED BY SAYING THAT IF THE VESSELS CAN BE FINANCED THROUGH THE MARINE RESOURCES DEVELOPMENT LOAN FUND AND BUILT AT A FIGURE WHICH WILL NICRONESIANS WILL SOON BE FIGHING THE OFFSHORE MATERS OF THE TRUST TERRITORY IN VESSELS WHICH THEY OWN AND OPERATE THEMSELVES. (HICOM ACTS ON MORTON MESSAGE)

(SAIPAN, JAM. 24 (MMS) -- TRUST TERRITORY HIGH COMMISSIONER EDWARD E. JOHNSTON MAS AMMOUNCED THE STEPS HIS ADMINISTRATION IS TAKING IN RESPONSE TO THE MESSAGE DELIVERED TO THE PEOPLE OF MICRONESIA WEDNESDAY (JAM. 23) BY SECRETARY OF THE INTERIOR ROGERS C.B. MORTON. THE INFORMATION IS CONTAINED IN A LETTER WRITTEN BY JOHNSTON TO THE SECRETARY, IN REPLY TO THE SECRETARY'S LETTER WHICH ACCOMPANIED THE FILMED AND TAPED MESSAGE MORTON DELIVERED.

"YOUR MESSAGE CONTAINED MUCH OF GREAT IMPORTANCE TO THE FUTURE OF THIS AREA," THE HICOM TOLD THE SECRETARY, "AND I FEEL SURE THAT THE RESPONSE TO THE POLICIES AND GOALS DISCUSSED IN YOUR MESSAGE WILL BE FAVORABLE." HE DDED THAT THE FILMS OF THE SPEECH WILL BE GIVEN THE WIDEST POSSIBLE DISTRIBUTION THROUGHOUT THE ENTIRE TRUST TERRITORY.

IN REPLY TO SPECIFIC COMMITTMENTS MADE BY SECRETARY MORTON IN THE ADDRESS, THE HICOM SAID HE HAS GIVEN THE CONGRESS OF MICRONESIA ASSURANCE OF THE FULL COOPERATION AND RESOURCES OF THE EXECUTIVE BRANCH OF THE TT AND U.S. GOVERNMENTS IN SECURING THE PASSAGE OF A CONSTITUTIONAL CONVENTION BILL AND EXPEDITING THE WORK OF SUCH CONVENTION.

THE HIGH COMMISSIONER SAID WORK HAS ALREADY BEGUN ON ASSEMBLING THE BASIC COMPONENTS OF AN EXPANDED AND ACCELERATED CAPITAL IMPROVEMENT PROGRAM FOR THE FIVE-YEAR PLANNING PERIOD OF FISCAL YEARS 1976 THROUGH 1980.

"OUR CURRENT APPROPRIATION AUTHORIZATION EXTENDS THROUGH FISCAL YEAR 1975 AT THE 60 MILLION DOLLAR LEVEL," HE STATED.
"EVEN PRIOR TO YOUR POLICY ANNOUNCEMENT, WE HAVE BEEN PLANNING ON THE BASIS OF AN INCREASE IN THE CEILING TO 70 MILLION DOLLARS FOR FISCAL YEARS 1978-1980. DURING RECENT DISCUSSIONS WITH

BOTH AMBASSADOR (F. HAYDN) WILLIAMS AND THE LEADERSHIP OF THE CONGRESS OF MICRONESIA'S JOINT COMMITTEE ON FUTURE STATUS, IT WAS AGREED THAT WE SHOULD MAKE EVERY EFFORT TO INTEGRATE OUR PROGRAM AND FINANCIAL PLANNING WITH THE BASIC ANALYSIS OF FINANCIAL REQUIREMENTS FOR THE FUTURE GOVERNMENT OF MECRONESIA DEVELOPED FOR THE STATUS NEGOTIATIONS.

THE HIGH COMMISSIONER WENT ON TO MENTION THE PLANNED SECOND SUPPLEMENTAL BUDGET REQUEST FOR THIS FISCAL YEAR, WHICH IS TO BE SUBMITTED SHORTLY TO THE U.S. CONGRESS. HE ALSO SUGGESTED THAT IT MIGHT BE APPROPRIATE LEGISLATION TO INCREASE THE FY 1975 CEILING ABOVE 60 MILLION DOLLARS, IN VIEW OF SHARPLY RISING COSTS FOR SUCH THINGS AS FUEL.

TURNING TO SECRETARY MORTON'S ANNOUNCEMENT OF NEW POLICY FOR FOREIGN INVESTMENT, HIGH COMMISSIONER JOHNSTON SAID THE TRUST TERRITORY ADMINISTRATION'S PLAN FOR PROCEEDING TO IMPLEMENT THIS POLICY WILL BE FORWARDED TO THE DEPARTMENT OF INTERIOR PRIOR TO MARCH 1. ALSO PRIOR TO THAT DATE, HE SAID THE DEPARTMENT WILL RECEIVE A FORECAST OF MANDOWER NEEDS IN THE TOR THE MEXT THREE YEARS. "A PROJECT ON WHICH WE HAVE BEEN WORKING CONTINUALLY SINCE THIS ADMINISTRATION DEGAN IN 1969."

THE HICOM ALSO SAID IT IS HOPED THAT PROPOSED LEGISLATION FOR IMPLEMENTING THE NEW U.S. POLICY ON RETURN OF PUBLIC LAND CAN BE SUBMITTED TO THE CONGRESS OF MICRONESIA FOR CONSIDERATION NOT LATER THAN FEBRUARY 1.

CONCERNING THE EDUCATION FOR SELF-GOVERNMENT PROGRAM, ON WHICH SECRETARY MORTON PLACED GREAT EMPHASIS IN HIS ADDRESS, THE HICOM SAID THAT THE WEEK OF JANUARY 27 THROUGH FEBRUARY 2 WILL BE DESIGNATED EDUCATION FOR SELF-GOVERNMENT WEEK THROUGHOUT MICRONESIA.

"AT THE START OF THE WEEK EACH DISTRICT WILL HEAR ON RADIO OR SEE ON TELEVISION THE MESSAGE WHICH I HAVE PREPARED TO OFFICIALLY BEGIN THE PROGRAM," SAID THE HIGH COMMISSIONER. "MY COMMENTS WILL BE FOLLOWED BY A MESSAGE FROM THE DISTRICT ADMINISTRATOR IN EACH DISTRICT.

"DURING EDUCATION FOR SELF-GOVERNMENT WEEK," HE CONTINUED,
"WE WILL BEGIN A SERIES OF BRIEF, CONCISE RADIO PROGRAMS AND,
AT THE SAME TIME, WILL BEGIN DISCUSSIONS AND DEBATES IN
SCHOOLS AND COMMUNITIES THROUGHOUT THE TRUST TERRITORY. WE
WILL KEEP YOU REGULARLY POSTED ON THE PROGRESS OF THIS NEW
PROGRAM," THE HICOM TOLD SECRETARY MORTON.

MOTHES AND COMPANY OF YAP WHOSE BUSINESS PERMIT WAS REVOKED LAST YEAR BASED ON RECOMMENDATION OF THE YAP ECONOMIC DEVELOPMENT BOARD. THE OTHER APPLICATION CAME FROM MARSHALL ISLANDS SEA FOOD ENTERPRISES, INC. FOR THE MARSHALLS.
