(TANKER ON WAY TO MICRONESIA)

SAIPAN, JAN. 3, (MNS) --- MOBIL OIL MICRONESIA OFFICIALS. SAID THURSDAY (JAN. 3) THAT THE TANKER "HALEKULANI" WAS TAKING ON FUEL ON GUAM DURING THE DAY AND WAS EXPECTED TO SAIL FOR THE TRUST TERRITORY LATE THURSDAY EVENING, FOLLOWING THE ARRIVAL ON GUAM OF A TANKER EARLIER THIS WEEK.

MOBIL HANAGER RON CHEVAKO SAID THE HALEKULANI WOULD SAIL TO SAIPAN, YAP AND PALAU ON THIS TRIP, SUPPLYING FUEL TO THE BULK PLANTS IN THOSE LOCATIONS AND THEREBY INCREASING THE TRUST TERRITORY RESERVES OF GASOLINE, DIESEL FUEL AND OTHER FUELS. CHEVAKO ADDED, HOWEVER, THAT THE ALLOCATION OF FUEL DURING JANUARY CONTINUES TO BE BASED ON 83 PER CENT OF JANUARY TO SEPTEMBER 1973 PURCHASES, THE SAME FORMULA USED IN DECEMBER. CONSERVATION MUST STILL BE PRACTICED BY EVERYONE. HE EMPHASIZED.

"WHAT MOBIL FEELS IN MOST IMPORTANT IS THAT EVERYONE REALIZE THAT FUEL IS LIMITED, BUT NOT SO LIMITED AS TO NECESSITATE HOARDING," CHEVAKO SAID. "SIMPLY DRIVE LESS, ECONOMIZE, BUT DON'T HOARD. IF WE ALL CONSERVE, FOLLOW OUR NORMAL BUYING PATTERNS -- EVEN FILL UP AS MUCH AS POSSIBLE, BUT STOP PREVIOUSLY WASTEFUL CONSUMING PATTERNS -- THE FUEL ON THE ISLAND CAN LAST MUCH LONGER.

"THE KEY TO SUCCESS OF ANY ALLOCATION PROGRAM," THE OIL COMPANY OFFICIAL STRESSED, "LIES IN THE HANDS OF THE PUBLIC.

WE ALL MUST CONSERVE FUEL.

SPEAKING WITH MNS BY TELEPHONE FROM GUAM, CHEVAKO NOTED THAT ON GUAN THE SAME SITUATION HAS BEGUN THAT SAIPAN EXPERIENCED A WEEK AGO -- LONG LINES AT MANY FILLING STATIONS, SOME STATIONS CLOSED, AND PEOPLE APPARENTLY BUYING MORE GASOLINE THEN THEY NORMALLY DO. HE SAID MOBIL WAS DOING ITS PART TO DE-FUSE THIS SITUATION THROUGH A CAMPAIGN OF ADVERTISEMENTS AND OTHER PUBLIC EDUCATION, WITH THE BASIC MESSAGE BEING: "DON'T PANIC, BUT DO CONSERVE FUEL."

IN THE TRUST TERRITORY THE DELIVERY OF JANUARY FUEL ALLOCATIONS HAS CONSIDERABLY REDUCED THE DEMAND FOR GASOLINE ON SAIPAN. CHEVAKO SAID MOBIL DELIVERED JANUARY ALLOCATIONS BEGINNING MONDAY, DECEMBER 31 AS A MEANS OF TAKING SOME PRESSURE OFF THE GASOLINE STATIONS WHICH HAD DECEMBER FUEL REMAINING. GASOLINE RATIONING IS STILL A POSSIBILITY ON THE ISLAND, BUT GOVERNMENT OFFICIALS ARE TAKING A "WAIT-AND-SEE" ATTITUDE AT THE MOMENT, HOPING PUBLIC COOPERATION WITH CONSERVATION MEASURES WILL MAKE DIRECT GOVERNMENT ACTION . UNNECESSARY.

HIGH COMMISSIONER EDWARD E. JOHNSTON, CHECKING WITH THE VARIOUS DISTRICT ADMINISTRATORS DURING THE REGULAR CONFERENCE CALL THURSDAY MORNING, FOUND THAT THE OTHER DISTRICTS HAVE SUCCESSFULLY REDUCED THEIR FUEL CONSUMPTION WHILE AVOIDING ANY PANIC BUYING ON THE PART OF THE PUBLIC. THE SITUATION IN PALAU, YAP, TRUK, PONAPE AND MARSHALLS HAS CHANGED LITTLE FROM A WEEK AGO.

(HICOM SIGNS SURVEYING CONTRACT)

SAIPAN, JAN. 3, (MNS) --- TRUST TERRITORY HIGH COMMISSIONER EDWARD E. JOHNSTON HAS SIGNED A CONTRACT FOR AN ACCELERATED PROGRAM OF SURVEYING OF AGRICULTURAL HOMESTEADS ON SAIPAN, IN THE MARIANA ISLANDS DISTRICT.

DURING A SPECIAL CEREMONY IN HIS OFFICE THIS WEEK, THE HICOM ANNOUNCED AMARD OF THE \$111,000 DOLLAR CONTRACT TO THE FIRM OF JUAN TENORIO AND ASSOCIATES OF SAIPAN, INCORPORATED. THE COMPANY WILL BEGIN THE WORK WITHIN THE MONTH, AND EXPECTS TO COMPLETE THE ASSIGNMENT WITHIN A YEAR.

PURSUANT TO A RECENT COURT ORDER, THE HIGH COMMISSIONER ISSUED QUITCLAIM DEEDS TO SOME 191 AGRICULTURAL HOMESTEADS ON SAIPAN, BUT PROMISED AT THE TIME THAT HE WOULD SEE THAT A PROPER SURVEY WAS EFFECTED FOR HOMESTEAD PARCEL RECIPIENTS, DESPITE THE CLASS ACTION SUIT BROUGHT TO COMPEL ISSUANCE OF THE DEEDS BY QUITCLAIM.

AT THE SIGNING, THE HICOM CONGRATULATED TENORIO AND HIS FIRM FOR HAVING BEEN AWARDED THE CONTRACT BY THE SELECTION COMMITTEE, AND AGAIN REAFFIRMED HIS INTENTION TO INSURE THAT EACH HOMESTEADER IS AWARE OF THE POUNDARIES OF HIS HOMESTEAD PARCEL. IT WAS NOTED THAT THE COURT ACTION OF LATE LAST YEAR MADE IT NECESSARY TO ISSUE THE QUITCLAIM CONVEYANCES WITHOUT PROPER BOUNDARY INDENTIFICATION.

A SPOKESMAN FOR THE LANDS AND SURVEYS DIVISION SAID THE WORK TO BE DONE UNDER THE CONTRACT WILL MAKE EVERY HOMESTEADER AWARE OF THE EXACT AREA AND BOUNDARIES OF HIS PROPERTY, AND WILL REMOVE ANY TITLE CLOUD UPON THE PREMISES WHICH MAY HAVE BEEN OCCASIONED BY THE REQUIRED QUITCLAIM CONVEYANCE.

PRESENT AT THE SIGNING OF THE CONTRACT, IN ADDITION TO THE HICOM, WERE MOZO YAMADA, CHIEF OF THE LANDS AND SURVEYS DIVISION, EMMETT RICE, LAND LAW EXAMINER FOR THE TT, AND JUAN TENORIO AND JOE TENORIO OF THE SURVEYING COMPANY.

(MEDICAL SUPPLIES DROPPED ON SATAWAL)

SAIPAN, JAN. 3, (MMS)---TRUST TERRITORY HEALTH SERVICES
DEPARTMENT OFFICIALS SAID THIS WEEK THAT A U.S. NAVY PLANE FROM
GUAM SUCCESSFULLY AIR-DROPPED A SUPPLY OF BADLY NEEDED MEDICAL
SUPPLIES ON THE ISLAND OF SATAWAL IN YAP DISTRICT THIS PAST
WEEKEND:

THE MEDICAL SUPPLIES WERE CALLED FOR BY THE HEALTH ASSISTANT IN SATAWAL, FOLLOWING AN OUTBREAK OF UPPER RESPIRATORY UNFLUENZA THAT HAS AFFECTED NEARLY 100 PER CENT OF THE 150 CHILDREN ON THE ISLAND, AND ABOUT HALF OF THE ADULTS. THE TOTAL POPULATION OF SATAWAL IS APPROXIMATELY 370.

EMERGENCY COORDINATION CENTER OF THE COMMANDER, NAVAL FORCES, MARIANAS ON GUAM, FOLLOWING A REQUEST FROM THE HEALTH SERVICES DEPARTMENT, SENT AN HU-16 ON THE MERCY MISSION SUNDAY, DEC. 30. AT 9:30 A.M. THE FLIGHT WAS ABLE TO AIR-DROP THE SUPPLIES, AND REPORTED THAT THE MISSION WAS SUCCESSFUL. (NOTE TO EDITORS AND NEWS DIRECTORS: THE STORY SLUGGED "NEW ASSISTANT CHIEF" IN THE FRIDAY, DECEMBER 23 MNS, WAS INCORRECT. IT STATED THAT VICTORINO T. BORJA HAS BEEN APPOINTED ASSISTANT CHIEF OF THE COMMUNICATIONS ENGINEERING BRANCH, WHEN IN FACT MR. BORJA WAS NAMED ASSISTANT CHIEF OF THE COMMUNICATIONS DIVISION. SAIPAN, JAN. 3 (MNS) --- TRUST TERRITORY HIGH COMMISSIONER EDWARD E. JOHNSTON HAS ANNOUNCED THE APPOINTMENT OF VICTORINO T. HE AND HIS WIFE, TRINIDAD, HAVE FIVE CHILDREN. (ALL USERS PLEASE CREDIT THE CONGRESS OF MICRONESIA)
