ENGIRAKED ON ESG)

SAIPAN, OCT. 4 (MNS) 74 THE CHAIRMAN OF THE PALAU DELEGATION TO THE MICRONESIAN CONSTITUTIONAL CONVENTION SAID ON SAIPAN THIS WEEK THAT THE CONGRESS OF MICRONESIA AND THE ADMINISTRATION SHOULD BE BLAMED FOR THE SEPARATIST MOVEMENTS COMING TO THE FORE IN MICRONESIA.

JOHN O. NG IRAKED, WHO IS ALSO A MEMBER OF THE PRE-CONVENTION COMMITTEE THAT HAD JUST COMPLETED A TOUR OF ALL SIX DISTRICTS. SPOKE ON THE HEADQUARTERS TASK FORCE ON EDUCATION FOR SELF-GOVERNMENT PROGRAM "DIALOGUE FOR MICRONESIA."

NG IRAKED POINTED OUT AS EXAMPLES THE CURRENT NEGOTIATIONS BETWEEN THE CONGRESS OF MICRONESIA JOINT COMMITTEE ON FUTURE STATUS AND THE UNITED STATES, THE U.S. NEGOTIATIONS WITH THE MARIANAS AND ON TOP OF THESE, THE UNITED STATES AND THE CONGRESS OF MICRONESIA CALLED FOR THE HOLDING OF A NATIONAL CONSTITUTIONAL CONVENTION. "THE CONFUSION," HE SAID, "IS COMPOUNDED BY THE ACTION OF THE ADMINISTRATION AND THE CONGRESS OF MICROMESIA FOR NOT PROPERLY COORDINATING THESE EVENTS."

THE FORMER SENATOR OF THE CONGRESS OF MICRONESIA ADDED THAT HE COULD NOT BLAME THE PEOPLE OF MICRONESIA IF THEY LOSE DIRECTION. "THE PEOPLE OF PALAU ARE LOST AT THIS POINT," HE STATED, "SO THEY SAY, 'LET'S GET ORGANIZED AT HOME."

REGARDING A VERY SMALL TURNOUT OF VOTERS IN THE MARSHALLS. FOR DELEGATE ELECTION TO THE CONCON LAST JUNE, NGIRAKED SAID THAT, TECHNICALLY, THE SMALL PERCENTAGE OF PEOPLE WHO WENT TO THE POLLS DOES NOT AFFECT THE VALIDITY OF THE ELECTION. "WE COULD PERHAPS DISCUSS THE MORALITY OF THE MATTER," HE CONTINUED, "BUT TECHNICALLY, THE LEGALITY OF THE ELECTION IN THE MARSHALLS IS NOT IN QUESTION." ASKED WHETHER THERE IS A POINT IN HOLDING A CONSTITUTIONAL CONVENTION WHEN ONE DISTRICT IS REPRESENTED BY PEOPLE WHO DO NOT SEEM TO REFLECT THE VIEWS OF A STRONG POLITICAL FACTION OF THAT DISTRICT, NGIRAKED STATED THAT THE IMPORTANT THING TO KEEP IN MIND IS TO PROVIDE THE PEOPLE OF THE MARSHALLS ALL THE OPPORTUNITIES AND THE NECESSARY MEANS TO ATTEND THE CONSTITUTIONAL CONVENTION AND TO PARTICIPATE IN IT. "THE FACT THEY DIDN'T TAKE ADVANTAGE OF THAT OPPORTUNITY," HE ADDED, "WAS THEIR CHOICE, NOT ANYBODY ELSE'S."

ASKED TO COMMENT WHETHER THE OTHER DISTRICTS SHOULD FOLLOW THE EXAMPLE OF PALAY AND CALL A CONVENTION TO DRAFT A CONSTITUTION BEFORE THE TT-WIDE CONVENTION IS HELD, THE CHAIRMAN OF PALAU DELEGATION TO THE CONCON REPLIED THAT HE WOULD "NEITHER RECONMEND NOR DISCOURAGE SUCH A STEP." HE SAID LOCAL CONSTITUTIONAL CONVENTION COULD BE USEFUL TO SHOW THE CONCERN AND AWARENESS OF THE PEOPLE. HE POINTED OUT THAT DELEGATES COULD LATER USE THIS INFORMATION AT THE MICRONESIAN CONVENTION. SOME DISTRICTS, ON THE OTHER HAND, THINK IT WOULD BE IMPROPER TO DO ANYTHING AT THE DISTRICT LEVEL UNTIL THE FRAMEWORK OF THE NATIONAL CONSTITUTIONAL HAS BEEN CONSTRUCTED. ACCORDING TO NG IRAKED. HE SAID THAT HE FELT BOTH LINES OF REASONING ARE VALID IN LIGHT OF THE VARYING CIRCUMSTANCES IN THE DIFFERENT DISTRICTS.

REGARDING THE PARTICIPATION OF THE MARIANAS DISTRICT IN THE CONSTITUTIONAL CONVENTION, THE PALAUAN ATTORNEY SAID THAT UNTIL THE TIME COMES WHEN THE MARIANAS IS OFFICIALLY SEPARATED FROM MICRONESIA. THAT DISTRICT SHOULD PARTICIPATE IN THE CONVENTION.

INQUIRED WHETHER HOLDING A TERRITORY-WIDE CONVENTION NEXT YEAR IS TOO EARLY, HE SAID MOST PEOPLE SEEM TO THINK THAT THE FURTHER OFF THE CONVENTION, THE BETTER. "THE IMPORTANT FACTOR," NGIRAKED EXPLAINED, "IS THE AMOUNT OF TIME NEEDED TO PREPARE FOR THE CONVENTION AND TO GET THE PEOPLE IN A STATE OF READINESS TO FACE THIS QUESTION. THE LAW IS NOT SPECIFIC ON THIS AND THERE IS NOTHING IN IT TO PREVENT THE PRE-CONVENTION COMMITTEE FROM SETTING THE CONVENTION DATE 11210 AFTER 1975 -- EVEN FIVE YEARS FROM NOW.

NG IRAKED SAID HE PERSONALLY FEELS THE WHOLE YEAR OF 1974 SHOULD TOTALLY BE DEDICATED TO AN INTENSIVE POLITICAL EDUCATION PROGRAM.

ASKED WHETHER SUCH A PROGRAM, EVEN IF IT WERE EXTENDED BEYONG 1975 WOULD HELP ACHIEVE UNITY IN MICRONESIA, HE REPLIED: "YES, I THINK ONE REASON MICRONESIA UNITY IS FALLING APART IS THE LACK OF PROPER AWARENESS OF WHAT'S GOING ON AND THE LACK OF VIGOROUS LEADERSHIP AT ALL LEVELS." HE SAID THE PEOPLE OF MICRONESIA NEED TO THINK ABOUT THEIR COMMONALITY, NOT THEIR DIFFERENCES.

IN A CLOSING STATEMENT, MG IR AKED URGED ALL THE LEADER SHIP IN MICRONESIA TO TRY TO WORK TOWARD UNITY. "I THINK THE VIABILITY OF OUR PEOPLE AS A NATION, DEPENDS ON THE VILLINGNESS OF THE PEOPLE TO SEEK THEIR FUTURE TOGETHER, AND THEIR WILLINGNESS AND DETERMINATION TO MAKE CERTAIN SACRIFICES TO ACHIEVE THIS. NO NATION DESERVES INDEPENDENCE, OR ANY FORM OF SELF-GOVERNMENT, IF IT IS NOT WILLING TO MAKE SACRIFICE WHEN IT IS TIME TO DO SO." HE CONCLUDED THAT IT IS HIS HOPE THAT MICRONESIA WILL GO DOWN IN HISTORY AS A NATION THAT WILLINGLY MADE SUCH SACRIFICES IN ORDER TO UNITE ITS PEOPLE.

## (DROSTHOLM VISITED SAIPAN)

SAIPAN, OCT. 4 (MNS) --- HILMAR DROSTHOLM, PRESIDENT OF THE DROSTHOLM PRODUCTS INCORPORATED OF COPENHAGEN, DENNARK, VISITED SAIPAN THIS WEEK AT THE INVITATION OF THE COMMUNITY DEVELOPMENT DIVISION. DROSTHOLM FIRM HAS PIONEERED THE TECHONOLOGICAL DEVELOPMENT OF THE BUILDING SYSTEM CALLED LATOREX WHICH IS BEING WIDELY INTRODUCED IN A NUMBER OF DEVELOPING NATIONS IN THE TROPICAL AND SUBTROPICAL AREAS OF THE WORLD.

LATOREX IS A TRADE NAME FOR BLOCKS FORMED FROM LATERITIC SOILS SUBJECTED TO HIGH PRESSURE, HEAT, MIXED WITH LIME AND UTILIZING SPECIAL MACHINERY MANUFACTURED BY THE DANISH FIRM. LATERITIC SOIL IS COMMONLY RECOGNIZED BY ITS CLAY AND REDDISH COLOR NORMALLY FOUND IN AREAS OF VOLCANIC ORIGIN.

THROUGH JOINT EFFORTS OF THE CONGRESS OF MICRONESIA AND THE EXECUTIVE BRANCH, DROSTHOLM WAS REQUESTED TO TEST SOIL SAMPLES FROM THE HIGH ISLANDS OF THE TRUST TERRITORY AND TO VISIT THE DEPOSIT SITES OF LATERITE. SAMPLES FROM SAIPAN AND BABELTHUAP, ALREADY TESTED IN DENMARK HAVE PROVEN TO BE OF VERY HIGH COMPRESSIVE STRENGTH THAN THE COMPRESSIVE STRENGTH OF CONCRETE BLOCK.

DROSTHOLM VISITED A NUMBER OF SITES FOR THE PAST FEW DAYS ON SAIPAN AND WAS NOTICEABLY IMPRESSED BY THE SIZE AND EQUALITY AS WELL AS VARYING COLORS OF THE DEPOSITS. HE WAS ASSISTED IN HIS SURVEY BY LAND MANAGEMENT AND COMMUNITY DEVELOPMENT DIVISION PERSONNEL.

TRUST TERRITORY DEPUTY HIGH COMMISSIONER PETER T.

COLEMAN SAID THAT HE WAS VERY IMPRESSED WITH DROSTHOLM'S
PRESENTATION OF POSSIBLE PRODUCTION OF CONSTRUCTION MATERIALS
LIKE BLOCKS IN MICRONESIA THROUGH THE USE OF LOCAL RESOURCES.
HE INDICATED THAT IT WOULD MEAN A SUBSTANTIAL REDUCTION IN
THE COST TO ALL PEOPLE WHO WISH TO BUILD THEIR HOMES. "THE
STUDY SAMPLES WHICH HAVE BEEN TAKEN WILL BE COMING SOON AND
AT WHICH TIME WE'RE GOING TO LOOK VERY CLOSELY INTO IT WITH
THE HOPE OF MOVING RAPIDLY IN SETTING UP A RESOURCE FACILITY
OF THIS TYPE IN MICRONESIA."

OF THE TERRITORY'S SOIL AND LIMESTONE RESOURCES WILL RESULT 1 1211

IN THE DEVELOPMENT OF AN ECONOMICAL AND LOCALLY PRODUCED BUILDING MATERIALS FOR HOUSING AND OTHER CONSTRUCTION USES. COLEMAN SAID.
