CONCERNING FUTURE ADMINISTRATION OF MARIANAS, YOU SHOULD ADHERE TO OUR PAST POSITION (PARA 3 REF C) THAT WHILE MARIANAS MAY BE ADMINISTERED SEPARATELY BEFORE THE END OF THE TRUSTEESHIP THE UNITED STATES INTENDS TO TERMINATE THE TRUST AGREEMENT FOR ALL MICRONESIA SIMULTANEOUSLY. YOU ALSO MAY SAY THAT USG HAS RECEIVED

RESOLUTION NO. 1-1974 PASSED BY THE MARIANAS DISTRICT LEGISLATURE OF SEPTEMBER 7, 1974 WHICH REQUESTS THAT THE MARIANAS DISTRICT BE ADMINISTERED SEPARATELY FROM THE OTHER DISTRICTS OF THE TRUST TERRITORY "AS SOON AS POSSIBLE AFTER THE APPROVAL OF THE AGREEMENT CONCERNING THE FUTURE POLITICAL STATUS OF THE DISTRICT BY THE PEOPLE THEREOF."
