THIS AGREEMENT, made this _____day of _____, 1974, by and between the COMMANDING OFFICER, KWAJALEIN MISSILE RANGE (KMR) and the GOVERNMENT of the TRUST TERRITORY OF THE PACIFIC ISLANDS (TTPI). The following facilities, services, and supplies shall be provided by KMR to TTPI and TTPI citizens on a reimbursable basis:

Facilities and Services

 I. Provide TTPI ships with water, food, ship supplies, fuel and laundry services to the extent not available from other local sources, and to the extent available from KMR resources.

2. Provide emergency repairs and tow services for TTPI and Micronesian boats.

3. Provide transient billeting and messing facilities for TTPI and Micronesian personnel on official business. Billeting will be provided on an as-available basis.

4. Provide access to retail outlets and similar services for TTPI Government personnel on official business at KMR.

5. Perform emergency medical evacuations, air drops of emergency medical/food supplies, and search and rescue operations.

6. Provide occasional mortician services.

7. Provide in-patient and sick-call medical services for TTPI personnel assigned at KMR and Micronesian personnel employed by the LSC.

8. Provide emergency dental and medical consultation, treatment, and hospitalization for TTPI employees and Micronesian citizens upon referral by the senior medical officer of the Ebeye Hospital or the District Administrator's Representative, Kwajalein Atoll.

9. Provide essential charter aircraft services for TTPI visiting dignitaries and working groups only when requirement cannot be satisfied by commercial airline. Requires approval of higher headquarters.

Provide essential trucking services on Kwajalein for TTPI cargo
 to, from and between air/harbor terminals and warehouses.
 Provide transportation for Air Micronesia passengers and

12. Provide KMR school facilities for dependent children of DISTADREP, Assistant DISTADREP, and certain TTPI key management personnel on Ebeye.

baggage from air terminal to marine terminal.

 Provide employment at KMR for a designated number of Micronesian personnel. The maximum number of Micronesian
 employees will be determined by BMDSCOM.

14. Provide two sets of family quarters (DISTADREP/AssistantDISTADREP) on Kwajalein.

15. Provide maintenance for TTPI vehicles on Kwajalein.

16. Provide maintenance services for TTPI communications equipment on Kwajalein.

17. Provide maintenance assistance for TTPI equipment on Ebeye when beyond the capability of TTPI. Includes drydocking and overhaul of TTPI watercraft on a noninterference basis with KMR maintenance.

18. Provide computer services to TTPI Government when requested on an as-available basis.

19. Provide other services and support at the discretion of the CO KMR in the best interest of the United States and in furtherance of the obligations assumed by the United States under the Trusteeship Agreement.

Supplies

1. Provide medical supplies, in emergencies.

2. Provide frozen food and produce, as available, in case lots or in bulk to agents designated by TTPI until such time as reefer storage capability can be established by TTPI.

3. Provide bread and other bakery products, as available, to agents designated by TTPI until such time as the TTPI develops capability to provide such products.

4. Provide rice and other food staples to TTPI or agents designated by TTPI, as available, to meet emergency requirements.

5. Provide building materials, office supplies, and other items of general supply to meet critical requirements.

6. Provide fresh water to Ebeye, as available, to meet critical requirements.

7. Provide on a reimbursable basis fuel, food, and necessities of life not otherwise available to the residents of the far-reaching islands of Ennubirr, Ebadon, and Arbwe. Amount to be controlled through KMR directives.

8. Provide access to KMR retail facilities to designated Trust Territory of the Pacific Islands U.S. employees and Kwajalein Atoll based U.S. citizen clergy.

9. Provide access to KMR retail facilities to the four (4) Kwajalein Atoll paramount Marshallese Traditional Chiefs (Iroij).

10. Provide prepared, food catering services to Trust Territory citizens for special events; i.e., first birthdays, funeral celebrations, church festivals and municipal functions within the capability of KMR, and upon approval of the Commander, KMR, or designated representative.

AGREEMENT

BETWEEN

THE COMMANDING OFFICER, KWAJALEIN MISSILE RANGE (KMR)

AND

THE DISTRICT ADMINISTRATOR (DISTAD), MARSHALL ISLANDS TRUST TERRITORY OF THE PACIFIC ISLANDS (TTPI)

WHEREAS, the Commanding Officer of the KMR has the need for the services of one or more representatives of the TTPI to reside full time on Kwajalein, and,

WHEREAS, the Government of the TTPI has consented to provide the requested representatives, it is hereby agreed:

1. The Commanding Officer, KMR, will provide the following facilities and services to the TTPI representatives assigned to KMR:

a. Provide office space for DISTADREP on Kwajalein.

b. Provide air and sea terminal facilities for authorized

TTPI visitors to KMR.

c. Provide use of KMR airfield and air navigation facilities for TTPI Government-owned/chartered aircraft. Provide docking and berthing services for TTPI-owned/chartered vessels visiting on official business.

d. Provide utilities and furnishings for assigned TTPI office and quarters (quarters telephones excluded) on Kwajalein.

e. Provide bus service for TTPI personnel on Kwajalein.
Provide taxi service for personnel on official business.
f. Provide explosive ordnance disposal service on
Kwajalein Atoll Islands.

g. Provide guard mail pickup and delivery for TTPI Representative on Kwajalein.

h. Offer property disposal items to TTPI in accordance with applicable DOD/DA Regulations.

i. Advise DISTADREP of communications assistance required in dissemination of Range Safety announcements. Provide Range Safety information and instructions.

j. Provide communications assistance to DISTADREP through KMR communications facilities.

k. Provide DISTADREP with Army publications of interest or essential to TTPI operations.

1. Provide use of AFRS facilities for Micronesian programs and spot announcements.

m. On special occasions and/or emergency situations, advise DISTADREP of Micronesian crowd control and police requirements.

n. Request appointment of LSC personnel as agricultural and quarantine inspectors.

o. Request appointment of LSC security guards as law enforcement officials of the TTPI.

p. Request appointment of KMR Community Court Judges.
q. Provide investigation and court facilities in High Court cases involving violation of TTPI Code on KMR-controlled islands.

r. Implement TTPI agricultural and quarantine procedure for arriving surface craft and Military Airlift Command aircraft.

s. Provide temporary storage on Kwajalein pier, as available, for Kwajalein Atoll cargo and in an emergency Majuro cargo.

2. The TTPI, through the DISTAD, will assign requested personnel to KMR and the said TTPI representatives will provide the following services, as required, to the Commanding Officer, KMR:

> a. Provide DISTADREP on Kwajalein. Provide advice and assistance to KMR on TTPI matters. Provide Marshallese translator for official KMR/TTPI business. Provide U.S. Consulate services for KMR residents, to include obtaining permission for visits to outer islands.

b. Locate and mark ordnance items for disposal.

• c. Disseminate Range Safety announcements through TTPI communications channels to all TTPI and Micronesian

personnel who could be affected by KMR activities.d. Provide communications assistance through establishedTTPI channels.

e. Provide KMR with TIPI publications of interest essential to KMR operations. Provide copies of Congress of Micronesia and Marshall Islands Nitijela legislation of interest to KMR.

f. Monitor Micronesian programs. Assist KMR in preparation and making announcements in Marshallese.
g. Provide police assistance from TTPI sources when required.

h. Appoint inspectors as requested.

i. Appoint judges as requested.

k. Provide High Court Judge, prosecutor, public defender, translator, and clerk to try cases when required.

1. Provide agricultural assistance for KMR-controlled islands, including seeds, seedlings, plants, etc.

a. Implement TTPI agricultural and quarantine procedures
