THE HEAVY DOWNPOUR OF RAIN THAT WELCOMED THE SENATOR TO SAIPAN DID NOT APPEAR TO DAMPEN HIS PHENOMONAL SPIRIT AND DRIVE.

ON HAND TO GREET THE SENATOR WERE HIGH COMMISSIONER EDWARD E. JOHNSTON, DEPUTY HIGH COMMISSIONER PETER T. COLEMAN; MARIANAS DISTRICT ADMINISTRATOR FRANCISCO C. ADA; MARIANAS DISTRICT PUBLIC AFFAIRS OFFICER DAVID Q. MARATITA AND THE POLICE HONOR GUARD.

SENATOR FONG IS ACCOMPANIED BY HIS WIFE, ELLYN, AND HIS ADMINISTRATIVE ASSISTANT, ALYCE THOMPSON AND AN AIR FORCE OFFICER. MAJOR ROSS A. POWELL.

THE SENATOR WILL TRAVEL TO PONAPE, AND KWAJALEIN BEFORE RETURNING TO HONOLULU SOMETIME THIS WEEK.

HE IS PARTICULARLY INTERESTED IN DISCUSSING THE STATUS OF DEFENSE INSTALLATIONS AND DEFENSE PLANNING AS IT RELATES TO ANY PROPOSED PULLBACK OF AMERICAN FORCES FROM COUNTRIES ON THE PACIFIC RIM.

WILLIAM MITCHELL), WHO GRADUATED WITH A MASTERS DEGREE FROM WELLESLEY COLLEGE, MASSACHUSSETTS: AND MARVIN ALLAN, NOW ATTENDING THE INTERNATIONAL SCHOOL OF LAW IN WASHINGTON, D.C.

SENATOR FONG GRADUATED FROM THE UNIVERSITY OF HAWAII WITH HONORS AND IS A MEMBER OF PHI BETA KAPPA. HE STUDIED LAW AT HARVARD UNIVERSITY WHERE HE RECEIVED HIS DOCTOR OF JURISPRUDENCE DEGREE IN 1935.

HIS EDUCATION WAS INTERUPTED TWICE FOR LACK OF FUNDS. THREE YEARS IN HIGH SCHOOL AND TWO YEARS AT THE UNIVERSITY.

HE WAS ALSO THE RECIPIENT OF SIX HONORARY DEGREES FROM VARIOUS UNIVERSITIES.

SENATOR FONG ALSO FOUNDED THE COSMOPOLITAN LAW FIRM OF FONG. MIHO, CHOY AND ROBINSON. HE RESIGNED FROM THE FIRM AFTER TAKING OFFICE AS UNITED STATES SENATOR.

A VETERAN OF WORLD WAR II. HE ENTERED THE U.S. ARMY CORPS OF ENGINEER IN 1942-44. HE ENTERED AS A IST. LIEUTENANT, WAS PROMOTED TO MAJOR AND SERVED AS A JUDGE ADVOCATE OF THE 7TH FIGHTER COMMAND OF THE 7TH AIR FORCE. HE IS NOW A RETIRED COLONEL. HE SERVED ON THE BOARD OF VISITORS OF BOTH THE U.S. MILITARY ACADEMY AT WEST POINT AND THE U.S. NAVAL ACADEMY IN ANNAPOLIS.

SENATOR FONG HAS BEEN ACTIVE IN MANY SERVICE AND CIVIC ORGANIZATIONS IN HAWAII. HE IS A MEMBER OS HARVARD CHUR IN HAWAII. CHAMBER OF COMMERCE, BOY SCOUTS, THE ARMY, NAVY AND CIVILIAN YOUNG MEN'S CHRISTIAN ASSOCIATIONS AND VARIOUS OTHER ORGANIZATIONS.

HE ALSO WAS THE RECIPIENT OF A NUMBER OF HONORS INCLUDING AN ELECTOR FOR THE HALL OF FAME: THE HORATIO ALGER AWARD FOR OUTSTANDING SUCCESS IN LAW, BUSINESS, AND PUBLIC SERVICE DESPITE HUMBLE BEGINNINGS (SELECTED BY BALLOTS DISTRIBUTED ANONG 500 U.S. COLLEGES) AND WAS THE FIRST CITIZEN OF HAWAII TO RECEIVE THIS AWARD; THE GOLDEN PLATE AWARD BY THE AMERICAN ACADEMY OF ACHIEVEMENTS, AND NUMEROUS OTHER AWARDS.

SENATOR FONG WAS DEPUTY ATTORNEY FOR THE CITY AND COUNTRY OF HONOLULU FROM 1935 TO 1938. HE SERVED FOURTEEN YEARS IN THE LEGISLATURE OF THE TERRITORY OF HAWAII INCLUDING FOUR YEARS AS VICE-SPEAKER OF THE HOUSE OF REPRESENTATIVES AND SIX YEARS AS 11587 SPEAKER. HE WAS ALSO VICE-PRESIDENT OF OF THE HAWAII STATE CONSTITUTIONAL CONVENTION.

HE WAS ELECTED TO THE U.S. SENATE IN JULY 28, 1959. THE SENIOR SENATOR FROM HAWAII WAS RE-ELECTED IN 1964 AND AGAIN IN NOVEMBER 1970.

REPUBLICAN SENATOR FONG WON 53.03 PERCENT OF THE VOTES IN 1954 IN THE FACE OF A DEMOCRATIC PRESIDENTIAL LANDSLIDE IN WHICH FORMER PRESIDENT LYNDON B. JOHNSON SWEPT HAWAII.

IN THAT ELECTION, SENATOR FONG SET AN ALL-TIME RECORD IN SENATORIAL ELECTIONS. HE BROKE THE PREVIOUS RECORD HELD BY THE LATE DEMOCRATIC SENATOR HARRY F. BYRD.

THE SENATOR IS A MEMBER OF NUMEROUS U.S. SENATE COMMITTEES AND SUB-COMMITTEES.

(U.N. DAY MESSAGE) SAIPAN, OCT. 22 (MNS) --- THE FOLLOWING IS A UNITED NATIONS DAY MESSAGE BY THE PRESIDENT OF THE TRUSTEESHIP COUNCIL, SIR LAURENCE MCINTYRE OF AUSTRALIA, TO THE PEOPLES OF THE TRUST TERRITORY OF THE PACIFIC ISLANDS AND PAPUA NEW GUINEA.

"ON THIS TWENTY-NINTH ANNIVERSARY OF THE UNITED NATIONS I SEND WARM GREETINGS FROM THE TRUSTEESHIP COUNCIL TO THE PEOPLES OF PAPUA NEW GUINEA AND THE TRUST TERRITORY OF THE PACIFIC ISLANDS, THE COUNCIL'S LAST REMAINING RESPONSIBILITIES OF THE ORIGINAL ELEVEN WITH WHICH IT WAS FIRST CHARGED. I AM PRIVILEGED TO TO CONVEY TO YOU MY BEST WISHES FOR YOUR WELL BEING AND FUTURE PROSPERITY.

"THE TRUSTEESHIP COUNCIL HAS FOLLOWED WITH GREAT INTEREST THE SUCCESSIVE STEPS THAT BOTH TERRITORIES HAVE TAKEN TOWARDS THE ATTAINMENT OF THE OBJECTIVES OF THE UNITED NATIONS CHARTER. THIS YEAR THE COUNCIL HAS MET IN JUNE AND AGAIN IN OCTOBER TO CONSIDER THE SITUATION IN THE TWO TERRITORIES.

"AT ITS MEETINGS IN JUNE THE TRUSTEESHIP COUNCIL HEARD AND DEBATED REPORTS ON CONDITIONS IN THE TRUST TERRITORY OF THE PACIFIC ISLANDS AND REVIEWED THE PROGRESS MADE IN THE PAST YEAR. IN THIS WE WERE GREATLY HELPED BY THE PARTICIPATION IN OUR DISCUSSIONS OF THE HIGH COMMISSIONER MR. EDWARD JOHNSTON AND SENATOR WILFRED KENDALL AND REPRESENTATIVE JOAB SIGRAH FROM THE CONGRESS OF MICRONESIA.

"IN STUDYING WITH CLOSE ATTENTION THE CONTINUING DISCUSSIONS OF THE FUTURE OF THE TERRITORY, THE COUNCIL NOTED THAT THE FUTURE POLITICAL STATUS OF MICRONESIA SHOULD BE APPROVED NOT ONLY BY THE UNITED STATES CONGRESS BUT ALSO BY THE CONGRESS OF MICRONESIA AND PARTICULARLY BY THE PEOPLE OF MICRONESIA BY MEANS OF A FREE CONSULTATION WHICH WOULD TAKE PLACE IN THE PRESENCE OF THE UNITED NATIONS.

"THE COUNCIL CONSIDERED PAPUA NEW GUINEA DURING OCTOBER, WHERE WE WERE GREATLY ASSISTED IN OUR WORK BY MR. ALBERT MAORI KIKI, MEMBER OF THE HOUSE OF ASSEMBLY AND MINISTER FOR DEFENSE, FOREIGN RELATIONS AND TRADE: MR. PAULIAS MATANE, SECRETARY OF THE DEPARTMENT OF BUSINESS DEVELOPMENT: AND MR. MCKENZIE DAUGI, MEMBER OF THE HOUSE OF ASSEMBLY WITH A SPECIAL INTEREST IN EDUCATION.

"THE COUNCIL FOUND PARTICULAR SATISFACTION IN THE ATTAINMENT OF PAPUA NEW GUINEA OF SELF-GOVERNMENT ON 1 DECEMBER 1973 AND THE FURTHER DEVOLUTION OF AUTHORITY FROM THE ADMINISTERING AUTHORITY TO THE GOVERNMENT OF PAPUA NEW GUINEA IN PREPARATION FOR INDEPENDENCE IN THE NEAR FUTURE.
