(CONGRESS LEADERSHIP, MEETING)

SAIPAN, NOV. 29/2(CONGRESS RELEASE) 123 MEETING OF THE CONGRESS OF MICRONESIA LEADERSHIP WAS CONVENED ON SAIPAN, THURSDAY (NOV. 28) TO DISCUSS SEVERAL IMPORTANT ISSUES, INCLUDING RETURN OF PUBLIC LANDS, AND PREPARATIONS FOR THE FORTHCOMING FIRST REGULAR SESSION OF THE SIXTH CONGRESS OF MICRONESIA.

THE CONGRESS WAS INFORMED BY DISPATCH ON NOVEMBER 21, THAT THE DEPARTMENT OF INTERIOR HAD DRAFTED A SECRETARIAL ORDER WHICH WOULD RETURN CERTAIN PUBLIC LANDS TO MICRONESIAN CONTROL

BE EXCUTIVE ORDER OF THE HIGH COMMISSIONER.

THIS ACTION FOLLOWED THE HIGH COMMISSIONER'S VETO OF LEGISLATION ANACTED BY THE CONGRESS OF MICRONESIA IN AUGUST WHICH WOULD HAVE RETURNED PUBLIC LANDS TO THE DISTRICTS.

IN A DISTPATCH RELAYED BY THE HICOM FROM DIRECTOR OF TERRITORIAL AFFAIRS STANLEY CARPENTER, THE CONGRESS AND OTHER MICRONESIAN LEADERS WERE INVITED TO "CONSULT" WITH INTERIOR REPRESENTATIVES IN HONOLULU, BEFORE THE ORDER WAS ISSUED.

IN THEIR THURSDAY MEETING, THE LEADERSHIP DISCUSSED THIS MATTER, AND DETERMINED THAT BEFORE TAKING ANY FURTHER ACTION, THEY WOULD INVITE THE SPEAKERS AND PRESIDENTS OF LEGISLATURES, AND TRADITIONAL CHIEFS FROM EACH OF THE DISTRICTS TO MEET ON SAIPAN WITH THE LEADERSHIP. THE PURPOSE OF THE MEETING WILL BE TO INFORM THE DISTRICT LEADERS OF THE IMPLICATIONS OF THE PROPOSED OPDER, AND TO SEEK THEIR VIEWS AND RECOMMENDATIONS.

DISTRICT ADMINISTRATORS FROM THE SIX DISTRICTS WERE ALSO INVITED TO ATTEND THE MEETING WHICH IS SCHEDULED FOR TUESDAY,

DECEMBER 3, 1974.

ON FRIDAY, NOVEMBER 29, THE LEADERSHIP DISCUSSED THE COMING SESSION OF THE CONGRESS, INCLUDING THE TOPICS OF NEW LEGISLATION, LOGISTICS, COORDINATION WITH THE EXECUTIVE BRANCH, AND STAFFING.

ATTENDING THE MEETING WERE: SENATE PRESIDENT TOSIWO NAKAYAMA, HOUSE SPEAKER BETHWEL HENRY, SENATE VICE PRESIDENT LAZARUS SALII, HOUSE VICE SPEAKER ENDY DOIS, SENATE FLOOR LEADER AMBILOS IEHSI, SENATE CLERK SASO ULOCHONG, AND HOUSE CLERK ASTERIO TAKESY. ALSO PARTICIPATING IN THE DISCUSSIONS WERE SENATORS ANDON AMARAICH AND JOHN MANGEFEL, AND REPRESENTATIVES RAYMOND SETIK AND SASAUO HARUO.

ANDERSON, HE HAS HAD INCREASING RESPONSIBILITY FOR THE GATHERING AND WRITING OF NEWS MATERIAL FOR THE FIVE-DAY-A-WEEK WIRE SERVICE, WHICH IS SUPPLIED TO THE SIX GCVERNMENT OPERATED RADIO STATIONS IN MICRONESIA AS WELL AS TO A VARIETY OF OTHER MEDIA OUTLETS AND GOVERNMENT OFFICES. THE NEWS SERVICE IS A FUNCTION OF THE PUBLIC INFORMATION DIVISION OF THE TI GOVERNMENT, WHICH ALSO PUBLISHES THE REPORTER AND THE BI-WEEKLY NEWSLETTER "HIGHLIGHTS."

PRIOR TO JOINING THE DIVISION, ROSARIO WAS FOR THREE YEARS AN ANNOUNCER AND NEWS DIRECTOR FOR RADIO STATION KJOR ON SAIPAN.

DEFENSE INFORMATION SCHOOL AT FORT BENJAMIN HARRISON, INDIANA. RAMON, 27, WAS FORMERLY WITH THE PONAPE DISTRICT DEPARTMENT OF EDUCATION, WHERE HE WAS THE DISTICT SOCIAL STUDIES SPECIALIST. HE RECEIVED A BACKELOR'S DEGREE IN EDUCATION FROM THE UNIVERSITY OF GUAM IN 1971. WHILE IN COLLEGE, RAMON WAS EDITOR OF THE MICRONESIAN STUDENT NEWSPAPER AT THE UNIVERSITY OF GUAM, AND SINCE THEN HE HAS BEEN A FREQUENT CONTRIBUTOR OF THE MAJURO-BASED NEWSPAPER "MICRONESIAN INDEPENDENT." THE "PACIFIC DAILY NEWS" ON GUAM, AND TO MNS.
