LACK OF THIS AUTHORIZATION, HE BELIEVES, COULD DELAY PROGRESS IN NEGOTIATIONS, FARTICULARLY WITH THE NEED FOR FUNDING OF A JOINT TRANSITION SECRETARIAT ONCE THE AGREEMENT IS SIGNED. UNQUOTE. HOUSE STAFF BELIEVES THAT CONSIDERATION OF AUTHORIZATION AND APPROPRIATION COULD MOVE EXPEDITIOUSLY IN FIRST QUARTER OF NEXT SESSION. 3.
