SAIPAN, DEC. 27 (MNS)---ELACK MICRO CONSTRUCTION COMPANY WAS AWARDED A CONTRACT BY THE TRUST TERRITORY GOVERNMENT LAST WEEK FOR THE COMPLETE CONSTRUCTION OF THE TERMINAL BUILDING AND ALL LANDSCAPING AT THE NEW SAIPAN INTERNATIONAL AIRPORT, DIRECTOR OF PUBLIC WORKS JAKES R. WHEELER MADE THE AWARD.

BLACK MICRO SUBMITTED THE LOWEST BID OF \$3,987,000 WHICH INCLUDES \$2,787,030 FOR COMPLETE CONSTRUCTION OF TERMINAL BUILDING AND \$169,200 FOR ALL LANDSCAPING.

THE SECOND LOWEGT BIDDER WAS SHIMIZU/SABLAN CONSTRUCTION COMPANY, A JOINT VENTURE WITH A JAPANESE CONSTRUCTION FIRM WITH A BID OF \$3,700,900.

THE HIGHEST BIDDER WAS HAVAIN DREDGING, DILLINGHAM CORFORATIONS'S CONSTRUCTION BRANCK WHICH BID \$4,074,800.

THE COVERNMENT ENGINEER'S ESTIMATE WAS \$4,974,800 OF WHICH \$3,939,360 WAS FOR THE TERMINAL BUILDING AND \$135,500 FOR LANDSCAPING.

INCREMENT TWO OF THE PROJECT INCLUDES THE DEPARTURES BUILDING, MAIN ENTRANCE AREA WITH A RAMP SYSTEM, THE WAITING ROOM, BUTY-FREE SHOP, RESTAURANT AND A BAR, A FLIGHT KITCHEN, ALL OF THE AIRLINES COUNTER OPERATIONS AND TWO OUTSIDE GARDEN-WAITING ROOM.

THE BID ALSO INCLUDES A MINOR RENOVATION OF THE DEPARTURES BUILDING PRESENTLY UNDER CONSTRUCTION BY THE SABLAN CONSTRUCTION COMPANY. THE RENOVATION IS TO CONVERT THAT BUILDING INTO A FULLY OPERATIONAL ARRIVAL BUILDING AND IS SCHEDULED FOR COMPLETION IN JUNE 1975.

THE RESTAURANT, BAR AND DUTY-FREE SHOP ARE SCHEDULED FOR COMPLETION ON MARCH 19, 1975. ALL OTHER BUILDINGS SHOULD BE COMPLETED 550 CALENDAR DAYS CONTRACT TIME FROM THE DATE THE CONTRACTORS RECEIVED A NOTICE TO PROCEED CONSTRUCTION.

(CARPENTER, DIRECTOR OF TERRITORIAL AFFAIRS, RETURNING TO STATE)

WASHINGTON, D.C. DECEMBER 28 (MNS)---SECRETARY OF THE INTERIOR ROGERS C. B. MORTON ANNOUNCED TODAY THAT STANLEY S. CARPENTER, DIRECTOR OF TERRITORIAL AFFAIRS, WILL RETURN TO THE STATE DEPARTMENT IN EARLY JANUARY TO RESUME HIS CAREER IN THE FOREIGN SERVICE. MR. CARPENTER IS A FOREIGN SERVICE OFFICER WHO HAS BEEN ON LOAN FROM THE DEPARTMENT OF STATE TO INTERIOR SINCE JANUARY OF 1972.

SECRETARY MORION SAID, "STAN CARPENTER APPROACHED ME IN OCTOVER ABOUT RETURNING TO THE FOREIGN SERVICE. WHILE I REGRET VERY MUCH LOSING MR. CARPENTER, I AGREED TO HIS REQUEST AND I HAVE BEEN IN CONSULTATIONS WITH DEPUTY SECRETARY OF STATE ROBERT S. INGERSOLL REGARDING THIS CHANGE. I HAVE BEEN VERY PLEASED WITH MR. CARPENTER'.S PERFORMANCE AS DIRECTOR OF TERRITORIAL AFFAIRS AND WISH HIM WELL AS HE RETURNS TO HIS FOREIGN SERVICE CAREER."

MR. CARPENTER WILL JOIN THE FOREIGN SERVICE INSPECTION CORPS OF THE DEPARTMENT OF STATE AND, AS HIS FIRST ASSIGNMENT, WILL LEAD AN INSPECTION TEAM TO THE AMERICAN ENBASSIES IN KOREA AND TAIWAN.

(MORTON ISSUES SECRETARIAL ORDER TO RETURN TRUST TERRITORY PUBLIC LANDS TO MICHONESIANS)

WASHINGTON, D.C. DECENDER 28 (MNS) ---SECRETARY OF THE INTERIOR ROGERS C.B. MORTON ANNOUNCED FRIDAY (DEC. 27 WASHINGTON TIME) THE ISSUANCE OF A SECRETARIAL ORDER WHICH WILL RETURN ALL UNUSED PUBLIC LANDS IN THE TRUST TERRITORY OF THE PACIFIC ISLANDS TO LOCAL MICRONESIAN OWNERSHIP AND CONTROL. THE SECRETARY'S ORDER, WHICH WILL BE MADE PART OF THE TRUST TERRITORY CODE, PROVIDES THE LEGAL FRAMEWORK FOR EACH DISTRICT OF MICRONESIA TO REQUEST AND RECEIVE TITLE TO APPLICABLE PUBLIC LANDS WITHIN ITS JURISDICTION.

THE GOAL OF THE SECRETARIAL ORDER IS TO FULFILL REPEATED MICRONESIAN REQUEST THAT TRUST TERRITORY GOVERNMENT PUBLIC LAND (ABOUT 60 PERCENT OF THE LAND AREA OF MICRONESIA) BE FINALLY RELEGATED TO DISTRICT OWNERSHIP AND THE SECRETARIAL ORDER WAS ISSUED AFTER CONSULTATIONS WITH MICRONESIAN REPRESENTATIVES GOING BACK OVER A YEAR AND A HALF. THE SECRETARIAL ORDER CALLS FOR EACH DISTRICT LEGISLATURE TO SET UP A LOCALLY CONSTITUTED "LEGAL ENTITY" OR LAND BOARD TO HOLD TITLE.

THE PURPOSE OF THE ORDER IS TO IMPLEMENT THE PROVISIONS OF THE UNITED STATES POLICY STATEMENT OF NOVEMBER 4, 1973, TO AUTHORIZE AND EMPOWER EACH OF THE DISTRICT LEGISLATURES TO CREATE OR TO DESIGNATE A LEGAL ENTITY WITHIN ITS DISTRICT TO HOLD TITLE TO PUBLIC LANDS WITHIN THAT DISTRICT IN TRUST FOR THE PEOPLE THEREOF AND TO MANAGE OR DISPOESE OF THE SAME, TO AUTHORIZE AND EMPOWER EACH DISTRICT LEGISLATURE TO ENACT LAWS PROVIDING FOR THE EXCERCISE OF THE POWER OF EMINENT DOMAIN AND TO ESTABLISH ADJUDICATORY BODIES WHICH MAY UTILIZE TRADITIONAL MEANS, WHEN APPROPRIATE, FOR SETTLEMENT OF CLAIMS TO TITLE OF RIGHTS IN THE LANDS TRANSFERRED, AND TO AUTHORIZE THE HIGH COMMISSIONER, UPON A FORMAL REQUEST BY A DISTRICT LEGISLATURE, TO CONVEY CERTAIN PUBLIC LANDS TO SUCH A LEGAL ENTITY WITHIN EACH DISTRICT.

THE DISTRICT LAND BOARDS WILL ALSO BE REQUIRED TO ABIDE BY CERTAIN SAFEGUARDS AND LIMITATIONS INCLUDED IN THE SECRETARIAL ORDER AND DESIGNED PRIMARILY TO FACILITATE ADMINISTRATION. ONCE THE PUBLIC LANDS ARE TRANSFERRED TO DISTRICT LAND BOARDS, REVENUES RECEIVED FROM THOSE PUBLIC LANDS WILL ACCRUE TO THE DISTRICT LEGISLATURES.

WITH THE ISSUANCE OF THE SECRETARIAL ORDER, WHICH IS NUMBER 2969, THE NEXT STEP IN THE PROCESS OF THE PUBLIC LAND RETURN IS FOR ANY DISTRICT DESIRING TRANSFER OF PUBLIC LANDS TO SO INFORM THE HIGH COMMISSIONER THROUGH A RESOLUTION OF ITS DISTRICT LEGISLATURE. THE LEGISLATURE MUST CREATE A "LEGAL ENTITY" OR LAND BOARD WHICH COMPLIES WITH THE SPECIFICATIONS OF THE SECRETARIAL ORDER TO RECEIVE TITLE AND CONTROL. THE DISTRICTS MAY ALSO ESTABLISH A LOCAL ADJUDICATORY BODY TO DECIDE UPON THE FINAL RIGHTFUL OWNERSHIP OF THE LANDS IN QUESTION.

SECRETARY MORTON ANNOUNCED THE NEW ORDER IN A LETTER TO THE SPEAKER AND THE PRESIDENT OF THE CONGRESS OF MICRONESIA. THE TEXT OF THE SECRETARY'S LETTER WAS ALSO MADE PUBLIC TODAY.
