SAIPAN, FEE. 23 (CONGRESS RELEASE) --- THE CONCEPT OF A LOOSE FEDERATION OF SEMI-AUTONOMOUS MICRONESIAN STATES DREW SUPPORT FROM PALAU AND MARSHALL ISLANDS DELEGATES TO THE CONGRESS OF MICRONESIA DURING A FRIDAY (FZD. 22) EVENING SESSION.

MARSHALLS SENATOR WILFRED KENDALL AND PALAU REPRESENTATIVE TIMOTHY OLKERIL BOTH TOOK THE FLOOR IN THEIR RESPECTIVE HOUSES ADVOCATING A LOOSE FEDERATION AS THE BEST STRUCTURE FOR THE FUTURE GOVERNENT OF NICRONESIA BECAUSE IN THEIR OPINION IT IS THE ONLY WAY REALITIES OF CULTURAL DIVERSITY AND OTHER DIFFERENCES AMONG MICRONESIA'S SIX DISTRICTS CAN BE TAKEN INTO ACCOUNT.

"MICRONESIA MAS BEEN CALLED AN 'HISTORICAL ACCIDENT,'
KENDALL TOLD THE SENATE IN A PREPARED STATEMENT, "AND RIGHTLY
SO. THREE HUGE ISLAND GROUPS, THE MARSHALLS, NARIANAS, AND
CAROLINE ISLANDS, OVER 2,000 ISLANDS IN ALL, SCATTERED OVER
THREE MILLION SQUARE MILES OF WATER, WERE SIMPLY BROUGHT
TOGETHER AS SPOILS OF WAR FOR ADMINISTRATIVE PURPOSES BY
COLONIAL POWERS."

THE MARSHALLS SENATOR ADMITTED, HOWEVER, THAT THIS "IMPOSED TOGETHER MESS" SINCE THE TURN OF THE CENTURY HAS GIVEN MICRONESIA A "COMMON BOND" TO A CERTAIN EXTENT, " BUT AS WE LOOK TO THE FUTURE IN THE ADSENCE OF THIS IMPOSED RULE BY A FOREIGN POWER," SAID KENDALL. "FOR THE FIRST TIME OUR DIFFERENCES WILL BEGIN TO EMERGE IN THE WAY WE WANT TO RULE OUR SELVES."

KENDALL PRAISED PALAU SENATOR ROMAN TWETUCHL WHO HAS CHAMPIONED THE CONCEPT OF A LOOSE FEDERATION AND SAID: "HIS PLAN REPRESENTS A MATURE, NECESSARY, AND LOGICAL OUTCOME OF A PROCESS OF POLITICAL GROWTH AND DEVELOPMENT WHICH HE HAS PARTICIPATED IN SINCE HIS MEMBERSHIP IN THE COUNCIL OF MICROMESIA MANY YEARS AGO. HIS PROPOSAL CLEARLY RECOGNIZES THE FACT THAT FOR UNITY TO TRULY EXIST IN MICROMESIA, POLITICAL AND CULTURAL DIFFERENCES MUST BE ATTAINED AND STIFLED, WHICH IS UNNATURAL FOR ANY COUNTRY."

KENDALL URGED EACH CONGRESS DELEGATION TO HOLD PUBLIC HEARINGS IN THEIR RESPECTIVE DISTRICTS ON THE SUBJECT OF THE RELATIONSHIP OF THE DISTRICTS TO THEIR FUTURE CENTRAL GOVERNMENT, AND REPORT THEIR FINDING TO THE COMBRESS AS SOON AS POSSIBLE.

IN THE HOUSE OF REPRESENTATIVES, PALAU CONGRESSMAN OLKERIL DECLARED THAT THE PEOPLE OF HIS DISTRICT ARE CONVINCED THAT ANY FORM OF GOVERNMENT OTHER THAN A LOOSE FEDERATION" IS IMPOSSIBLE. REGARDLESS OF. WHETHER OR NOT A CLOSER UNITY MIGHT BE DESIRABLE."

"IT IS FOR THIS REASON THAT WE WILL ACCEPT NO OTHER FORM OF UNION," HE SAID.

OLKERIL ALSO TOOK EXCEPTION TO REMARKS DELIVERED IN THE HOUSE OF REPRESENTATIVES THURSDAY BY PONAPE REPRESENTATIVE SUNGIWO HADLEY FAVORING A STRONG CENTRAL GOVERNMENT, INDICATING HE FELT HADLEY MISINTERPRETED THE RESONS WHY PALAU FOVARS SUCH AN ARRANGEMENT. HADLEY HAD SUGGESTED THAT AMERICAN PROPOSALS TO MAINTAIN MILITARY FACILITIES IN PALAU, MARSHALLS AND THE MARIANAS DISTRICTS, TENDED TO ENCOURAGE DISUNITY AND SEPARATISM, SO THAT REVENUES DERIVED FROM THESE INSTALLATIONS WOULD REMAIN IN THOSE DISTRICTS.

HOWEVER, OLKERIIL, REFERRING TO A PETITION SIGNED BY THE LEADERS OF PALAU IN NOVEMBER OPPOSING ANY MILITARY PRESENCE

IN PALAU DISTRICT DECLIRED: "NOT OULY DO HE NOT WISH TO BENEFIT FROM MILITARY MONEY, WE ARE STRONGLY OPPOSED TO THE PRESENCE OF ANY MILITARY ACTIVITIES WHATEVER IN PALAU NOW OR IN THE FUTURE." HE ADDED THAT SINGE THE PETITION WAS CIRCULATED, SENTIMENTS IN PALAU HAVE BECOME MORE ANTI-MILITARY, AND THIS WAS ONE OF THE PRINCIPLE FOR MICRONESIA.

"AS LOWS AS THE DECISION RESTS WITH THE PEOPLE OF PALAU." HE SAID, "THERE WILL BE NO MILITARY INSTALLATIONS ANYWHERE IN OUR DISTRICT.

OLVERIIL SAID HIS PEOPLE WANT TO HAVE TH POWER TO DENY THE MILITARY ACCESS TO PALAU, A POWER WHICH HE INDICATED WOULD BE IN THE HANDS OF A STRONG CENTRAL GOVERNMENT.

ANOTHER REALITY, HE SAID, IS THAT ALL MICRONESIAN DISTRICTS HAVE REPEATEDLY SHOWN THAT THEY RESENT CONTROL OF THEIR AFFAIRS BY OUTSIDERS. OLKERIIL SAID IT SOMETIMES APPEAR THAT THIS SEMIIMENT IS MOST CLEARLY SHOWN WHEN CONTROL IS EXCERCISED BY OTHER MICRONESIANS.

THE TURNING DISPUTE PETWEEN THE MARSHALLS DISTRICT AND THE REST OF THE CONGRESS OVER REVENUE SHARING IS AN EXAMPLE AND A FORETASTE OF WHAT WE CAN EXPECT IF ONE DAY WE ARE UNDER A STRONG CENTRAL MICRONESIAN GOVERNMENT," HE SAID. "DIVIDE AND CONQUER HAS ALREADY WORKED TOO WELL. WE MUST BE REALISTIC AND REALIZE THAT WE CANNOT TURN BACK THE CLOCK NO MATTER HOW MUCH WE MIGHT LIKE TO DO SO."

OLKERIIL DESCRIBEB A CENTRAL GOVERNMENT FOR MICRONESIA AS "CLUMSY" AND SAID WITHOUT THE ABSOLUTE POWER OF A COLONIAL ADMINISTRATION IT IS IMPOSSIBLE.

SAIPAN, FEBRUARY 23 (CONGRESS RELEASE)---REPRESENTATIVE FELIPE 9. ATALIG OF THE MARIANAS CALLED ATTENTION THIS WEEKEND TO THE PLIGHT OF THE EMPLOYEES OF THE TRUST TERRITORY'S EXCLUSIVE SHIPPING COMPANY, TRANSPACIFIC LINES, INC., WHICH WAS DECLARED BANKRUPT LAST WEEK.

ATALIG SAID IN A SPEECH IN THE HOUSE OF REPRESENTATIVES THAT TRANSPAC EMPLOYEES WERE INFORMEM BY GOVERNMENT AND BY THE RECEIVER FOR THE COMPANY THAT THERE WERE NO ASSURANCES THAT THEY WOULD BE PAID.

"NOT ONLY DOES THIS AFFECT THOSE EMPLOYEES OF TRANSPAC WHO WORK HERE ON SAIPAN AND OTHER DISTRICTS, BUT IT ALSO AFFECTS THOSECREWWENDERS WHO ARE PRESENTLY ABOARD THE M/V LOTTE REITH, WHICH IS PRESENTLY ON HER WAY TO THE WESTERN DISTRICTS OF YAP AND PALAU," HE SAID. REMINFING THE CONGRESS THAT ITS REPORT ON TRANSPAC BY THE RESOURCES AND DEVELOPMENT COMMITTEES URGED THE HIGH COMMISSIONER TO TAKE POSITIVE STEPS TO PROTECT AND FIND EMPLOYMENT FOR ALL PRESENT MICRONESIAN EMPLOYEES OF THE COMPANY, ATALIG SAID THAT IT DOES NOT MATTER IF, TECHNICALLY SPEAKING, THE FRANCHISE AGREEMENT HAS NOT YET BEEN TERMINATED. "IT IS A FACT THAT FINANCIALLY SPEAKING, THE COMPANY IS DEAD," HE SAID. "IT IS ALSO ANOTHER FACT THAT OUR

GOVERNMENT AND THE ADMINISTERING AUTHORITY HAVE THE OBLIGATION TO PROTECT THE RIGHTS AND WELFARE OF OUR CITIZENS."

WHILE HE SAID HE APPRECIATED THE GOVERNMENT'S ACTION OF PROVIDING FINANCIAL ASSISTANCE TO COVER BACK DEBTS OWED BY TRANSPAC LAST WEEK SO THE SHIPOUNERS OF THE LOTTE REITH WOULD NOT AUCTION OFF THE SHIP'S \$ 2 MILLION IN CARGO, ATALIG SAID HE HOPED THE ADMINISTRATION WOULD ACT QUICKLY TO HELP TRANSPAC'S EMPLOYEES. HE SAID THE MARIANAS DELEGATION DONATED \$150.00 AND URGED OTHER CONGRESS DELEGATIONS TO DO LIKEWISE TO EXPRESS THEIR CONCERN.
