



Building Permits

Despite a few problems in the civilian building business this past year-such as Program 20 and the FHA moratorium-the Building Permit and Inspection Division of the Department of Public Works reports that calendar year 1973 reached an all-time high in estimated construction costs.

The Division issued a total of 4,118 permits for an estimated cost of \$102,198,715, compared with 4,223 permits and \$86,123,125 for 1972, and 4,492 permits at \$63,767,366 for 1971. The 1973 figures show a dollar increase in excess of \$16 million over 1972, and \$38 million over 1971, while the total number of permits issued each year has decreased.

The rising cost of land, materials and construction, particularly in the residential field, is clearly reflected in the following table. Taken on a per home average basis, it cost \$15,635 to construct a house in 1971, \$18,936 in 1972, and \$27,223 in 1973. It cannot be said, however, that the jump is all due to rising prices-the houses are being built larger and a bit more luxurious than in previous years.

At artments also are getting larger and nicer. In 1972, the per-unit average was \$9,968, which jumped to \$15,074 last year. There are no accurate records available for the number of units constructed in the first half of 1971, and it would be difficult to estimate the per-unit cost for that year.

The following table, covering the last three calendar years, lists the number of permits issued and estimated costs. It does not include new buildings for non-profit organizations.

Contracts awarded over the past two months have included two to lack Peters. \$27,300 and \$44,700 for (1) replacement of the screen at Skyview Theatre, and (2) hydrant pit and cover modifications, both at Andersen AFB; two to Guam Painting, \$21,000 and \$53,352, also for work at Andersen AFB; one to Construction totaling \$638,900 for mass fill and project at Guam International Air Terminal, AJB Construction, \$184,126, for park Ipan and Talofofo park development, and \$15,555 to Mowil, Inc., for custodial services at NCS, Finegayan.
