(AIRLINE HEARINGS OPEN)

SAIPAN, MARCH 11 (MNS) --- RE-OPENED HEARINGS INTO THE SAIPAN/JAPAN AIRLINE ROUTE CASE CONVENED ON SAIPAN MONDAY MORNING (MARCH 114) BEFORE ADMINISTRATIVE LAW JUDGE GREER MURPHY OF THE UNITED STATES CIVIL AERONAUTICS BOARD.

THE PROCEEDINGS, EXPECTED TO LAST FROM THREE WEEKS TO A MONTH, WILL BE IN TWO PHASES, ACCORDING TO CAB OFFICIALS. PHASE ONE WILL EXAMINE THE QUESTION OF WHETHER THE AIRLINES COMPETING FOR THE ROUTE AWARD MAY HAVE VIOLATED CAB RULES . OF PROCEDURE IN THEIR LOBBYING FOR LOCAL SUPPORT IN MICRONESIA. THE SECOND PHASE WILL BE AN ATTEMPT BY THE CAB TO DETERMINE EXACTLY WHERE THE PEOPLE OF MICRONESIA STAND ON THE AWARD.

THE SAIPAN HEARINGS WERE ORDERED EARLIER THIS YEAR BY THE FIVE-MEMBER BOARD, AFTER IN DETERMINED THAT IT WAS UNABLE TO REACH A DECISION ON THE SERVICE TO SAIPAN CASE ON THE BASIS OF INFORMATION AND TESTIMONY RECEIVED SO FAR. THE BOARD ORDERED THE NEW HEARING CONFINED TO THE TWO TOPICS WHICH

WILL BE TAKEN UP IN PHASES ONE AND TWO.

THE PROCEEDING GOT UNDER WAY IN THE TTRUST TERRITORY HIGH COURT CHAMBERS, WITH AN AUDIENCE COMPOSED LARGELY OF REPRESENTATIVES OF THE AIRLINES, GOVERNMENT OFFICIALS AND NEWSMEN. A LARGER CONTINGENT OF SPECTATORS WAS PRESENT FOR THE AFTERNOON CONTINUATION OF THE HEARINGS, ACCORDING TO OBSERVERS.

ALL THREE AIRLINES COMPETING FOR THE ROUTE WERE REPRESENTED. THEY ARE NORTHWEST ORIENT AIRLINES, PAN AMERICAN WORLD AIRWAYS, AND CONTINENTAL AIRLINES, THE PARENT COMPANY OF THE TRUST TERRITORY'S AIRLINE, AIR MICRONESIA. PAN AM AND CONTINENTAL ARE CONSIDERED TO BE THE MAJOR CONTENDERS FOR THE ROUTE, WHICH WOULD INVOLVE DIRECT FLIGHTS FROM TOKYO AND OSAKA IN JAPAN TO SAIPAN. JAPAN AIR LINES ALREADY HAS AUTHORITY TO FLY THE ROUTE, ALTHOUGH IT HAS NOT YET BEGUN TO DO SO.

OPENING STATEMENTS WERE READ INTO THE RECORD BY MICHAEL WHITE, AN ATTORNEY REPRESENTING THE CONGRESS OF MICRONESIA AND THE SO-CALLED MICROMESIAN PARTIES IN THE CASE, AND BY LEE HYDEMAN, AN ATTORNEY FOR CONTINENTAL. OTHERS DID NOT MAKE FORMAL STATEMENTS ALTHOUGH MOST OFFICIAL REPRESENTATIVES OF THE AIRLINE AND OF THE CAB PARTICIPATED IN THE DISCUSSION, WHICH CENTERED LARGELY AROUND THE ORDER OF PROCEDURE AND THE

SEQUENCE FOR CALLING CERTAIN WITNESSES.

EDWARD THOMAS AND CHRISTOPHER BROWNE, OF THE CAB'S BUREAU OF ENFORCEMENT, HAVE BEEN IN THE TRUST TERRITORY FOR THE PAST TWO WEEKS GATHERING EVIDENCE ON THE QUESTION OF CARRIER CONDUCT. THEY ARE EXPECTED TO CALL A NUMBER OF WITNESSES DURING THAT PORTION OF THE PROCEEDINGS, WHICH WILL TAKE PLACE FIRST, OPPORTUNITY WILL BE GIVEN FOR THE AIRLINE REPRESENTATIVES TO CROSS-EXAMINE THOSE WITNESSES.

THE ENTIRE HEARING IS CONDUCTED MUCH AS A COURTROOM LEGAL TRIAL OR HEARING WOULD BE, AND SIMILAR RULES OF CONDUCT

AND PROCEDURE ARE OBSERVED.

THE FIRST WITNESS, SCHEDULED TO BE HEARD MONDAY AFTERNOON, WAS TO BE TRUST TERRITORY HIGH COMMISSIONER EDWARD E. JOHNSTON. HE HAD BEEN ASKED TO TESTIFY BY ONE OF THE AIRLINES INVOLVED, BUT THE EXACT NATURE OF HIS TESTIMONY WAS NOT KNOWN. THE PARTIES IN THE PROCEEDING AGREED THAT HE COULD BE HEARD FIRST BECAUSE HE WILL BE LEAVING THE TRUST TERRITORY IN A FEW DAYS AND WOULD BE UNAVAILABLE FOR TESTIMONY AT A LATER DATE. ...

THE TRUST TERRITORY GOVERNMENT HAS TAKEN NO OFFICIAL POSITION ON THE SAIPAN/JAPAN ROUTE CASE.

TOYOMI SINGEO, BALANG (CHIEF) OF PELELIU, PALAU:
AND MRS. MARY LANVI, WOMEN'S INTEREST OFFICER OF MARSHALLS.
ALSO CHOSEN WERE SOUKICHI FRITZ, PRESIDING JUDGE OF TRUK;
