(M/V NORMAR DRIFTING)

SAIPAN, MARCH & (MNS) -- RESCUE EFFORTS ARE STILL UNDER WAY TO BRING A SHIP BELONGING TO THE SAIPAN SHIPPING COMPANY (SAISHIP), THE M/V NORHAR, INTO PORT FOLLOWING A BREAKDOWN ON HER ENGINE SUNDAY, MARCH 3. THE SHIP HAS BEEN DRIFTING SINCE THAT TIME.

LATE WEDNESDAY AFTERNOON A SPOKESMAN SAID THE SHIP HAD BEEN LOCATED BY A SEARCH AIRCRAFT AFTER RADIO CONTACT WITH HER WAS LOST, BUT A TUGBOAT SENT TO TOW HER IN HAD RADIO TROUBLE HERSELF AND RETURNED TO GUAM. THE TUG, A DILLINGHAM VESSEL, WAS TO LEAVE GUAM AGAIN WEDNESDAY EVENING TO RETURN TO THE MORMAR'S POSITION, ABOUT 135 MILES NORTH-NORTHWEST OF GUAM, AND HOPEFULLY TAKE THE SHIP IN TOW BY SOMETIME THURSDAY MORNING. THERE ARE REPORTEDLY 27 PEOPLE ON BOARD THE NORMAR, WHICH WAS ON A REGULAR RUN FROM GUAM TO ROTA, TINIAN AND SAIPAN WHEN THE ENGINE TROUBLE DEVELOPED NEAR TINIAN.

THE NORMAR IS ALSO THE SHIP USED BY THE TT GOVERNMENT TO PROVIDE FIELD TRIP SERVICES TO THE NORTHERN MARIANAS. A FIELD TRIP THAT WAS TO HAVE BEGUN MONDAY HAD TO BE POSTPONED BECAUSE OF THE ENGINE TROUBLES ON THE SHIP.

THE U.S. MILITARY'S AIR SEA RESCUE CENTER ON GUAN HAS BEEN COOPERATING IN LOCATING THE SHIP AND GUIDING THE TOW BOAT TO HER.

(CONGRESS SELECTS UN AND SPC DELEGATES)

SAIPAN, MARCH 6 (MNS)---THE CONGRESS OF MICRONESIA HAS SELECTED SENATOR WILFRED KENDALL (MARSHALLS) AND REPRESENTATIVE JOAB SIGRAH (PONAPE) TO ACCOMPANY THE HIGH COMMISSIONER TO THIS YEAR'S MEETING OF THE UNITED NATIONS TRUSTEESHIP COUNCIL IN NEW YORK CITY. THE MEETING BEGINS MAY 28.

THE CONGRESS ALSO VOTED LATE IN ITS RECENTLY-COMPLETED SESSION TO SELECT MARSHALLS SENATOR ANATA KABUA AS ITS REPRESENTATIVE TO THE 14TH SOUTH PACIFIC CONFERENCE THIS YEAR. REPRESENTATIVE SASAUO HARUO (TRUK) WAS SELECTED BY THE HOUSE TO ACCOMPANY SENATOR KABUA.

EACH YEAR THE CONGRESS SENDS TWO OF ITS MEMBERS TO THE U.N., AND ONE OR MORE MEMBERS TO THE SPC. LAST YEAR SENATOR ANDON AMARAICH (TRUK) ATTENDED THE U.N. ALONG WITH CONGRESSMAN SIGRAH. FOLLOWING ITS PRACTICE OF SENDING ONE NEW MEMBER ALONG WITH ONE OF THE TWO WHO ATTENDED AND PREVIOUS YEAR, SIGRAH WAS AGAIN SELECTED, ALONG WITH SENATOR KENDALL.

CONGRESSMAN HARUO WAS THE CONGRESSIONAL DELEGATE TO THE SPC LAST YEAR. HE IS CHAIRMAN OF THE HOUSE COMMITTEE ON RESOURCES AND DEVELOPMENT, WHILE SENATOR KABUA CHAIRS THE SAME COMMITTEE IN THE SENATE.

THE TRUST TERRITORY ADMINISTRATION HAS ALSO ANNOUNCED THAT TRUK DISTRICT ADMINISTRATOR JUAN SABLAN WILL ACCOMPANY THE HIGH COMMISSIONER TO THE U.N. MEETING THIS YEAR AS A SPECIAL ADVISOR. (CARPENTER TO HEAD U.S. DELEGATION TO SPC MEETING)

INTERIOR DEPARTMENT, MARCH 6 (MNS)---DIRECTOR OF TERRITORIAL AFFAIRS, STANLEY S. CARPENTER, HAS BEEN DESIGNATED TO HEAD THE U.S. DELEGATION TO A SPECIAL MEETING OF THE SOUTH PACIFIC COMMISSION SCHEDULED TO BE HELD MARCH 5TH TO 7TH AT WELLINGTON, NEW ZEALAND, ACCORDING TO A PRESS RELEASE RECEIVED FROM WASHINGTON THIS WEEK.

THE U.S. DELEGATION WILL ALSO INCLUDE OFFICIALS FROM THE STATE DEPARTMENT AND FROM THE U.S. EMBASSY IN FIJI.

THIS SPECIAL MEETING IS TO BE HELD IN RESPONSE TO A RESOLUTION PASSED BY THE LAST SPC COMPERENCE HELD ON GUAM IN SEPTEMBER LAST YEAR. AMONG OTHER THIMBS, THE RESOLUTION CALLED FOR A "REVIEW OF PROCEDURES UNDER THE CAMBERRA AGREEMENT, THE BASIC DOCUMENT OF THE SOUTH PACIFIC COMMISSION, WITH A VIEW TOWARD MERGING THE ANNUAL COMMISSION AND CONFERENCE SESSIONS."

"IF MEMBER GOVERNMENTS CAN REACH AGREEMENT IN WELLINGTON, THE MERGER WOULD RESULT IN A YEARLY COMBINED MEETING INVOLVING VIRTUALLY ALL TERRITORIES IN THE PACIFIC AND THE EIGHT MEMBERS OF THE SPC: THE UNITED STATES, FRANCE, UNITED KINGDOM, AUSTRALIA, NEW ZEALAND, WESTERN SAMOA, NAURU AND FIJI. ALSO THE TERRITORIES WOULD THEREBY BECOME MORE FULLY INVOLVED IN THE DECISIONS AFFECTING THE SPC." THE INTERIOR DEPARTMENT RELEASE SAID.

ACCORDING TO SPECIAL CONSULTANT TO THE HICOM DVIGHT HEINE, THE TT IS NOT A MEMBER OF THE SOUTH PACIFIC COMMISSION. SHE IS HOWEVER, A MEMBER OF THE SOUTH PACIFIC CONFERENCE AS ARE THE OTHER TERRÍTORIES AND ISLAND-NATIONS IN THE SOUTH PACIFIC AREA. HEINE NOTED THAT THE TT HAS BEEN CONTRIBUTING HER SHARE TO THE SOUTH PACIFIC CONFERENCE FOR THE PAST SEVERAL YEARS, ADDING THAT THE TT'S CONTRIBUTION MAY BE INCREASED IN THE FUTURE.

(AMB. WHITE FAMILIARIZATION TOUR CONTINUES)

SAIPAN, MARCH 6 (MNS) --- AMBASSADOR BARBARA WHITE, WHO ARRIVED ON SAIPAN LAST WEEK, LEFT WEDNESDAY FOR A DAY-LONG VISIT TO ROTA IN THE MARIANAS DISTRICT. FOLLOWING THE ROTA TRIP, ANB. WHITE WILL VISIT TINIAN THURSDAY FOR ONE DAY BEFORE RETURNING TO SAIPAN. SHE WILL BE ACCOMPANIED BY MISS MARY V. TRENT, STATE DEPARTMENT LIAISON OFFICER, ON HER TRIP TO THE OTHER DISTRICTS.

WILL NOT BE ABLE TO VISIT THE PALAU DISTRICT DURING THIS TRIP, BECAUSE OF HER TIGHT SCHEDULE.

AFTER SPENDING SEVERAL DAYS IN YAP, AMB. WHITE WILL DEPART FOR TRUK DISTRICT MARCH 12 FOR A TWO-DAY VISIT. SHE WILL LEAVE TRUK FOR PONAPE DISTRICT ON THE 14TH AND THEN ON THE 16TH, SHE WILL TRAVEL TO KWAJALEIN FOR THE PURPOSE OF VISITING EBEYE IN THE MARSHALLS.

FROM EBEYE, THE AMBASSADOR WILL VISIT MAJURO AND THEN WILL

CONTINUE WITH HER TRIP BACK TO THE U.S.

(SEMINAR FOR U.S. TAXPAYERS) SAIPAN, MARCH 6 (MNS) --- A SPECIAL SEMINAR FOR U. S. TAXPAYERS, INCLUDING GOVERNMENT EMPLOYEES, BUSINESSMEN, AND PERSONS PRIVATELY EMPLOYED, WILL BE HELD MARCH 21 AT 1:00 O'CLOCK IN THE AFTERNOON, IT WAS ANNOUNCED THIS WEEK BY JESUS P. MAFNAS, CHIEF OF THE TT REVENUE DIVISION. THE SEMINAR WILL BE HELD AT THE TRAINING DIVISION LOCATED AT THE LOWER BASE AREA ON SAIPAN.

ACCORDING TO FALCAM, IRTARTE WILL RECEIVE MEDICAL TREATMENT AT TORANO MON HOSPITAL IN TOKYO AND WILL BE ESCORTED BY SEBIO BERMANIS WITH ATTENDANT ASSISTANCE PROVIDED BY PAULINO IRIARTE.

FALCAM REQUESTED THE U.S. EMBASSY IN TOKYO TO PROVIDE ASSISTANCE, AS WELL AS TO MONITOR THE CONDITION OF THE AILING

CHIEF FROM PONAPE.

(SENATE PRESIDENT'S REMARKS)

SAIPAN, MARCH 4 (CONGRESS RELEASE) --- BEFORE POUNDING THE GAVEL TO ADJOURN THE SECOND REGULAR SESSION OF THE FIFTH CONGRESS OF MICRONESIA, SENATE PRESIDENT TOSIVO NAKAYAMA DELIVERED BRIEF REMARKS EXTENDING APPRECIATION OF THE SENATE TO THOSE WHO HAVE BEEN RESPONSIBLE FOR WHAT ACCOMPLISHMENT HAVE BEEN MADE DURING THE SESSION.

PRESIDENT NAKAYAMA THANKED ALL THE COMMITTEE CHAIRMEN AND NEMBERS FOR THEIR WORK AND EFFORT IN CONSIDERING THE LEGISLATION WHICH CONGRESS HAS HAD TO CONSIDER. HE ALSO GAVE DUE CREDIT TO THE SENATE STAFF, THE ATTORNEYS, AND OTHER STAFF OF THE LEGISLATIVE COUNSEL'S OFFICE WHO HAVE ASSISTED

TO MOVE THINGS ALONG DURING THE SESSION.

THE SENATE PRESIDENT SAID: "AS ALWAYS, WE ARE GRATEFUL TO THE HIGH COMMISSIONER AND HIS STAFF FOR THEIR ASSISTANCE, AND OF COURSE TO THE PEOPLE AND LEADERS OF THE MARIANA ISLANDS

DISTRICT FOR THEIR HOSPITALITY."

NAKAYAMA ALSO EXTENDED A HUMEROUS SPECIAL APPRECIATION TO SENATOR ANDON AMARAICH "FOR HIS ABILITY AS THE UNOFFICIAL SENATE PROOFREADER: TO SENATOR MANGAFEL FOR THE FREQUENCY AND IMPORTANCE OF HIS STATEMENTS -- NOT TO MENTION HIS ABILITY AS A CONSULTANT; TO SENATOR THETUCHL FOR HIS MANY THOUGHTFUL ABSTAINING VOTES; AND TO SENATOR IEHSI FOR HIS FOOTWORK ON THE FLOOR."

ADDING A SERIOUS NOTE TO HIS BRIEF SPEECH, THE SENATE PRESIDENT SAID: "AT THE BEGINNING OF THE SESSION, I SAID THAT OUR ABILITIES AS LAWMAKERS WILL BE PUT TO THE TEST AND THAT I HAD HIGH HOPES THAT WE WOULD SET A GOOD EXAMPLE IN HIS REGARD. WHILE I FEEL WE HAVE DONE IMPORTANT WORK IN PASSING SOME IMPORTANT LEGISLATION, THE FINAL WORD AS TO OUR SUCCESS MAY NOT BE WRITTEN OR SPOKEN WHEN WE ADJOURN, BUT ONLY BETWEEN NOW AND THE BEGINNING OF THE FIRST REGULAR SESSION OF THE SIXTH CONGRESS OF MICRONESIA."

PRESIDENT NAKAYANA THEN WISHED EVERYONE A SAFE RETURN TO

THEIR DISTRICTS UNTIL CONGRESS MEETS AGAIN.

SAIPAN, MARCH 6 (CONGRESS RELEASE) --- IN THE FINAL MINUTES OF THE SECOND REGULAR SESSION OF THE FIFTH CONGRESS OF MICRONESIA, PONAPE REPRESENTATIVE BETHUEL HENRY, SPEAKER OF THE HOUSE OF REPRESENTATIVES, MADE TWO BRIEF STATEMENTS CONCERNING SOME OF

THE SENSITIVE ISSUES AND DEBATES WHICH SURFACED DURING THE 50-DAY SESSION.

"FIRST," HE NOTED, "NO PROGRESS ANYWHERE HAS EVER BEEN MADE WITHOUT SOME CONFLICT OR WITHOUT DISAGREEMENT. - SECOND. WHILE

OUR FEELINGS AND OPINIONS AT THIS PARTICULAR MOMENT MAY SEEM LIKE CONCRETE THINGS WHICH NEVER CHANGE, EXPERIENCE TEACHES US THAT TIME, INDEED, DOES CHANGE EVERYTHING AND THAT WHEN WE REVIEW OUR ACTIONS AND IDEAS AFTER A MONTH OR TWO, WE MAY SEE THINGS WITH A DIFFERENT PERSPECTIVE."

THE HOUSE SPEAKER WAS CBVIOUSLY REFERRING TO THE SOMETIMES HEATED ARGUMENTS DURING THE FINAL DAYS OF BUSINESS IN THE HOUSE, PARTICULARLY CONCERNING THE CONTROVERSIAL REVENUE SHARING, CONSTITUTIONAL CONVENTION, REAPPORTIONMENT, AND PUBLIC LAND TRANSFER BILLS. "IT IS PERHAPS AN UNDERSTATEMENT TO SAY THAT THIS PARTICULAR SESSION HAS BEEN AN EXTREMELY DIFFICULT ONE," HE SAID.

NOTING THAT THESE AND OTHER MATTERS CONSIDERED WERE "EXTREMELY IMPORTANT", HENRY THANKED HIS COLLEAGUES FOR THEIR

FUTURE LEGISLATIVE TASKS.

SPEAKER HENRY ALSO THANKED THE HIGH COMMISSIONER, HIS STAFF, AND THE VARIOUS DEPARTMENTS AND DIVISIONS OF THE TRUST TERRITORY ADMINISTRATION FOR THEIR ASSISTANCE AND SUPPORT, ALONG WITH THE STAFF MEMBERS OF THE COMBRESS ITSELF.

"WE ARE ALSO PARTICULARLY GRATEFUL FOR THE MANY RECEPTIONS AND PARTIES GIVEN ON BEHALF OF THIS CONGRESS, WITH SPECIAL NOTE TO THE MARIANAS DELEGATION AND THE PEOPLE OF THIS DISTRICT FOR THEIR KINDNESS AND SUPPORT," HENRY CONCLUDED. CONTRIBUTIONS AND EFFORTS AND SUGGESTED THE MEMBERSHIP SEEK ADDITIONAL ADVICE FROM THEIR CONSTITUENTS IN THEIR HOME DISTRICTS IN ORDER TO RETURN NEXT SESSION WITH A "RENEWED MANDATE AND THE FRESH ENERGY AND IMAGINATION NEEDED FOR OUR


