CONGRESS UNLESS IT CONTAINS PROVISIONS FOR THE FUTURE FINANCIAL SUPPORT OF MICRONESIA OF AT LEAST DOLLARS 80 MILLION PER YEAR IN GRANTS FOR OPERATIONS AND CAPITAL IMPROVEMENT PROJECTS, OR IN THE ALTERNATIVE, IF THE UNITED STATES IS UNABLE TO PROVIDE FINANCIAL SUPPORT AT THIS LEVEL, UNLESS THE PROPOSED ARRANGEMENT PROVIDES FOR US AUTHORITY IN FOREIGN AFFAIRS AND DEFENSE SIGNIFICANTLY REDUCED FROM THAT WHICH IS PRESENTLY CONTAINED IN THE PROVISIONS OF THE DRAFT COMPACT." SUBSEQUENT PARA DIRECTS STATUS DELEGATION TO CONTINUE NEGOTIATIONS WITH US "ON CONDITION THAT PROGRESS IS MADE TOWARD A SATISFACTORY
