#### A SENATE JOINT RESOLUTION

Requesting the United States to clean the so-called public lands in Micronesia so that they will be in the same condition when returned as they were in when seized from the rightful owners.

- 1 MIEREAS, the United States has belatedly agreed to return to
- 2 the rightful owners the large areas of so-called public lands in
- 3 Micronesia which were seized or purchased through duress by the
- 4 Japanese, German, or Spanish governments and which have been
- 5 retained "in trust" by the United States; and
- 6 MHEREAS, had these so-called public lands been earlier
- 7 returned to the people of Micronesia, they could have, by now,
- 8 been put to some productive use; and
- 9 MHERWAS, substantial areas of these public lands are still
- 10 pockmarked with bomb craters littored with scrap metal, and made
- 11 dangerous by the presence of unexploded ordnance, as a result of
- 12 World War II hostilities between the United States and Japan;
- 13 now, therefore,
- 14 BE IT RESCLVED by the Senate of the Fifth Congress of
- 15 Micronesia, Second Regular Scssion, 1974, the Nouse of Repre-
- 16 sentatives concurring, that the United States Government is
- 17 requested to forthwith commence filling the bomb craters and
- 18 removing the scrap metal and unexploded ordnance from the
- 19 so-called public lands in Micronesia, so that those lands will
- 20 be returned to the rightful owners in the same condition that
- 21 they were in when originally seized; and
- BE IT FURTHER RESOLVED that certified copies of this Senate
