HAYDM WILLIAMS INFO HOWARD WILLENS REFERENCE TO NEXT ROUND MARIANAS STATUS NEGOTIATIONS SCHEDULED FOR DECEMBER 2, 1974 ON SAIPAN. FOLLOWING COMMISSION MEMBERS STRONGLY URGE NEGOTIATIONS TO PROCEED AND COMMENCE AS AGREED BY AMBASSADOR WILLIAMS AND COMMISSION CHAIRMAN PANGELINAN AND VICE CHAIRMAN SANTOS: MITCH PANGELINAN, JOSE CRUZ, OLYMPIO BORJA, BERNARD HOPFSCHNEIDER, BENJAMIN MANGLONA, JOANNES TAIMANAO, DAN MUNA, VICENTE CAMACHO, HERMAN GUERRERO, VICENTE SANTOS AND CHAIRMAN PANGELINAN. 2. SANTOS ALSO STATED HE HAD DRAFT COUNTER OFFER FOR LAND NEGOTIATIONS BUT WAS UNABLE TO ACT DUE TO LACK OF INSTRUCTIONS FROM SEN. PANGELINAN, WHO IS IN MANILA. PANGELINAN EXPECTED BACK LATE NEXT WEEK AND CAN BE REACHED AT MANILA INTERCONTINENTAL HOTEL IN MEATIME. SANTOS STATED, BERGESEN
