SAIPAN, SEPT. 24 (MNS) TRUST TERRITORY DIRECTOR OF EDUCATION DAVID RAMARUI REVEALED THIS WEEK THAT MICRONESIAN STUDENTS ARE ABOUT FOUR TO FIVE YEARS BEHIND THE UNITED STATES EDUCATIONAL STANDARD. BUT, IMPROVEMENTS ARE BEING MADE. HE CITED THE INCREASED ACCEPTANCE OF TT STUDENTS IN US COLLEGES AS AN EXAMPLE OF THESE IMPROVEMENTS.

RAMARUI SPOKE ON THE HEADQUARTERS TASK FORCE ON EDUCATION

FOR SELF-GOVERNMENT PROGRAM "DIALOGUE FOR MICRONESIA."
RAMARUI DESCRIBED THE TT EDUCATIONAL SYSTEM AS A

COMBINATION OF THE U.S. AND JAPANESE SYSTEMS. THE US SYSTEM IS JUST A MODEL, HE SAID, AND THE TT IS NOT "STUCK WITH THIS MODEL. ADAPTATIONS AND MODIFICATIONS ARE CONSTANTLY

BEING STUDIED AND MADE," HE STATED.

CONCERNING VOCATIONAL EDUCATION, THE EDUCATION
DIRECTOR SAID THAT THE TT HAS MADE CONSIDERABLE PROGRESS
IN THIS FIELD. HE GAVE AS EXAMPLES THE MANY ELEMENTARY
SCHOOLS THAT HAVE ARTS AND CRAFTS PROGRAMS LEADING TO
INDUSTRIAL ARTS AND VOCATIONAL PROGRAMS IN SOME HIGH SCHOOLS
IN THE TT. HE HOTED THAT MARSHALLS HIGH SCHOOL STUDENTS
BUILT THEIR OWN GYMNASIUM WITH THE AID OF THE CIVIC ACTION
TEAM AND IN PALAU AN AGRICULTURE BUILDING AND THE LIBRARY
WERE BUILT BY STUDENTS WITH THE HELP OF CIVIC ACTION TEAMS.

"MICRONESIA IS NO DIFFERENT FROM THE REST OF THE WORLD," RAMARUI SAID, REFERRING TO PROBLEMS OF KEEPING UP WITH THE REST OF THE DEVELOPING WORLD. "MICRONESIA HAS A DIFFICULT CHOICE TO MAKE," HE CONTINUED. "EITHER TO SPEED UP DEVELOPMENT, PRESENTLY HELD BACK BY THE TRADITIONAL CULTURE, OR TO MAINTAIN THE PRESENT PACE AND LIVE LIKE WE HAVE BEEN." HE POINTED OUT THAT THERE ARE MANY UNCONTROLLABLE FACTORS IN RESOLVING THE PROBLEM BECAUSE OF POLITICAL DECISIONS AND ECONOMICS.

REGARDING THE POSSIBLE TERMINATION OF GOVERNMENT AID TO NON-PUBLIC SCHOOLS, THE FORMER SENATOR SAID THAT WHILE THERE WERE PROBLEMS WITH THE LEGAL ASPECTS OF THE PRESENT POLICY, THE STANDARD \$212,000 WOULD BE PROVIDED TO NON-PUBLIC SCHOOLS THROUGH FY 76. HE DID SAY THAT IT WAS A DISTRICT RESPONSIBILITY TO PLAN FOR FUTURE AID TO THESE SCHOOLS. THE TT CODE, RAMARUI POINTED OUT, DOES REQUIRE CERTAIN ASSISTANCE TO STUDENTS OF NON-PUBLIC SCHOOLS AND TERMINATION OF THIS AID WOULD BE IN VIOLATION OF THE LAW.

"DIALOGUE FOR MICRONESIA" PROGRAMS ARE DUPLICATED FOR BROADCAST THROUGHOUT MICRONESIA AS PART OF THE EDUCATION FOR SELF-GOVERNMENT PROGRAM.

(TAIWAN FISHERMEN SENTENCED)

SAIPAN, SEPTEMBER 24 (MNS) --- TEN TAIWANESE FISHERMEN CAPTURED WHILE IN THE ACT OF POACHING TURTLES AND SHELLFISH FROM REMOTE HELEN REEF IN PALAU DISTRICT HAVE BEEN FINED \$500 DOLLARS EACH IN TRUST TERRITORY HIGH COURT IN KOROR, AND SENTENCED TO FIVE MONTHS IN JAIL.

TWO OTHER CREWMEN, BOTH JUVENILES, WERE NOT CHARGED. ALL OF THE MEN WERE FROM THE TAIWAN FISHING BOAT TEI-SHENG NUMBER 6, WHICH FLED THE SCENE LEAVING THE MEN STRANDED ON THE REEF WHEN THEY WERE CAPTURED IN EARLY JUNE.

THE FIVE MONTH PRISON SENTENCES INCLUDE CREDIT FOR TIME ALREADY SERVED, MEANING THE MEN WILL BE RELEASED ON NOVEMBER 3 FROM THE KOROR JAIL PROVIDED THE FINES HAVE BEEN PAID. TT AUTHORITIES ARE IN CONTACT WITH THE SHIP'S OWNERS CONCERNING PAYMENT OF THE FINES AND REPATRIATION OF THE CREW.

THE TEI-SHENG WAS TAKEN INTO CUSTODY AT HELEN REEF, AN UNINHABITED ATOLL ABOUT 350 MILES SOUTHWEST OF THE PALAU DISTRICT CENTER, IN APRIL. SHE WAS BROUGHT TO KOROR, WHERE HER CAPTAIN AND CREW WERE FINED A TOTAL OF \$10,000 DOLLARS. THE SHIP WAS RELEASED UPON PAYMENT OF THE FINES, BUT WITHIN JUST A FEW DAYS SHE WAS DISCOVERED BACK AGAIN AT HELEN REEF, WHITH ELEVEN OF HER MEN ASHORE TAKING MARINE RESOURCES WHILE THE SHIP STOOD OFFSHORE WAITING.

THE TRUST TERRITORY FIELD TRIP VESSEL M/V HAFA ADAI MADE THE SECOND DISCOVERY, BUT WAS UNABLE TO APPREHEND THE TEI-SHENG, WHICH LEFT IN A GREAT HURRY WITHOUT MOST OF HER CREW. THE TEI-SHENG LATER TURNED UP BACK IN TAIWAN, WHERE HER CAPTAIN WAS DISCIPLINED BY THE TAIWAN GOVERNMENT AND HER OWNERS WERE FORBIDDEN TO PERMIT THE SHIP TO GO BACK TO SEA FOR A TIME BECAUSE OF THE TWO INCIDENTS OF ILLEGALLY ENTERING THE TERRITORIAL WATERS OF THE TRUST TERRITORY AND TAKING MARINE RESOURCES.

SAIPAN, SEPTEMBER 24 (MNS) --- THE CHAIRMAN OF THE MARIANAS DISTRICT ECONOMIC DEVELOPMENT BOARD HAS BEGUN WARNING FOREIGN CORPORATIONS WHICH HAVE APPLIED FOR BUSINESS PERMITS IN THE MARIANAS THAT UNLESS THEY ACTUALLY GO INTO BUSINESS SOON, THEIR BUSINESS PERMITS WILL BE CANCELLED.

PEDRO DELA CRUZ TOLD KJOR RADIO NEWS THIS WEEK THAT FIFTEEN FOREIGN CORPORATIONS MIGHT BE AFFECTED. HE POINTED OUT THAT FOREIGN INVESTORS ARE REQUIRED TO COMMENCE BUSINESS IN THE TRUST TERRITORY WITHIN A REASONABLE TIME AFTER THEIR APPLICATIONS ARE APPROVED. NONE OF THE FIFTEEN HAS YET BEGUN ITS BUSINESS A REQUIRED BY LAW.
