

(COSTIGAN MEETS HUD OFFICIALS) 1975 SAIPAN, JANUARY 3 (MIS) --- FATHER HUGH F. COSTIGAN OF PONAPE RETURNED RECENTLY FROM AN OFFICIAL VISIT WITH THE HIGHEST LEVEL OFFICIALS OF THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) IN WASHINGTON, D.C.

SPEAKING AS AN EMISSARY OF THE TRUST TERRITORY HOUSING COMMISSION, COSTIGAN REVIEWED THE CURRENT EFFORTS OF THE NEW HOUSING COMMISSION AND THE DISTRICT HOUSING AUTHORITIES TO PARTICIPATE UNDER THE U.S. HOUSING AND COMMUNITY DEVELOPMENT ACT

CF 1974.

HUD SECRETARY JAMES T. LYNN (RECENTLY NAMED BUDGET DIRECTOR BY PRESIDENT FORD) AND ASSISTANT SECRETARY SHELDON B. LUBAR TALKED FOR OVER AN HOUR ABOUT HOW BOTH RURAL AND DISTRICT CENTER LOW-COST HOUSING PROGRAMS COULD BE EXPANDED WITH FEDERAL HOUSING ASSISTANCE. LONGER MEETINGS WITH ASSISTANT SECRETARY LUBAR FOLLOWED REGARDING PRODUCTION STRATETIES AND PROBLEMS.

ACCORDING TO HOUSING COMMISSION CHAIRMAN WILLIAM ALLEN, BOTH HUD OFFICIALS MERE REMARKABLY KNOWLEDGEABLE ABOUT THE CONDITIONS IN MICRONESIA. HE SAID FATHER COSTIGAN ALSO MET WITH ANOTHER WASHINGTON HUD OFFICIAL, MORRIS SHRODER, WHO TOGETHER WITH GARY KAHN OF THE SAN FRANCISCO HUD REGIONAL OFFICE ATTENDED THE TRUST TERRITORY HOUSING AUTHORITY WORKSHOP AT PONAPE AGRICULTURE AND TRADE SCHOOL LAST JULY.

"COSTIGAN ASSURED ME THAT HUD IS DEFINITELY READY TO HELP THE TRUST TERRITORY. THE RESPONSIBILITY IS NOW OURS TO PUT TOGETHER A WELL THOUGHT OUT APPLICATION FOR ASSISTANCE THAT MEETS GUR

PRESENT MANAGEMENT CAPABILITY," ALLEN SAID.

WHILE HOLDING THESE MEETINGS, THE PONAPE DELEGATION WILL ASSESS PEOPLES NEEDS AND OPINIONS REGARDING A GUTURE CONSTITUTION OF MICRONESIA, JOHNNY REPORTS.
