Dear Ed:

Enclosed is our statement for legal services rendered during the period September 1 through December 31, 1974. suant to our previous understanding, the statement is based upon a standard fee of \$5,000 per month and an additional \$5,000 for those months in which a substantial amount of time was spent by one or more lawyers from the firm in Saipan. In view of our participation in the Fifth Round of negotiations during late November and December, the enclosed statement for the months involved is accordingly in the amount of \$25,000. I have included in the statement a list of the lawyers who have worked on Commission matters during the months covered by the statement.

I have also included in the statement the unpaid balance remaining from our statement to the Commission dated September 30, This earlier statement was in the amount of \$30,000 and I have subtracted the \$15,000 which the Commission paid my firm in December.

We understand the difficulties which the Commission has encountered during the past several months in obtaining funds to support its activities. I hope that it will be possible for the Commission to satisfy some portion of the enclosed statement out of money currently available and that the District Legislature will enable the Commission to meet its obligations by appropriate action during the next legislative session.
