(CONGRESS 24TH DAY) 1975 SAIPAN, FEB. 5 (MNS) --- TWO BILL PASSED FINAL READING IN THE HOUSE WEDNESDAY (FEB. 5) AND WERE SENT TO THE SENATE. FOR CONSIDERATION DURING THE TWENTY-FOURTH DAY OF THE CURRENT 50-DAY REGULAR SESSION. THE HOUSE MEMBERS ALSO DEFERRED ACTION ON ANOTHER BILL TO GIVE THE MEMBERS TIME TO READ THE COMMITTEE REPORT ON THE BILL.

PASSED ON SECOND AND FINAL READING WAS A MEASURE TO APPROPRIATE \$176,828 FOR THE OPERATING EXPENSES OF THE SOCIAL SECURITY OFFICE FOR FISCAL YEAR 1976, (HB 6-4); AND A BILL APPROPRIATING \$30,000 FOR CONTINUING AND EXPANDING ONGOING VOCATIONAL AGRICULTURE PROGRAMS IN PONAPE AGRICULTURE AND TRADE SCHOOL (PATS), (HB 6-6).

IN A DEBATE CONCERNING PATS, SEVERAL MEMBERS QUESTIONED WHY NO MONEY HAS BEEN MADE AVAILABLE TO OTHER NON-PUBLIC SCHOOLS IN THE TRUST TERRITORY. REPRESNETATIVE SIGRAH FROM PONAPE SUGGESTED THAT THE CONGRESS AMEND THE LAW TO MAKE IT APPLICALBE TO OTHER NON-PUBLIC SCHOOLS. MARIANAS CONGRESSMAN HERMAN R. GUERRERO POINTED OUT THAT THE SAIPAN FARMERS MARKET WAS DEVELOPED AS A RESULT OF TWO SAIPAN RESIDENTS COMPLETING COURSES AT THAT INSTITUTION.

THE BILL PASSED WITH CONGRESSMEN SASAUO HARUO, ISIDORO RUDIMCH, RESIO MOSES AND JOHN HAGLELGAM VOTING AGAINST. FLOOR LEADER LUKE M. TNAN VOTED "CONFLICT OF INTEREST" EXPLAING THAT, SINCE HE IS A MEMBER OF TE BOARD OF TRUSTEES OF THE PONAPE AGRICULTURE AND TRADE SCHOOL, HE IS NOT QUALIFIED TO VOTE.

A TOTAL OF SEVENTEEN BILLS, NINE OF THEM APPROPRIATION MEASURES, WERE INTRODUCED. THE APPROPRIATIONS BILL INCLUDE: \$760,905.80 FOR CERTAIN PUBLIC PURCHASES AND PROJECTS FOR YAP DISTRICT, (HB 6-156); \$120,020 TO PURCHASE TWO FERROCONCRETE VESSELS FOR TRUK DISTRICT, (HB 6-158); \$232,572 TO DEFRAY THE ADMINISTRATIVE COST AND CONTINGENT EXPENSES OF THE DISTRICT HOUSING AUTHORITIES, (HB 6-159); \$470,000 TO DEFRAY THE COST AND CONTINGENT EXPENSES OF CERTAIN PUBLIC WORKS PROJECTS, PROGRA'S AND SERVICES IN PALAU DISTRICT, (HB 6-160); \$50,000 TO CLEAR AND REHABILITATE PUBLIC LANDS ON WOTJE, MILI, JALUIT AND MALOELAP ATOLLS, IN THE MARSHALLS DISTRICT, (HB 6-50); \$10,000 TO PROVIDE FOR THE TRAINING OF MUNICIPAL POLICE IN TRUK DISTRICT, (HB 6-164); \$75,000 TO PURCHASE AN ICE-MAKING MACHINE FOR PUBLIC USE IN TRUK DISTRICT, (HB 6-165); \$5,000 TO PURCHASE A FREEZER FOR A FISHING VESSEL CONSTRUCTED UNDER PUBLIC LAW 4C-71, (HB 6-167); AND \$10,800 TO FUND THE SALARIES OF EIGHT HEALTH ASSISTANT MIDWIVES IN THE DEPARTMENT OF HEALTH SERVICES IN TRUK DISTRICT, (HB 6-163).

THE OTHER BILLS WOULD: AMEND CERTAIN SECTIONS OF PUBLIC LAW 5-21 AND ADD A SUBSECTION TO PROVIDE THAT THE MANAGERS OF THE FISHING AUTHORITY IN EACH DISTRICT MEET ONCE A YEAR AND APPROPRIATE \$30,000 FOR ITS PURPOSE, (HB 6-172); AMEND CERTAIN SECTIONS OF THE TT CODE TO IMPOSE A SI50 ENTRY FEE ON ALL FOREIGN FISHING VESSELS ENTERING A PORT OF ENTRY, (HB 6-174); AMEND CERTAIN SECTIONS OF THE TT CODE TO ALLOW THE DISTRICT FISHING AUTHORITIES TO COLLECT THE TAXES PAID FOR FUEL BY FOREIGN FISHING VESSELS, (HB 6-170); REMIT TO THE DISTRICT LEGISLATURES ALL DOCKING FÉES AND WHARFAGE FEES ASSESSED ON INBOUND AND OUTBOUND CARGO PASSING OVER GOVERNMENT OWNED DOCKS, (HB 6-159); AMEND CERTAIN SECTIONS 13533 OF THE TT CODE RELATIVE TO NATURALIZATION REQUIREMENTS, (HB 6-166); CREATE AN OUTER ISLAND DEVELOPMENT AGENCY IN EACH OF THE DISTRICTS IN THE TT, TO ESTABLISH A SINKING FUND AND APPROPRIATE \$600,000 FOR ITS PURPOSE, (HB 6-162); AMEND CERTAIN SECTIONS OF PUBLIC LAW 5-21 AND ADD A NEW SECTION RELATIVE TO THE RELATIONSHIP BETWEEN THE MARINE RESOURCES

DIVISION AND THE DISTRICT FISHING AUTHORITIES, (HB 6-161); AMEND CERTAIN SECTIONS OF THE TT CODE TO ALLOW A TAX DEDUCTION ON SCHOLARSHIP AND FELLOWSHIP GRANTS, (HB 6-155); AND A MEASURE TO AMEND A SECTION IN THE TT CODE TO INCLUDE TT GOVERNMENT SEAMEN TO THE MERIT SYSTENM, (HB 6-157).

THE FOUR HOUSE JOINT RESOLUTIONS ARE: INVITING THE UNITED NATIONS ASIAN INSTITUE FOR ECONOMIC DEVELOPMENT AND PLANNING TO LOCATE A REGIONAL OFFICE IN THE TT AND ALSO INVITE ITS DIRECTOR TO VISIT MICRONESIA IN THE NEAR FUTURE, (HJR 6-36); REQUESTING THE COPRA STABILIZATION BOARD TO SUBSIDIZE THE PRICE OF COPRA FROM THE OUTER ISLANDS BY 50 CENTS PER BAG TO EQUALIZE PRICES BETWEEN THE DISTRICT CENTERS AND OUTLYING ISLANDS, (HJR 6-37); REQUESTING THE HICOM AND THE PROGRAM AND BUDGET OFFICER TO INCREASE THE OPERATIONS BUDGET OF THE MARINE RESOURCES DIVISION FROM \$600,000 TO \$1,000,000, (HJR 6-38); AND REQUESTING THE HICOM TO SEEK U.S. FEDERAL AIRPORT MONEY UNDER THE FEDERAL AVIATION ACT OF 1958 TO UPGRADE AND INPROVE GODING FIELD IN PALAU DISTRICT. (HJR 6-39).

THE ONLY HOUSE RESOLUTION OFFERED WEDNESDAY IS TO DIRECT THE HOUSE COMMITTEE ON HEALTH MATTERS TO INVESTIGATE THE LIVING CONDITIONS AND OTHER PROBLEMS OF REFERRAL PATIENTS OF THE MEDICAL REFERRAL PROGRAM IN GUAM, (HJR 6-12).

ACTIVITY WAS BRIEF IN THE SENATE ON WEDNESDAY (FEB. 5) WITH ONE SENATE BILL PASSING SECOND READING TO BE SENT TO THE HOUSE FOR FURTHER ACTION. THE PURPOSE OF THE BILL IS TO CREATE A MICRONESIAN DELEGATION TO THE UN LAW OF THE SEA CONFERENCE, SINCE IT IS EXPECTED THAT MICRONESIA WILL BE GRANTED FORMAL OBSERVER STATUS BY THE CONFERENCE, (SB 6-76). MARSHALLS SENATOR WILFRED KENDALL WAS THE SOLE 'NO' VOTER ON THE MEASURE.

SEVEN BILL AND ONE SENATE JOINT RESOLUTION WERE INTRODUCED IN THE SENATE SESSION. THE BILLS ARE: TO APPROPRIATE \$50,000 FOR THE COST OF MATERIALS TO BUILD AN ICE-MAKING PLANT AND STORAGE FACILITY IN OLLEI VILLAGE IN PALAU, TO BE USED BY THE OLLEI-NGERCHELONG FISHERMEN'S COOPERATIVE ASSOCIATION IN STORING AND PRESERVING THE FISH CAUGHT PRIOR TO RESALE, (SB 6-95); APPROPRIATING \$50,000 FOR THE PURCHASE AND CONSTRUCTION OF AN ICE-MAKING PLANT AND STORAGE FACILITY IN ANGAUR MUNICIPALITY FOR USE BY THE PELELIU-ANGAUR FISHERMEN'S COOPERATIVE ASSOCIATION, (SB 6-96); A MEASURE AMENDING CERTAIN SECTIONS OF THE TT CODE RELATING TO THE HICOM'S SPECIAL ORDER NO. 9 ESTABLISHING THE ANGAUR HOUSING AUTHORITY (SB 6-97); APPROPRIATING \$760,905.80 FOR CERTAIN PUBLIC PURCHASES AND PROJECTS FOR YAP DISTRICT, (SB 6-98); A MEASURE AMENDING SECTIONS OF THE TT CODE AUTHORIZING THE CHARTERED DISTRICT LEGISLATURES AND THE CHARTERED MUNICIPAL GOVERNMENTS TO ESTABLISH SURTAXES ON WAGES. SALARIES AND GROSS REVENUES. (SB 6-99): A BILL TO بالمحوجة تشبوكم "AMEND CERTAIN SECTIONS OF THE TT CODE TO INCREASE THE PENALTIES OF FOREIGN VESSELS VIOLATION TERRITORIAL WATERS, (SB 6-107); AND A MEASURE TO APPROPRIATE \$817,266 FOR THE OPERATING AND CONTINGENT EXPENSES OF THE OFFICE OF THE LEGISLATIVE COUNSEL, (SB 6-101).

THE SENATE JOINT RESOLUTION INTRODUCED WOULD REQUEST THE SECRETARY OF THE INTERIOR TO AMEND DEPARTMENTAL ORDER NO. 2918 REGARDING THE REGULAR SESSIONS OF THE CONGRESS OF MICRONESIA SO THERE WOULD BE TWO 30-DAY REGULAR SESSIONS EACH YEAR IN JANUARY AND JULY, (SJR 6-17).

THE SENATE RECESSED UNTIL 4:00 P.M. THURSDAY (FEB. 6), AND THE HOUSE UNTIL 3:00 P.M.
