SAIPAN, FEB. 24 (MNS) ===WITH SEVEN MORE DAYS REMAINING IN THE SESSION, THE HOUSE OF REPRESENTATIVES PASSED MONDAY (FEB. 24) AND SENT TO THE SENATE TWO MEASURES, ONE OF THEM. WITH SEVEN MEMBERS VOTING AGAINST.

PASSED AND SENT TO THE SENATE ARE: A BILL TO RAISE THE MEMBERS! OFFICIAL EXPENSE ALLOWANCE FROM \$2,500 TO \$3,500. PRIOR TO THE PASSAGE OF THE BILL, YAP FRESHMAN CONGRESSMAN JOHN HAGLELGAM TOOK THE FLOOR AND SPOKE AGAINST THE BILL

PAGE 03 RUHGSAA6437 UNCLAS SAYING THAT PASSAGE OF THE BILL WILL NOT BENEFIT THE PEOPLE OF MICRONESIA BUT ONLY THE MEMBERS OF CONGRESS AND CALLED FOR THE DEFEAT OF THE BILL (SEE FOLLOWING STORY FOR FURTHER COVERAGE OF HIS SPEECH).

PONAPE CONGRESSMAN RESID MOSES ALSO SPOKE AGAINST THE BILL SAYING THAT THE PASSAGE OF THE BILL IS AN "IRRESPONSIBLE ACT" OF THE CONGRESS AND SUGGESTED THAT THE BILL BE DELAYED. ANOTHER FRESHMAN CONGRESS FROM TRUK, REP. LAMBERT AAFIN PLEDGED TO SUPPORT THE INTENT OF THE BILL PROVIDED THAT THE CONGRESS AGREED TO REDUCE THEIR SALARIES BY \$1,000.

REP. POLYCARP BASILIUS WANTED TO INCREASE IT TO \$5,000 AND AT THE SAME TIME INCREASE THE SALARY. COMMENTS WERE SUPPORTED BY MARSHALLS CONGRESSMAN CHARLES DOMNICK WHO STATED THAT THE INCREASE IS NOT ENOUGH AND CALLED THE CONGRESS MEMBERS! SALARY "UNFAIR."

IN A ROLL CALL VOTE, CONGRESSMEN LAMBERT AAFIN, HERMAN GUERRERO, JOHN HAGLELGAM, RESIÓ MOSES, OSCAR RASA, ATAJI BALOS AND CONGRESSWOMAN CARMEN BIGLER VOTED AGAINST. THE MEASURE WILL NOW GO TO THE SENATE FOR FURTHER ACTIONS.

THE OTHER BILL THAT PROLONGED THE HOUSE SESSION WAS A BILL

TO ATTEND SCHOOL THAN TO DEDUCT SOME MONEY FROM SCHOLARSHIP FUNDS WHICH WOULD DEPRIVED OTHER DESERVING STUDENTS FROM RECEIVING SCHOLARSHIPS.

RASA STATED THAT THE INTENT OF THE MEASURE IS TO HELP THE OUTER ISLANDERS WHO ARE IN TRANSIT AT THE DISTRICT CENTERS

ON THEIR WAY TO COLLEGES.

OTHER MEMBERS WANTED TO KNOW WHERE THE MONEY TO HELP DEFRAY THE EXPENSES OF THE STUDENTS! ROOM AND BOARD WOULD COME FROM. IN A ROLL CALL VOTE ON THE BILL, REPRESENTATIVE RESID MOSES CAST THE LONE DISSENTING VOTE.

THE HOUSE ALSO DEFERRED ACTION ON A MEASURE APPROPRIATING \$60,000 FOR PROGRAMS RELATING TO UNITY IN MICRONESIA, (HB 6=133) AFTER A LENGTHY DISCUSSION. REP. POLYCARP BASILIUS SUGGESTED THAT THE CONGRESS SHOULD ESTABLISH GOALS, GUIDELINES AND PROCEDURES AS TO HOW THE MONEY SHOULD BE USED BY THE DISTRICTS.

SAYING THAT EACH DISTRICT GETS SHARES OF \$10,000 EACH,
BASILIUS SUGGESTED THAT THE MONEY SHOULD BE USED AS THE
DISTRICTS SEES IT FIT AND NOT TO RESTRICT IT ONLY TO UNITY
RELATED ACTIVITIES.

REP. RASA POINTED OUT THAT THE MEASURE LACKS GUIDELINES.
PROGRAMS CONCERNING UNITY ARE NOW BEGINNING TO EMERGE, HE ADDED.
THE MARIANAS CONGRESSMAN WENT ON TO SAY THAT MOST OF THE PEOPLE
CONCERN WITH MICRONESIAN UNITY DOES NOT KNOW THE CHANNEL TO
GET THE MONEY APPROPRIATED UNDER THE ACT. IN THE CASE OF THE
MARIANAS, THE ISSUE IS CONSIDERED A "CONTROVERSIAL" ONE, RASA
ASSERTED. HE SUGGESTED THAT THE CONGRESS SHOULD DEFINE THE
REQUIREMENTS FOR ACQUISITION OF THE MONEY.

REP. RAYMOND SETIK REMINDED THE MEMBERS THAT THERE ARE ALREADY GUIDELINES SET UNDER THE EXISTING PUBLIC LAW
