MOL HAS 16 MEMBERS, 3 FROM ROTA, 1 FROM TINI N, 1 FROM THE NORTHERN ISLANDS AND 11 FROM SAIPAN. TEN OF SAIPAN MEMBERS ARE POPULAR PARTY, REMAINING SIX TERRITORIAL PARTY.

3. FULL TEXT RESOLUTION FOLLOWS:

BEGIN FXT.

A RESOLUTION TO APPROVE THE COVENANT TO ESTABLISH A COMMONWEALTH OF THE NORTHERN MARIANA ISLANDS IN POLITICAL UNION WITH THE UNITED STATES OF AMERICA SO THAT THE PEOPLE OF THE NORTHERN MARIANA ISLANDS CAN EXERCISE THEIR SOVEREIGN AND INALIENABLE RIGHT OF SELF-DFERMINATION IN A PLEBISCITE.

WHEREAS, IN MAY 1972 THE MARIANA ISLANDS DIS RICT LEGIS-LATURE CREATED THE MARIANAS POLITICAL STATUS COMMISSION, WHICH CONSISTS OF REPRESENTATIVES OF ALL OF THE PECPL OF THE NORTHERN MARIANA ISLANDS; AND

WHEREAS, IN ACCORDANCE WITH THE DESIRES OF TE PEOPLE, THE MARIANA ISLANDS DISTRICT LEGISLATURE INSTRUCTED THE MARIANAS POLITICAL STATUS COMMISSION TO NEGOTIATE WITH THE UNITED STATES CONCERNING THE TERMS OF A CLOSE AND ENDURING POLITICAL RELATIONSHIP PETWEEN THE UNITED STATES AND THE NORTHERN ARIANA ISLANDSWY AND

WHEREAS. THE MARIANAS POLITICAL STATUS COMMISSION HAS CONDUCTED STUDIES, HAS CONSULTED WITH AND MACE REPORTS TO THE MARIANA ISLANDS DISTRICT LEGISLATURE. AND HAS NEGOTIATED FOR MORE THAN TWO YEARS WITH THE UNITED STATES; AND

WHEREAS. THE MARIANAS POLITICAL STATUS COMMISSION HAS APPROVED AND HAS PRESENTED TO THE MARIANA ISLANDS DISTRICT LEGISLATURE THE COVENANT TO ESTABLISH A COMMONW ALTH OF THE NORTHERN MARIANA ISLANDS IN POLITICAL UNION WITH THE UNITED STATES OF AMERICAN AND RELATED DOCUMENTS! AND

WHEREAS THE DISTRICT LEGISLATURE HAS CAREFULLY REVIEWED THE COVENANT AND THE TECHNICAL AGREEMENT REGARDING THE USE OF AND TO BE LEASED TO THE UNITED STATES IN THE NORTHERN MARIANA ISLANDS, AND THE CTHER MATERIALS SUBMIT ED IN THE FEBRUARY 1975 REPORT OF THE MARIANAS POLITICAL STATUS COMMISSIONS AND

WHEREAS, THE PEOPLE OF THE MARIANA ISLANDS H VE AND MUST BE GIVEN THE OPPORTUNITY TO EXERCISE THEIR SOVEREIGN AND INALIENABLE RIGHT OF SELF-DETERMINATION;

NOW. THEREFORE, BE IT RESOLVED BY THE FOURTH MARIANA ISLANDS DISTRICT LEGISLATURE, THAT THE MARIANAS POLITICAL STATUS COMMISSION HAS PROPERLY PERFORMED ITS FUNCTION HE NEGOTIATING A CLOSE AND ENDURING POLITICAL RELATIONSHIP WITH THE UNITED

BE IT FURTHER RESOLVED, THE PRESIDENT SHOULD CERTIFY TO AND THE LEGISLATIVE SECRETARY ATTEST TO THE ADOPTION HEREOF A DITHEREAFTER TRANSMIT COPIES OF THE SAME TO THE GENERAL ASSEMBLY OF THE UNITED NATIONS, THE TRUSTEESHIP COUNCIL OF THE UNITED NATIONS, THE PRESIDENT OF THE UNITED STATES, THE SECRETARY OF STATE, THE SECRETARY OF THE INTERIOR, MEMBERS OF THE SENATE COMMITTEE ON INTERIOR AND INSULAR AFFAIRS AND OF THE HOUSE COMMITTEE ON INTERIOR AND INSULAR AFFAIRS OF THE UNITED STATES CONGRESS, THE HIGH COMMISSION, PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE OF THE CONGRESS OF MICRONESIA, AND THE DISTRICT ADMINISTRATOR FOR THE MARIANA ISLA DS DISTRICT.
