I WOULD LIKE TO SUGGEST THAT WE PLAN

TO HOLD THIS MEETING IN MICRONESIA DURING THE FIRST PART OF APRIL. AS YOU KNOW CONGRESSMAN SETIK AND SENATOR OLTER ARE IN WASHINGTON AT THE MOMENT ALONG WITH MANY OFFICIALS OF THE TRUST TERRITORY IN CONJUNCTION WITH THE HEARINGS BEING HELD BY SENATOR JACKSON. I WILL BE IN TOUCH WITH THE PRESIDENT AND SPEAKER AS TO THE EXACT PLACE TO HOLD THE MEETING AND THE DATE. WHEN A FIRM DECISION IS REACHED, I SHALL BE IN TOUCH WITH YOU IMMEDIATELY.
