KOROR, MAR. 26 (MNS)---A FIRE RESULTING FROM FAULTY ELECTRICAL WIRING DEMOLISHED A MOTEL, AN ABAI, AND THREE PRIVATE HOMES IN KOROR WEDNESDAY, (MAR. 26) ACCORDING TO DISTRICT PUBLIC INFORMATION OFFICER FAVIO NGIRMIDOL.

"FIRE OFFICIALS SAID THEY WERE UNABLE TO CONTROL THE FLAMES BECAUSE ALL THE BUILDINGS WERE MADE OF WOOD WHICH BURNED SO FAST THAT THEIR EQUIPMENT WERE USELESS," NGIRMIDOL REPORTED.

IN THE PAST, PATA DIRECTED MOST OF ITS ENERGY TOWARDS INCREASING THE NUMBER OF VISITORS TO THE PACIFIC. ACCORDING TO ASHMAN, MORE EFFORT NOW WILL BE EXPENDED TOWARDS IN-COUNTRY DEVELOPMENT PROJECTS SUCH AS PRESERVING TOURIST DESTINATION AREAS AND THEIR CULTURAL ASSETS, AS WELL AS PROTECTION OF THE ENVIRONMENT.

ONE SUCH RESOLUTION ADOPTED AT THE AUSTRALIA CONFERENCE DIRECTS PATA TO USE "EVERY REASONABLE MEANS TO INFLUENCE GOVERNMENTS AND ALL ORGANIZATIONS... ANOTHER PROJECT, WHICH MICRONESIA HAS PROPOSED, CALLS FOR PATA TO CONDUCT A THOROUGH EXAMINATION INTO THE ECONOMICS OF TOURISM. "WE WANT TO KNOW EXACTLY WHAT ECONOMIC BENEFITS TOURISM BRINGS TO AN ISLAND AREA SUCH AS OURS," SAID ASHMAN, ADDING, "WITH THE GREAT AMOUNT OF IMPORTS REQUIRED TO CREATE AND CARRY ON THE BUSINESS OF TOURISM, WE HAVE TO GET THE ANSWER TO HOW MUCH DOES TOURISM BENEFIT THE ECONOMY, SO THAT WE CAN PLAN THE WISE USE OF OUR HUMAN AND LAND RESOURCES." "THIS PROJECT WILL BE CONSIDERED BY PATA THIS YEAR AND OUR MEMBERSHIP ON THE BOARD," ASHMAN SAID, "WILL GIVE US A GOOD CHANCE OF SEEING THAT THIS PROJECT IS UNDERTAKEN."

WASHINGTON, MARCH 26 (MNS)--THE HOUSE INTERIOR SUBCOMMITTEE ON TERRITORIAL AFFAIRS APPROVED A PACKAGE OF BILLS RECENTLY TO AUTHORIZE MORE MONEY FOR THE TRUST TERRITORY AND PROVIDE SPECIAL HELP FOR BIKINI AND THE NORTHERN MARIANAS, ACCORDING TO WEDNESDAY'S (MAR. 26) EDITION OF THE PACIFIC DAILY NEWS.

THE SUBCOMMITTEE, CHAIRED BY REP. PHILIP BURTON, (D-CALIF), WHICH GENERALLY PREVAILS IN THE FULL INTERIOR COMMITTEE, APPROVED ANOTHER \$15 MILLION FOR MICRONESIA FOR THE CURRENT FISCAL YEAR--RAISING THE AUTHORIZATION CEILING FROM \$60 MILLION TO \$75 MILLION.

IT ALSO APPROVED BURTON'S BILL TO PROVIDE \$3 MILLION TO THE PEOPLE DISPALCED FROM BIKINI DURING THE NUCLEAR TESTING AFTER WORLD WAR II AND ACCEPTED AND BILL THE SENATE PASSED LAST WEEK TO GIVE \$1.5 MILLION TO THE NORTHERN MARIANAS FOR COSTS FO TRANSITION TO THE PROPOSED COMMONWEALTH STATUS.

THE SENATE BILL HOLD THE TRANSITION MONEY FOR RELEASE AFTER CONGRESS APPROVES THE COMMONWEALTH COVENANT. BURTON SAID HE DIDN'T LIKE THIS DELAY, BUT DISLIKE IT LESS THAN

IMPORTANT SEMINAR LIKE THIS," PALAU DISTRICT ADMINISTRATOR THOMAS REMENGASAU SAID. "WE HAVE SEEN ACHIEVEMENT AND GREAT PROGRESS OF HEALTH SERVICES PROGRAMS IN OUR DISTRICT AS WELL AS IN THE ENTIRE MICRONESIA," HE EMPHASIZED.

TT DIRECTOR OF HEALTH SERVICES DR. MASAN KUMANGAI ALSO SPOKE. HE REVEALED THE PAST ACCOMPLISHMENTS OF THE OVERALL TT HEALTH SERVICES PROGRAMS AND SOME OF THE PROBLEMS THAT WILL AFFECT FUTURE HEALTH SERVICES PROGRAMS IN MICRONESIA.

"THERE ARE NOW 44 MEDEX GRADUATES, AND WE EXPECT 18 MORE GRADUATES BY OCTOBER OF THIS YEAR. THIS WILL GIVE US, FOR THE FIRST TIME, THE MEANS TO UPGRADE THE QUALITY OF PRIMARY HEALTH CARE SERVICES TO SOME 50,000 MICRONESIAN PEOPLE IN THE OUTER ISLANDS," DR. KUMANGAI SAID.

CITING SOME EXAMPLES OF IMPROVED HEALTH CARE IN THE DISTRICT CENTERS DR. KUMANGAI POINTED OUT THE FOLLOWING: THE ORTHOPEDIC

HAND OTOLARYNGOLOGY SERVICES WHICH ARE MADE POSSIBLE BY STAFF SURGEONS AND VISITING CONSULTANTS FROM GUAM AND HONOLULU, THE FULLY OPERATIONAL LIMITED HEMODIALYSIS CARE FACILITY IN THE MARSHALLS DISTRICT, IMMUNIZATION PROGRAM, VENEREAL DISEASES SURVEILLANCE AND CONTROL EFFORTS, AND THE TUBERCULOSIS CONTROL PROGRAM.

SOME OF THE PROBLEMS CONFRONTING THE TT, ACCORDING TO DR. KUMANGAI IS THE HEALTH CARE COST WHICH HAS GONE UP IN A MAGNITUDE THAT THIS FISCAL YEAR BUDGET COULD NOT SUPPORT EXPENDITURE FOR MEDICAL SUPPLIES AND MEDICAL REFERRAL. HE INDICATED THAT THE TRUST TERRITORY WILL DEFINITELY RUN INTO THE LARGEST ANNUAL DEFICIT EVER COMPILED.

"HIGH COST OF PERSONNEL COMPENSATION, WHICH HAVE RESULTED FROM UPWARD ADJUSTMENT OF SALARIES FOR SEVERAL HEALTH PERSONNEL CATEGORY, AND THE USUAL ANNUAL SALARY INCREMENTS HAVE PUT A LOT OF STRAIN AND EVEN HAVE REDUCED THE AMOUNT OF FUNDS NEEDED TO PAY FOR SUPPLIES LOCALLY, AND ALSO FUNDS NEEDED FOR INTRA-DISTRICT TRAVEL," HE ADDED.

FINALLY, HE SAID THAT THE EMERGENCY AIR MEDICAL EVACUATION IS NO LONGER AVAILABLE TO THE PEOPLE OF MICRONESIA. HE INDICATED

IN A LETTER TO BURTON DATED MARCH 26, 1975, RASA AND MAFNAS CHARGED THAT THE HICOM HAS DETAILED A U.S. CITIZEN WHO IS AN EMPLOYEE OF THE TT GOVERNMENT AS SPECIAL ADVISOR TO THE DIRECTOR OF PUBLIC AFFAIRS AND A MEMBER OF THE TASK FORCE ON EDUCATION FOR SELF-GOVERNMENT TO PRODUCE RADIO

PROGRAMS CALLED "UNDERSTANDING THE COVENANT."

THE CONGRESSMEN ALSO CHARGED THAT THE HICOM'S SUBORDINATE WHO IS ASSIGNED THE TASK OF PRODUCING RADIO PROGRAMS ARRANGED FOR EMPLOYEES OF THE TT GOVERNMENT'S PUBLICATION DIVISION TO "EXPEDITE THE PRINTING OF THE SECOND ISSUE OF THE COVENANT NEWSLETTER, WORK FOR WHICH THEY WERE PAID BY THE TT GOVERNMENT INCLUDING OVERTIME."

THEY ALSO CITED THAT CERTAIN UNNAMED EMPLOYEES OF THE TT GOVERNMENT IN THE MARIANAS HAVE BEEN ASSIGNED THE TASK OF TRANSLATING THE COVENANT AND RELATED INFORMATIONAL MATERIALS INTO THE LOCAL LANGUAGE FOR RADIO PROGRAMS. THE PROGRAM "OUR MICRONESIA" PRODUCED BY THE ESG TASK FORCE FOR BROADCAST IN THE TT "HAS BEEN DROPPED WITHOUT EXPLANATION IN THE MARIANAS AND REPLACED BY "UNDERSTANDING THE COVENANT," RASA AND MAFNAS POINTED OUT.

THEY ALSO NOTED THAT THEIR "CONCERN IS NOT THAT A POLITICAL EDUCATION PROGRAM IS BEING LAUNCHED IN FAVOR OF THE PROPOSED COVENANT, BUT THAT THE WORK IS BEING CARRIED OUT BY 'SUBORDINATES' OF THE HIGH COMMISSIONER WITH HIS APPROVAL, AND THAT SUCH WORK CERTAINLY DOES TEND TO 'INFLUENCE' MARIANAS VOTERS."
