(SECRETARY MORTON ACTS TO AUTHORIZE PLEBISCITE IN THE NORTHERN MARIANAS ISLANDS FOR JUNE 17, 1976)

WASHINGTON, APR. 11 (MNS) --- SECRETARY OF THE INTERIOR ROGERS C.B. MORTON TODAY ISSUED A PROCLAMATION CALLING FOR A PLEBISCITE TO BE HELD ON TUESDAY, JUNE 17, 1975, IN ORDER THAT THE PEOPLE OF THE NORTHERN MARIANAS ISLANDS, PRESENTLY ADMINISTERED AS A PART OF THE TRUST TERRITORY OF THE PACIFIC ISLANDS, MAY DECIDE WHETHER THEY WISH TO BECOME A COMMONHEALTH OF THE UNITED STATES. THE ISLANDS, INCLUDING SAIPAN, TINIAN, ROTA AND OTHERS, LIE NORTH THE U.S. TERRITORY OF GUAM.

ON FEBRUARY 15, 1975, THE MARIANAS POLITICAL STATUS COMMISSION AND THE PRESIDENT'S PERSONAL REPRESENTATIVE, AMBASSADOR HAYDN WILLIAMS, SIGNED A COVENANT TO ESTABLISH A COMMONWEALTH OF THE NORTHERN MARIANA ISLANDS IN POLITICAL UNION WITH THE UNITED STATES OF AMERICA. THE COVENANT CALLS FOR THE HOLDING OF SUCH A PLEBISCITE. DESTRE COVENANT IS AFPROYED BY THE PEDELE THE MARIANA ISLANDS NORTHERN MARIANA ISLANDS HOULD BECOME A U. 6. COMMONWEALTH.

IN ANNOUNCING THE PLEBISCITE SECRETARY MORTON STATED, "THE PLEBISCITE WILL BE HELD IN A FAIR AND IMPARTIAL MANNER UNDER THE SUPERVISION OF A PLEBISCITE COMMISSIONER. THE PRESIDENT HAS DESIGNATED MR. ERWIN D. CANHAM, TO SERVE IN THAT POSITION AS HIS PERSONAL REPRESENTATIVE." SECRETARY MORTON ALSO DECLARED. "OBSERVERS FROM THE UNITED NATIONS AND THE U.S. CONGRESS WILL BE WELCOME TO WITNESS THE PLEBISCITE AS WELL AS THE PLEBISCITE EDUCATION PROGRAM, THE REGISTRATION OF VOTERS, AND OTHER PRE-PLEBISCITE ACTIVITIES."

COMMENTING ON MR. CANHAM'S APPOINTMENT, SECRETARY MORTON NOTED HIS LONG AND DISTINGUISHED RECORD OF PUBLIC SERVICE INCLUDING A PERIOD AS A UNITED STATES DELEGATE TO THE UNITED NATIONS DURING ITS FORMATIVE YEARS, AND EXPRESSED APPRECIATION FOR HIS WILLINGNESS TO ACCEPT THE PRESENT APPOINTMENT. MR. CANHAM WAS FOR MANY YEARS EDITOR-IN-CHIEF OF THE CHRISTIAN SCIENCE MONITOR AND IS PRESENTLY EDITOR ENERTIES, HE HAS PARTICIPATED IN THE WORK OF COMMISSIONS CONCERNED WITH PUBLIC AFTAIRS AND HOLDS HONORARY DEGREES OF ENTATIONS FROM SEVERAL AMERICAN UNIVERSITIES AND FROM THE GOVERNMENTS OF ENGLAND, FRANCE, AND GREECE, GERMANY AND AUSTRIA."

SECRETARY MORTON ALSO ISSUED A SECRETARIAL ORDER THAT GRANTS ADMIN INTERNAL USE ONLY

THE AUTHORITY AND ESTABLISHES ADMINISTRATIVE RESPONSIBILITY FOR THE HOLDING OF A PLEBISCITE. THE ACTION CREATES THE PLEBISCITE COMMISSIONER POSITION, OUTLINES THE RESPONSIBILITIES OF THE TRUST TERRITORY OF THE PACIFIC ISLANDS ADMINISTRATION, ESTABLISHES A NORTHERN MARIANA ISLANDS PLEBISCITE ADVISORY COMMITTEE, OUTLINES THE FUNCTION OF A PLEBISCITE EDUCATION PROGRAM, CREATES A VOTER QUALIFICATIONS, AND AUTHORIZES A SPECIAL PLEBISCITE APPELLATE COURT.

ON NUMEROUS OCCASIONS OVER MORE THAN TWENTY YEARS THE PEOPLE OF THE NURTHERN MARIANA ISLANDS HAVE SOUGHT A CLOSE AND ENDURING ASSOCIATION WITH THE UNITED STATES. SECRETARY MORTON'S ACTION WILL PROVIDE AN OPPORTUNITY FOR THEM TO DECIDE, PURSUANT TO THEIR RIGHT OF SELF-DETERMINATION, WHETHER THEY WISH TO BECOME A COMMONWEALTH IN ACCORDANCE WITH THE TERMS OF THE COVENANT. AT LEAST 55 PERCENT OF THE VALID VOTES CAST IN THE PLEBISCITE MUST FAVOR COMMUNWEALTH STATUS BEFORE THE COVENANT IS PRESENTED TO THE UNITED STATES CONGRESS FOR ITS APPROVAL.

HIGH COMMISSIONER EDWARD E. JOHNSTON SAID THE SELECTION OF MR. ERWIN D. CANHAM AS PLEBISCITE COMMISSIONER WAS AN EXCELLENT CHOICE AND THAT HIS WIDE EXPERIENCE IN PUBLIC AFFAIRS WOULD BE MOST USEFUL IN THIS IMPORTANT TASK. "WE LOOK FORWARD TO SEEING MR. CANHAM ON SAIPAN AND WE PLEDGE OUR COOPERATION AND ASSISTANCES WHERE THEY MAY BE NEEDED," HICOM JOHNSTON SAID.

WHEREAS, BY ACT OF MAY 19-1972, THE MARIANAS DISTRICT
LEGISLATURE ESTABLISHED THE MARIANAS POLITICAL STATUS COMMISSION
AND PRESCRIBED ITS DUTIES TO INCLUDE NEGOTIATIONS WITH THE UNITED
STATES GOVERNMENT ON THE FUTURE POLITICAL STATUS OF THE MARIANA
ISLANDS DISTRICT; AND

COMMISSION AND THE PERSONAL REFRESENTATIVE OF THE PRESIDENT OF PEOPLE OF THE MARIANA ISLANDS DISTRICT AND THE CONGRESS OF THE UNITED STATES, ADULD, UPON TERMINATION OF THE TRUSTEESHIP ADMIN INTERNAL USE ONLY

AGREEMENT BETWEEN THE UNITED STATES AND THE UNITED NATIONS, ESTABLISH A COMMONWEALTH OF THE NORTHERN MARIANA ISLANDS IN POLITICAL UNION WITH THE UNITED STATES OF AMERICA; AND WHEREAS, THIS SIGNING MARKED THE CONCLUSION OF NEGOTIATIONS BETWEEN THE TWO PARTIES AFTER MORE THAN THENTY YEARS OF EFFORTS BY THE PEOPLE OF THE NORTHERN MARIANA ISLANDS THROUGH PUBLIC UNITED STATES; AND

WHEREAS, THE COVENANT WAS UNANIMOUSLY APPROVED.ON
FEBRUARY 20, 1975 BY THE MARIANAS DISTRICT LEGISLATURE; AND
WHEREAS, BY RESOLUTION NO. 126-1975 THE MARIANAS DISTRICT
LEGISLATURE ON FEBRUARY 28, 1975 FORMALLY REQUESTED THE UNITED
STATES AS ADMINISTERING AUTHORITY OF THE TRUST TERRITORY OF THE
PACIFIC ISLANDS TO SET A DATE FOR AND CALL A PLEBISCITE IN THE
MARIANA ISLANDS DISTRICT RELATIVE TO THE COVENANT;

NOW THEREFORE, I, ROGERS C.E. MORTON, SECRETARY OF THE INTERIOR, BY VIRTUE OF THE POWERS VESTED IN ME UNDER EXECUTIVE ORDER 11021 OF JULY 1, 1962 AND WITH THE CONCURRENCE OF THE SECRETARY OF STATE, DO HEREBY CALL FOR A PLEBISCITE TO BE HELD ON TUESDAY, JUNE 17, 1975 THROUGHOUT THE MARIANA ISLANDS DISTRICT TO PROVIDE AN UPPORTUNITY FORNTHE PEOPLE OF THE NORTHERN MARIANA WHETHER THEY WISH TO BECOME A COMMONWEALTH OF SELF-DETERMINATION, IN ACCORDANCE WITH THE TERMS OF THE COVENANT SIGNED ON FEBRUARY 15, 1975.

POLITICAL UNION WITH THE UNITED STATES OF AMERICA.

NO - I VOTE AGAINST COMMONWEALTH IN POLITICAL UNION WITH THE UNITED STATES AS SET FORTH IN THE COVENANT RECOGNIZING THAT, IF COMMONWEALTH IS REJECTED. THE NORTHERN MARIANA ISLANDS WILL REMAIN AS A DISTRICT OF THE TRUST TERRITORY WITH THE RIGHT TO PARTICIPATE WITH THE OTHER DISTRICTS IN THE DETERMINATION OF AN ALTERNATIVE FUTURE POLITICAL STATUS.

IN RECOGNITION OF THE HISTORIC IMPORTANCE OF THIS ACT OF SELF-DETERMINATION, I DECLARE THAT THE DAY OF THE PLEBISCITE SHALL BE A PUBLIC HOLIDAY IN THE MARIANA ISLANDS DISTRICT AND THE HIGH COMMISSIONER SHALL GIVE ADMINISTRATIVE LEAVE TO ALL TRUST TERRITORY OF THE PACIFIC ISLANDS GOVERNMENT EMPLOYEES IN SAID DISTRICT.

OBSERVERS FROM THE UNITED NATIONS AND THE CONGRESS OF THE UNITED STATES WILL BE WELCOME TO WITNESS THE PLEBISCITE AS WELL AS THE PLEBISCITE EDUCATION PROGRAM, THE REGISTRATION OF VOTERS, AND OTHER PRE-PLEBISCITE ACTIVITIES. SUCH OBSERVERS WILL BE PROVIDED ALL NECESSARY ASSISTANCE.

I HAVE TODAY ISSUED SECRETARIAL ORDER NO. 2973 WHICH DEFINES THE AUTHORITY AND PROCEDURES FOR HOLDING THE PLEBISCITE FOR THE MARIANA ISLANDS DISTRICT IN ACCORDANCE WITH THE RESPONSIBILITY OF THE UNITED SZAZES AS ADMINISTERING AUTHORITY UNDER THE TRUSTEESHIP AGREEMENT OF JULY 16, 1947 BETWEEN THE UNITED NATIONS AND THE UNITED STATES OF AMERICA.

WHEREAS, A COVENANT TO ESTABLISH A COMMONWEALTH OF THE NORTHERN MARIANA ISLANDS IN POLITICAL UNION WITH THE UNITED STATES OF AMERICA, HAS NOW BEEN NEGOTIATED AND SIGNED BY THE DULY AUTHORIZED REPRESENTATIVES OF THE MARIANAS DISTRICT AND STHE UNITED STATES AND RECEIVED THE UNANIMOUS APPROVAL OF THE MARIANA ISLANDS. DISTRICT LEGISLATURE ON FEBRUARY 20, 1975;

NOW, THEREFORE, PURSUANT TO EXECUTIVE ORDER NO. 11021 OF JULY 1, 1962 AND WITH THE CONCURRENCE OF THE SECRETARY OF STATE SEC. 1 PURPOSE

THE PURPOSE OF THIS ORDER IS TO ESTABLISH THE AUTHORITY AND THE ADMINISTRATIVE RESPONSIBILITY FOR THE HOLDING OF A PLEBISCITE ON JUNE 17, 1975, IN THE MARIANA ISLANDS DISTRICT AS AN EXERCISE BY THE PEOPLE OF THAT DISTRICT OF THEIR RIGHT OF SELF-DETERMINATION.
SEC. 2 THE PLEBISCITE COMMISSIONER

A PLEBISCITE COMMISSIONER DESIGNATED BY THE PRESIDENT OF THE UNITED STATES SHALL BE RESPONSIBLE FOR THE PLANNING, THE PREPARATIONS FOR AND THE HOLDING OF THE PLEBISCITE IN THE NORTHERN MARIANA ISLANDS, THE COMMISSIONER SHALL:

- (1) ENSURE THAT AN IMPARTIAL PLEBISCITE EDUCATION PROGRAM IS CONDUCTED THROUGHOUT THE NORTHERN MARIANA ISLANDS;
- (2) APPOINT A FLEBISCITE VOTER REGISTRATION BOARD, DESIGNATE ITS CHAIRMAN AND ESTABLISH PROCEDURES FOR THE REGISTRATION OF VOTERS;
- (3) ESTABLISH AN OFFICIAL PLEBISCITE REGISTER ON THE BASIS OF THE FINAL VUTER REGISTRATION LIST AS CERTIFIED BY THE VOTER REGISTRATION BUARD, TO INCLUDE QUALIFIED ABSENTEE VOTERS;
- (4) OVERSEE THE ADMINISTRATIVE PLANS FOR AND SUPERVISE THE HOLDING OF THE PLEBISCITE; AND
- (5) APPONT TECHTIVE DIRECTOR WHO SHALL BE RESPONSIBLE TO HIM FOR THE EXECUTION AND COORDINATION OF ALL ACTIVITIES IN SEC. 3 PERPONSIBLE IN THE PLEBISCITE.
- SEC. 3 RESPONSIBILITIES OF THE TRUST TERRITORY OF THE PACIFIC ISLANDS ADMINISTRATION
- COMMISSIONER ADMINISTRATIVE SUPPORT AND SHALL ASSURE THE PLESITO ITE IMPLEMENTATION OF POLICIES AND RESCRIME RELATED TO THE PLEBISCITE IN THE MANNER PRESCRIBED BY THE PLEBISCITE COMMISSIONER.

(AL THERE IS HEREBY CREATED A PLEBISCITE VOTER REGISTRATION BOARD CONSISTING OF ELEVEN MEMBERS, EIGHT OF WHOM SHALL BE APPOINTED AT LARGE BY THE PLEBISCITE COMMISSIONER THE THREE OF WHOM SHALL BE APPOINTED BY THE PLEBISCITE COMMISSIONER FROM THE MUNICIPAL COUNCILS OF SAIPAN, ROTA AND TINIAN TO SERVE ON THE BOARD ONLY WHEN IT ACTS AS A BODY OR SITS EN BANC ON MATTERS INVOLVING THEIR RESPECTIVE MUNICIPALITIES.

- (B) VOTERS SHALL BE REGISTERED IN THE VOTING DISTRICTS IN WHICH THEY RESIDE. THE PLEBISCITE COMMISSIONER MAY, HOWEVER, ISSUE SPECIAL REGULATIONS RELATING TO THE CENTRAL REGISTRATION OF VOTERS AND SHALL ESTABLISH SPECIAL PROCEDURES FOR THE REGISTRATION OF VOTING OF ABSENTEE VOTERS. THE VOTER REGISTRATION SHALL BE CARRIED OUT IN THE VOTING DISTRICTS BY PANELS OF THE VUTER REGISTRATION BOARD CONSISTING OF NOT LESS THAN TWO MEMBERS; THEY SHALL BE JOINED EX OFFICIO BY THE VILLAGE COMMISSIONER OF THAT DISTRICT, OR IN THE ABSENCE OF SUCH VILLAGE COMMISSIONER BY ITS MAYOR. THE EX OFFICIO MEMBERS SHALL HAVE THE RIGHT TO VOTE WITH THE PANELS. REGISTRATION SHALL BEGIN ON A DATE TO BE SET BY THE PLEBISCITE COMMISSIONER AND SHALL TERMINATE ON MAY 16, 1975.
- (C) THE MEMBERS OF THE BOARD SHALL HAVE ALL NECESSARY AND APPROPRIATE AUTHORITY TO CARRY OUT THE FOLLOWING FUNCTIONS:
- (1) IN CONJUNCTION WITH THE EX OFFICIO MEMBERS, REGISTER ALL VOTERS QUALIFIED TO VOTE IN THE PLEBISCITE;
- (2) SITTING EN BANC AS AN APPELLATE REVIEW BOARD, HEAR CHALLENGES OF DECISIONS GRANTING OR DENYING REGISTRATION TO ANY PERSON; AND

- (D) DECISIONS OF THE PANELS DENYING REGISTRATION MAY BE CHALLENGED BY ANY REGISTERED VOTER. CHALLENGES MUST BE MADE WITHIN THREE WORKING DAYS AFTER THE PUBLICATION OF THE DECISION DF THE PANEL. SUCH CHALLENGES SHILL BE HEARD BY THE VOTER REGISTRATION BOARD SITTING EN BANC. THE BOARD SHALL DECIDE ALL CHALLENGES AS EXPEDITIOUSLY AS POSSIBLE. - (1) A THUST TERRITORY CITIZEN DOMICILED IN THE MARIANA ISLANDS DISTRICT:
- (2) 18 YEARS OF AGE OR OLDER ON THE DATE OF THE PLEBISCITE;
- (3) AT THE TIME OF REGISTRATION NOT SERVING A SENTENCE OR UNDER PAROLE OR PROBATION FOR ANY FELONY FOR WHICH HE HAS BEEN CONVICTED BY ANY COURT OF THE TRUST TERRITORY;
