A COMMONWEALTH OF THE NORTHERN MARIANA ISLANDS IN POLITICAL UNION WITH THE UNITED STATES OF AMERICA UPON TERMINATION OF THE TRUSTEESHIP AGREEMENT BETWEEN THE UNITED STATES AND THE UNITED NATIONS. THE UNITED STATES SECRETARY OF THE INTERIOR HAS ISSUED A PROCLAMATION ESTABLISHING JUNE 17, 1975 AS THE DATE FOR A PLEBISCITE TO BE HELD THROUGHOUT THE MARIANAS DISTRICT IN ORDER TO ENABLE RESIDENTS OF THE DISTRICT TO APPROVE OR REJECT THE COVENANT.

I HAVE BEEN AUTHORIZED BY MY GOVERNMENT TO EXTEND AN INVITATION THROUGH YOU TO THE TRUSTEESHIP COUNCIL TO SEND A VISITING MISSION TO OBSERVE THIS PLEBISCITE. MY GOVERNMENT EXPECTS THAT THE VISITING MISSION WOULD COMPRISE THE TRA-

DITIONAL NUMBER OF FOUR MEMBERS AND WOULD REMAIN IN THE DISTRICT FOR A PERIOD SUFFICIENTLY LONG TO ENABLE IT TO OBSERVE THE CAMPAIGN, THE ACTUAL POLLING AND THE COUNTING OF THE VOTES. MY GOVERNMENT IS PREPARED TO ARRANGE AN ITINERARY FOR THE MISSION WHICH WOULD ENABLE IT TO OBSERVE CAMPAIGNING AND POLLING THROUGHOUT THE DISTRICT.

WHILE MY GOVERNMENT EXPECTS THAT THE PRIMARY PURPOSE OF THE MISSION WOULD BE TO OBSERVE THE PLEBISCITE, THE MISSION WILL OF COURSE, BE WELCOME TO FAMILIARIZE ITSELF WITH POLITICAL, ECONOMIC AND SOCIAL DEVELOPMENTS IN THE MARIANA ISLANDS DISTRICT.

MY GOVERNMENT HOPES THAT THE FORTHCOMING SESSION OF THE TRUSTEESHIP COUNCIL WILL ACCEPT THIS INVITATION. KISSINGER
