SAIPAN, APR. 23 (MNS)---A FLIGHT OF 56 AMERICAN MILITARY DEPENDENTS OF VIETNAMESE ANCESTRY WILL BE ARRIVING ON SAIPAN THURSDAY MORNING, AT 6:25 (APRIL 24), ON A SPECIAL FLIGHT FROM SINGAPORE, ACCORDING TO DEPUTY HIGH COMMISSIONER PETER T. COLEMAN.

THE DEPENDENTS WILL BE STAYING ON SAIPAN FROM ONE TO TWO WEEKS FOR PROCESSING BEFORE DEPARTING FOR THEIR HOMES IN THE UNITED STATES MAINLAND.

SAIPAN, APR. 23 (MNS)---MARIANAS SENATOR PEDRO A. TENORIO SENT A MESSAGE TO WASHINGTON THIS WEEK "TO FIND OUT ANSWERS FROM THE UNITED STATES WHETHER CERTAIN ISSUES IN THE COVENANT COULD BE RE-NEGOTIATED AS CLAIMED BY OPPONENTS OF THE COVENANT."

IN A DISPATCH TO PRESIDENT GERALD FORD, CONGRESSMAN PHILIP BURTON, INTERIOR SECRETARY ROGERS C.B. MORTON AND AMBASSADOR FRANKLIN HAYDN WILLIAMS, SENATOR TENORIO STATES THAT "THE MARIANAS PEOPLE WANT TO KNOW BEFORE THE PLEBISCITE" WHETHER THESE ITEMS IN THE COVENANT COULD BE RE-NEGOTIATED:

- "U.S. MINIMUM WAGE, MPSC REQUESTED THIS, CAN IT BE RE-NEGOTIATED?;

- "INCLUDE PROVISIONS IN (THE) COVENANT TO PROVIDE FAST AND FULL WAR CLAIMS COMPENSATION TO MARIANAS BEFORE THE NEW MARIANAS GOVERNMENT (IS) FORMED;

- "UNILATERAL TERMINATION OF POLITICAL RELATIONSHIP, MARIANAS OPTION TO SEVERE RELATIONSHIP AT ANYTIME; AND

- "INCREASE COVENANT APPROVAL IN PLEBISCITE TO SIXTY-SIX AND TWO-THIRDS PERCENT RATHER THAN FIFTY-FIVE PERCENT."

SAIPAN, APRIL 23 (CONGRESS RELEASE)---THE CONGRESS OF MICRONESIA'S JOINT COMMITTEE ON PROGRAM AND BUDGET PLANNING IS HOLDING HEARINGS ON SAIPAN CONCERNING THE TRUST TERRITORY BUDGET.

THE COMMITTEE STARTED ITS HEARINGS MONDAY (APRIL 21) REGARDING THE IMPLEMENTATION OF THE NEW FINANCIAL MANAGEMENT SYSTEM AND EXPANDED USE OF THE AUTOMATIC DATA PROCESSING SYSTEM. THE IMPLEMENTATION OF THE FINANCIAL MANAGEMENT SYSTEM WILL REQUIRE MORE MONEY THEN IS PRESENTLY AVAILABLE.

ANOTHER AREA WHICH THE COMMITTEE IS CONSIDERING CONCERNS HOUSE BILL 97, CREATING A COMPREHENSIVE ECONOMIC DEVELOPMENT PLAN FOR MICRONESIA. THE SPOKESMAN SAID THE

JOINT COMMITTEE ON PROGRAM AND BUDGET PLANNING IS RESPONSIBLE FOR DEVELOPING THE PLAN IF THE BILL IS APPROVED BY THE HIGH COMMISSIONER. THE COMMITTEE IS SOLICITING DISTRICT INPUT FROM ALL DISTRICT ADMINISTRATORS.

ALSO UNDER CONSIDERATION BY THE COMMITTEE IS THE DESIGN OF THE MICRONESIAN PRINCESS. THE SPOKESMAN INDICATED THAT THERE ARE PROBLEMS WITH THE VESSEL, NOW IN USE IN THE DISTRICTS, AND THE COMMITTEE IS SOLICITING EXPERTISE FROM T.T. DEPARTMENT OF TRANSPORTATION PEOPLE ON THE MOST PRACTICAL DESIGN FOR THE REMAINING SHIPS THAT CAN WORK BETTER IN THE DISTRICTS.

AMONG OTHER THINGS, THE COMMITTEE IS HOLDING HEARINGS ON THE IMPLEMENTATION OF THE PROGRAM FOR FISCAL YEAR 1976 AND IS ALSO DISCUSSING CAPITAL IMPROVEMENT PROJECTS PRIORITIES FOR THAT YEAR. THE SPOKESMAN NOTED THAT THE TT'S FISCAL YEAR BUDGET FOR 1975 SUFFERED PROBLEMS SUCH AS OVER SPENDING, AND THE COMMITTEE IS INTERESTED IN FINDING OUT HOW THIS PROBLEM COULD BE AVOIDED FROM OCCURRING IN THE FUTURE.

THE COMMITTEE WILL ALSO BE DOING PRELIMINARY REVIEW WITH ALL DISTRICT OFFICIALS ON THE 1977 FISCAL YEAR BUDGET.

FLOOR LEADER FERMIN LIKICHE OF THE TRUK DISTRICT LEGISLATURE (TDL) SPOKE IN FAVOR OF THE PRICE CONTROL BILL SAYING THAT "THE LOCAL MERCHANTS' PRICES ARE JUST TOO HIGH AND THERE'S NO WAY TO CONTROL THEM."

SPEAKER KOICHI SANA SUGGESTED THAT A THOROUGH STUDY OF EXISTING MARKED UP PRICES IN THE BUSINESS ESTABLISHMENTS SHOULD BE UNDERTAKEN FIRST BEFORE SUCH LEGISLATION IS TO BE ENACTED. THE MORTGAGE BILL DID NOT RECEIVE ANY OPPOSITION. HOWEVER,

THE COMMITTEE LEARNED THAT THE RISK OF MORTGAGING LAND IN TRUK IS NO GREATER THAN THE IDEA OF SELLING LANDS WHICH HAPPENS TO BE A COMMON PRACTICE IN TRUK, RUBEN POINTED OUT.

A PROPOSED BILL TO RAISE THE USURY LIMIT IN THE TRUST TERRITORY FROM 12 PERCENT PER YEAR TO 15 PERCENT PER YEAR RECEIVED DIFFERENT RESPONSES. THOSE WHO FAVOR THE INCREASE BELIEVE THAT THE PRIME RATE IN THE TT IS QUIET LOW COMPARED TO GUAM AND THE UNITED STATES. THEY CONTENDED THAT RAISING THE USURY LIMIT WOULD MAKE IT POSSIBLE FOR THE BANKS TO GET LOANS OUTSIDE THE TT.

THOSE WHO DISAGREED ARGUED THAT LOCAL DEPOSITS AT THE BANKS IN THE DISTRICTS ARE SUFFICIENT AND THAT OUTSIDE LOANS ARE NOT NEEDED.

DURING A MEETING WITH THE LOCAL CONTRACTORS AND GOVERNMENT OFFICIALS CONCERNING CONTRACTING PROCEDURES, CONTRACTORS COMPLAINED THAT THE PUBLIC WORKS DEPARTMENT HAS AWARDED CONTRACTS WITHOUT SUFFICIENT INFORMATION ABOUT THE PROJECT. OTHERS COMPLAINED THAT THERE IS NO CONTRACTING PROCEDURE SET BY THE GOVERNMENT.
