1. APPRECIATE YOUR STATUS LNO 80. IN ADDITION TO SUCH WEEKLY REPORT PLEASE SEND UNCLASSIFIED TELS GIVING SPOT REPORTS ON NATURE AND EXTENT OF ANY NOTABLE MEDIA COVERAGE.

2. WITH REGARD TO INSTRUCTIONS PASSED TO YOU IN REFTEL, I WOULD LIKE TO STRESS PARA 4A OF THAT MESSAGE, ESPECIALLY LAST SENTENCE. YOU SHOULD NOT HESITATE ON YOUR OWN INITIATIVE TO CORRECT FACTUAL ERRORS PUBLICLY AS NECESSARY WHENEVER THEY OCCUR. SUCH CORRECTIONS SHOULD BE MADE IN VEIN THAT THEY ARE FOR PURPOSE OF SETTING RECORD STRAIGHT.

3. WHILE WE CANNOT REFUTE ENTIRE PLETHORA OF IRRESPONSIBLE CHARGES APPEARING IN GROWING VOLUME IN LOCAL TTPI AND GUAM PRESS, NEVERTHELESS WE CAN AND SHOULD MAKE VIGOROUS EFFORT TO POINT OUT FALSITY OF SUCH CHARGES OR ASSERTIONS BY PROVIDING ACCURATE AND TIMELY INFORMATION IN SPECIFIC REPLY.

4. PLEASE KEEP US FULLY ADVISED AS YOU HAVE IN PAST ABOUT POSSIBLE AREAS OF MISUNDERSTANDING AND MISINTERPRETATION OF COVENANT AND ON ANY OTHER MATTERS THAT MAY INTERFERE WITH FULL UNDERSTANDING BY THE PEOPLE OF FACTS AND EXACT PROVISIONS REGARDING COMMONWEALTH AGREEMENT.
