WE HAVE INFORMED SOVIET TRUSTEESHIP COUNCIL (TC) REP
(KORVALENKO) OF US DESIRE THAT TC SEND SPECIAL VISITING
MISSION, INCLUDING SOVIETS, TO MARIANAS TO OBSERVE JUNE 17
PLEBISCITE. WE HAVE ALSO FURNISHED SOVIET MISSION WITH MARIANAS
COVENANT AS WELL MAJOR PUBLIC ANNOUNCEMENTS RELATING TO
ORGANIZATION OF PLEBISCITE. SOVIET REPS HAVE NOT REACTED
DIRECTLY TO US.

WE ARE MAKING IT CLEAR TO OTHER TC MEMBERS THAT USG HAS ALREADY PUBLICALLY PLEDGED TO TC THAT IT WILL REQUEST TERMINATION OF TRUSTEESHIP FOR ALL OF TRUST TERRITORY AT SAME TIME.

3. ACTION REQUESTED: WE BELIEVE IT WOULD BE USEFUL PRIOR TO TC SESSION BEGINNING MAY 27, FOR EMBASSY MOSCOW TO MAKE FACTUAL PRESENTATION TO FOREIGN OFFICE ON MARIANAS COVENANT, FORTHCOMING PLEBISCITE AND STATUS OF NEGOTIATIONS WITH CONGRESS OF MICRONESIA FOR REST OF TRUST TERRITORY.
