SUBJECT: CLARIFICATION OF JOB PREFERENCES UNDER COVENANT  
1. IT HAS REPEATEDLY BEEN STATED THAT GOVERNMENT OF NORTHERN MARIANAS WILL BE ABLE TO ESTABLISH STANDARDS AND QUALIFICATIONS FOR EMPLOYMENT BUT THAT JOB PREFERENCES AS SUCH WILL NOT BE AVAILABLE TO CITIZENS OF THE NORTHERN MARIANAS UNDER THE COVENANT.  
2. QUESTION HAS BEEN RAISED WHETHER JOB PREFERENCES ARE GRANTED UNDER SOME PROGRAMS IN THE UNITED STATES TO CERTAIN GROUPS, SUCH AS BLACKS, CHICANOS, AND WOMEN, WHO REQUIRE SPECIAL PROTECTION BECAUSE OF HISTORICAL CIRCUMSTANCES. IF QUOTA SYSTEMS AND/OR OTHER DEVICES HAVE BEEN USED, AND FOUND LEGALLY UNEXCEPTIONABLE, TO ADVANCE ECONOMIC INTERESTS OF SUCH GROUPS, IT WOULD BE OF CONSIDERABLE INTEREST IN
