(CORRECTION ON WILLIAMS, TENORIO STORY)

SAIPAN, MAY 10 (MNS) --- THE MNS STORY DATED FRIDAY, MAY 9 (WILLIAMS RESPONSE TO TENORIO) CONTAINED A SERIOUS TYPOGRAPHICAL ERROR WHICH SHOULD BE CORRECTED BEFORE RELEASE. THE WORD QUOTE NOT UNQUOTE WAS INADVERTENTLY LEFT OUT IN THE FIRST LINE OF THE STORY. THE CORRECT OPENING SENTENCE FOR THAT STORY SHOULD READ AS FOLLOWS: "THE MARIANAS COVENANT" IS NOT OPEN FOR AMENDMENT, REVISION, OR RENEGOTIATION" ACCORDING TO
