In full agreement with the resolution passed by the Nuclear Free Pacific Conference, held in Fiji in April 1975, the Friends of Micronesia, representing over 3,000 people vitally concerned with issues affecting Micronesia, requests the Trusteeship Council to require the Government of the United States of America to cancel the plebiscite planned for the Northern Mariana Islands on 17 June 1975.


In view of previous Trusteeship Council requests that the United States end separate negotiations with the Northern Mariana Islands, in view of the lack of official United Nations supervision of the plebiscite (the plebiscite commissioner will be appointed by the President of the United States), and because the proposed Covenant of Commonwealth 1/ has not been made available in either Chamorro or Carolinian, the local languages, the Friends of Micronesia urges the Trusteeship Council to determine that the plebiscite as presently planned is not a legitimate act of self-determination in accordance with resolutions 1514 (XV) and 2621 (XXV) of the General Assembly.

On behalf of the Marianas Political Status Commission, it is my privilege to formally request that you allow three (3) petitioners from the Commission to appear before the Trusteeship Council meeting scheduled for the latter part of May. The petitioners are Mr. Edward DLG. Pangelinan, Chairman, and Senator Pedro A. Tenorio and Dr. Francisco T. Palacios, members, of the Marianas Political Status Commission. The purpose of the appearance is to report on the conclusion of the Marianas status negotiations and other matters relative to the signing of the Covenant to Establish a Commonwealth of the Northern Marianas in Political Union with the United States of America. 1/ We would also like to present information regarding the programs that are being conducted on political education in preparation for the plebiscite to be held in the Marianas on 17 June 1975.
