IN LIGHT OF OUR UNDERSTANDING THAT COPIES OF THE REPORT HAVE BEEN MADE AVAILABLE TO PERSONS OUTSIDE THE TTPI ADMINISTRATION, WE TRUST THAT YOU WILL MAKE CLEAR TO ALL THAT YOUR REPORT IS A WORKING PAPER DEVELOPED FOR CONSIDERATION OF THOSE WHO MUST MAKE FINAL RECOMMENDATIONS TO THE SECRETARY OF THE INTERIOR. THAT HE REPORT AS IT NOW EXISTS CARRIES NO OFFICIAL APPROVAL ND THAT THE CONCLUSIONS AND RECOMMENDATIONS OF THE REPORT E NOT NECESSARILY THOSE WHICH EVENTUALLY WILL BE REFLECTED OFFICIAL US ACTIONS.
