(PROCLAMATION FOR PLEBISCITE DAY) SAIPAN, JUNE 11 (MNS) --- DEPUTY HIGH COMMISSIONER PETER T. 1975 COLEMAN HAS PROCLAIMED TUESDAY (JUNE 17, 1975) A PUBLIC HOLIDAY IN THE MARIANA ISLANDS DISTRICT. THE DEPUTY HIGH COMMISSIONER. IN A PROCLAMATION RELEASED WEDNESDAY AFTERNOON (JUNE 11), PROCLAIMED THAT "ALL EMPLOYEES OF THE GOVERNMENT OF THE TRUST TERRITORY OF THE PACIFIC ISLANDS LOCATED IN THE MARIANA ISLANDS DISTRICT ARE GRANTED ADMINISTRATIVE LEAVE IN OBSERVANCE OF PLEBISCITE DAY." THE PROCLAMATION WAS MADE IN RECOGNITION OF THE HISTORIC IMPORTANCE OF THE ACT OF SELF-DETERMINATION OF THE PEOPLE OF THE MARIANA ISLANDS ON JUNE 17, 1975, WHEN THE PEOPLE OF THE MARIANAS WILL GO TO POLLS TO CAST THEIR BALLOTS ON WHETHER THEY APPROVE OR DISAPPOVE THE COMMONWEALTH COVENANT IN POLITICAL AFFILIATION WITH THE UNITED STATES OF AMERICA.
