1. FINAL RESULT OF MARIANAS PLEBISCITE ON COVENANT IS 3939 FOR (78.8 PERCENT), 1060 AGAINST, A TOTAL OF 4999 VALID BALLOTS. THROUGHOUT WAS 92.9 PERCENT OF THE 5,379 REGISTERED AND ELIGIBLE TO VOTE.

2. PLEBISCITE COMMISSIONER WILL CERTIFY RESULTS UPON RECEIPT OF BALLOTS FROM NORTHERN ISLANDS, EXPECTED TO ARRIVE WITHIN 48 HOURS.
